MINUTES OF REMOTE REGULAR MEETING

Thursday July 16, 2020

Chair Betty Slade called the regular meeting to order at 6:12 pm with Vice-Chair Tim Gillespie, John Bell, Dale Weber, and Janet Jones in attendance. Elizabeth Collins was absent. Mr. Morton was present but had not been sworn in yet and did not vote. Also present were Philp Weinberg from ConCom and Marc Schmid from the Planning Board who will be the Reps to the CPC once appointed.

<u>Chair's Announcement</u> — Under MGL Chapter 30A, section 20(f) — Meeting being recorded. Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitations on the number of people that may gather in one place, this meeting of the **Westport Community Preservation**Committee is being conducted via remote participation. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings as provided for in the Order. Town meeting and handout

Ms. Slade reviewed the handout. She noted that she will plan to attend the Town Meeting outside the High School on Saturday July 25. 2020. Jennifer Dubois from the Land Trust would also be present. Motion by Ms. Jones to approve the handout. Seconded by Mr. Gillespie. The members voted 5 in favor by roll call.

CP-3 Due

Mr. Bell agreed to input the information into the CP-3 form this year. This year's new applications will be sent to him containing the information.

September hearing

Ms. Slade explained that the public hearing will take place in September but at the current time it is not known if in person or by remote participation. She asked for authority to make that decision based on the town and governor's recommendations.

Reports by liaisons

Ms. Slade reviewed the outstanding projects and liaison persons.

There was an adjustment for John Bell being removed from the Handy House roof project and reassigned to Janet Jones and Dale Webber as it is a historical rehabilitation project and Janet serves on the Historical Commission. Ms. Slade also explained to the upcoming new members how historical projects are also reviewed by the Historical Commission as in the case for both the Handy House and the Bell School projects.
