JBS Towing Violation:

Site Visit:

Agent gave his report on onsite done. Amnesty procedure application discussed. Work started without CH 91 license. DEP is concerned. Fines may ensue. Barrier at public access to public wharf. Roadway is public way.

DEP findings on paint spill - Arnold Tripp: Department of Environmental Protection found that it would do more harm to remove than leave dried product.

Dock Policy: Clarification: “No CCA treated lumber” can be used but does not specify where. Can stringers and decking material, that do not come in contact with water allowed? Mr.Reynolds clarified leaching. ACQ discussed. Policy remains as written,.
