WORKS PROJECTS ADMINISTRATION

SEWING PROJECT

Jan. 1st to June 23rd. Employing 12 to 14 women. Total Payroll \$3,423.92 These women were engaged in making different articles of clothing which was sent in to Fall River Headquarters. In return, the town receives whatever garments are requested in order to help clothe the needy. These garments are given out at the Federal Surplus Commodity Distribution Center at the Head of Westport. During the period of operation Jan. 1st to June 23rd these women made 2,181 men's shirts.

13 women working on this project were without jobs when the Federal Government closed all small sewing units on June 23, 1941.

FEDERAL SURPLUS COMMODITY DISTRIBUTION CENTER

Jan 1st to Dec 31st. Employing 2 persons. Total Payroll \$1,873.96. The following articles were issued to the needy of the Town from the Federal Surplus Commodity Distribution Center during the year: 6,748 lbs. cabbage, 5,890 lbs. rice, 9,327 lbs. prunes, 8,792 doz. eggs, 4,986 lbs. smoked ham, 8,966 lbs. salt pork, 26,658 lbs. white flour, 13,475 lbs. fresh grapefruit, 19,243 lbs. dried beans, 23,837 lbs. corn meal, 14,140 lbs. lard, 18,516 lbs. white potatoes, 10,955 lbs. raisins, 19,375 lbs. fresh apples, 14,630 lbs. wheat flour, 11,271 lbs. fresh carrots, 1,750 lbs. dried peaches, 2,051 lbs. fresh peaches, 15,265 lbs. graham flour, 5,701 lbs. fresh beets, 2,865 lbs. fresh tomatoes, 1,742 lbs. sweet corn, 550 lbs. celery, 362 cans grapefruit juice, and 3,044 articles of clothing. The estimated value of this food is \$24,507.06 and clothing \$3,004.20 a total valuation of \$27,511.26.

GYPSY MOTH PROJECT

Feb. 3rd to March 25th. Employing 18 to 20 men. Total Payroll \$1,888.08. These men went through dif-

ferent sections of the Town's wooded areas that were infested with Gypsy Moths, and painted the Egg Clusters with Creosote in approximately 775 acres. Project closed March 25, 1941.

ROAD PROJECT (MAIN ROAD)

Jan. 1st to June 22nd. Employing 20 to 50 men. Total Payroll \$12,007.84. Continuation of project worked last year. Widening road bed from the present 16 to 18 ft. width to a 24 ft. wide road, from George H. Gifford's corner to Cornell Road. During this period the men did the following; 5,362 cu. yds. earth excavation, 5,780 cu. yds. of crushed gravel base fill, 819 cu. yds. boulder excavation. Also disposed of all earth excavation, stumps and rocks.

This road has been tarred by the Highway Dept. from Gifford's corner down as far as Arthur Tripp's corner under supervision of Elton C. Tripp, Highway Surveyor.

SIDEWALK PROJECT

Jan. 1st to 8th and April 7th to Dec. 28th. Employing 15 to 35 men. Total Payroll \$16,030.86. Completed Concrete Sidewalks 4 ft. wide and 6 in. Concrete Curb on the Old Bedford Road from the Narrows to Blossom Road; up Blossom Road by Lydia G. Hicks land, or almost to the Fall River line and on the west side of Sanford Road from the State Highway to Gadoury Street. Project closed Dec. 28th and men transferred to Defense Project at Camp Edwards.

RETAINING WALL PROJECT

Oct. 20th to Dec. 28th. Employing 10 to 20 men. Total Payroll \$2,670.24. Constructed retaining wall from State Highway up to the hill on west side of Sanford Road approximately 800 ft. so as to hold the bank. In order to put this wall up the men had to excavate and dispose of 195 cu. yds. of earth excava-

tion, haul in 377 tons of stone and construct the wet wall consisting of 217 cu. yds. Project completed Dec. 28th and men transferred to Defense Project at Camp Edwards.

The total salaries paid under Work Projects Administration Funds during the year 1941 amounted to \$37,894.90.

At present there are approximately 20 men working on Defense Project at Camp Edwards and 2 persons working at the Commissary at the Head of Westport.

BOARD OF PUBLIC WELFARE

The Board met March 15th, 1941 and organized as follows: Samuel A. Boan, Chairman; Truman C. Emery, Certifying Officer for Federal Surplus Commodities, Everett W. Cornell was appointed Secretary and Investigator. Jessica E. Cornell was appointed Clerk-Typist.

Since that time regular meetings have been held the first Saturday of each month with such special meetings as were necessary from time to time. During the year this Board and the Bureau of Old Age Assistance has put into immediate effect the various changes in rules and policies of the State Department of Public Welfare. Unless the Board had adopted these policies and rules they would not have been reimbursed by the State and Federal Government. The Secretary was directed to carry out all such rules and regulations as effected the administration of public assistance and to devise such local procedures as were in accordance with suggestions by the State Department.

A most important ruling regarding the reporting in detail of any change of status during the month following that in which the change occurred has resulted in a more constant watch for current bills and necessitated very close cooperation of the local Board with doctors, clinics, and hospitals in order that there be a minimum of delinquent bills for which no reimbursement could be received.

The department has received notification that both Everett Cornell and Jessica Cornell have passed the qualifying examinations for their respective positions. Miss Cornell is now employed subject to the rights and privileges of Civil Service. It was with regret that the Board accepted the resignation of

Everett W. Cornell, effective October 31st, 1941. Mr. Cornell resigned to accept a position as Social Worker in the State Department of Public Welfare and is affiliated with the local District Office. The members of the Board of Public Welfare take this opportunity to thank Mr. Cornell for the valuable work he did in reorganizing local administration to conform with the State policy. Thelma McHugh has been appointed Agent in conformance with Civil Service requirements.

Total expenditures for Public Welfare and Infirmary aid were \$14,867.80. Reimbursements from State, cities and towns were \$3,318.62, leaving a net cost to the town of \$11,549.18.

BUREAU OF OLD AGE ASSISTANCE

The Bureau met March 15th, 1941 and organized as follows: Roby C. Burt, Chairman. Everett W. Cornell and Jessica E. Cornell were appointed as Secretary and Clerk-Typist, respectively.

Policies in local administration have been adjusted to conform with requirements for reimbursement. The response of local physicians to repeated requests for more detailed information regarding patients and for more frequent and complete billing data has been gratifying. We shall appreciate their continued cooperation during the next year when we anticipate the revised budgetary requirements will preclude granting of supplementary aid without prior notice and approval of individual cases.

The change in the residence requirement to three years residence during the past nine years instead of the present five years and the increase in minimum grants to persons living alone are the major changes in the new Old Age Assistance law effective May 1st, 1942. The State Department is compiling rules and regulations under which local Bureaus will act in determining eligibility and deductions in each case.

We have also received a schedule of maximum reimbursable charges for dental, out-patient, nursing, nursing home, x-ray, and hospital cases. These schedules have been worked out by the State Department in collaboration with representatives of the medical profession and form a basis of reimbursement which has been determined reasonable. Such studies by the Department summarize conditions over a wide area and assure the Town and the recipient adequate and reasonable services, equal for all.

The Bureau of Old Age Assistance, together with the Board of Public Welfare appointed Thelma McHugh as Agent after the resignation of Mr. Cornell. We wish Mr. Cornell success in his new work and we feel all who know him join us in that wish.

The Library hours were voted to be the same as in previous years, viz: 3-5 and 7-9 every Saturday afternoon and evening, except when this date falls on a holiday, in which case the Library will be open the preceding Friday and notice will be posted in the Library.

There was no assistant Librarian appointed as the secretary to the Board has offered her services without charge whenever she is needed. If she is unable to serve, the Librarian is authorized to hire an assistant and her wage is to be \$.25 per hour. This arrangement has worked very well in the past years and has saved the Board quite an expense.

The circulation of the Library has been about the same as in 1940. This is very good when we consider that in many Small Libraries and in some big ones the circulation has shown a decided decrease. We also feel that there has been a decided improvement in the books chosen by our juvenile readers for their leisure moments. Children's books have shown a decided improvement in the last few years in their print and pictures and this may be the reason. The Bookmobile has continued to loan us books through-

out the year and has materially helped the schools and people who could not, because of distance, make use of the Library itself. We loan books to the Bookmobile to place in the outlying districts of the town.

January, 1942

To the School Committee of the Town of Westport:
Gentlemen:

In accordance with custom I submit the forty-ninth in the series of annual reports of the school superintendents of this town.

Within our limited means every effort has been made to maintain our school buildings and equipment in a good state of repair. Much more could be done, should be done if the funds were only available.

The well at the High School filled in and its repair not only made it impossible to do some of the things we had in mind but necessitated our requesting emergency funds from the Finance Committee.

The south roof of the Agricultural Shop was shingled and the downstairs was arranged as one good-sized general shop with a small class room at the east end.

Our Teachers

Continuing the policy of last year those teachers not yet at maximum salary were granted a \$50 increment. This, plus the previous increments, amounts to the restoration of seventy-five percent of the depression cuts.

Now that the cost of living has gone up and is still rising it is imperative that a full restoration or adjustment of salaries be made if we are to keep our teachers from transferring to better positions either in other school systems or in industry.

During the past year we have had several changes in the teaching force. Mrs. Marshall left the High School to accept a better paying position nearer her home. The late date of Mrs. Marshall's resignation made it seem advisable to replace her for this year with Mrs. Ruth Robinson, who is serving in a substitute capacity. She needs no introduction as she has come to our aid on other occasions.

Mr. John Dolan secured a year's leave of absence and entered industry. It is doubtful if he ever returns to us. His several years of service in various capacities made him very valuable to our High School. Mr. David Pierce of Swansea, a graduate of Brown University and a former high school teacher and principal, was available and his co-operation and activity have gone a long way toward covering our loss.

Mr. Norman Gifford, our High School Principal, is also on a leave of absence. He is associated with the National Youth Administration and is assisting the High School Principals in this section of the State with their local N. Y. A. problems. Mr. Gifford did splendidly with N. Y. A. activities in our High School and I am sure will be very helpful to the program.

Your Committee chose to cover Mr. Gifford's absence by adopting a reorganization within the system.

By so acting there will be no difficulty in making changes should they appear desirable or making the necessary readjustments when Mr. Gifford returns. Your servant was assigned to serve as High School Principal and to continue with the business administration of the school system. Miss Audrey Tripp was assigned to cover the teaching supervision of the first eight grades while continuing as Principal of the Factory School.

Mr. William Smith resigned his position of instructor in Agriculture to become manager of the Fall River Milk Producers' Association. Mr. Harold Wood, who had served as his part-time assistant, is now in complete charge of our Vocational Agricultural Department, serving on a full time basis. This year's enrollment has made it possible to operate with one teacher.

Miss Cahoon, who had too large a group last year, has a small Household Arts enrollment this year, and can give one-third of her time to other departments in the school.

Miss Audrey Tripp reports that:

"Each of the three new teachers in the elementary grades has commenced her first year as teacher with a display of seriousness of purpose and evidence of adaptability which should promise success in her chosen field.

Miss Ruth Davis' pre-primary and first grade groups at Greenwood Park School are "living" as well as "learning" under excellent inspirational direction.

Miss Barbara Manchester's work in grades three and four at the Head School is characterized by a thoroughness both in preparation and performance which manifested itself at the beginning of the year, in spite of the difficulty of working with a group which represented a wide range of mental abilities.

Miss Harriett Welch is doing outstanding work along the lines of individual instruction and her co-operation is of the highest type. (Miss Welch teaches Grades three and four at the Point School).

The elementary teachers, as a group, serve well and their work meets the needs of their pupils. The lack of publicity which their results receive is no reflection upon the quality of the work which they do."

Our Schools

Miss Tripp reports that: The "pre-primary placement policy for entering pupils finds approval among teachers and parents, and certainly gives the pupil a more hopeful start. This plan faces the problem of dealing with differences in maturity in reading — a condition always present in any school system. Some entering pupils have by this time been recognized as first graders and in each case the parent has been notified to this effect. There are at present thirty-one pupils under pre-primary classification."

"Curriculum changes include the addition of a course of study in art, for which subject an outline was prepared by Miss Lillian E. Elliott, Supervisor of Art in Fairhaven and Mattapoisett."

"The textbook change involved by the placement of the McConnell Geography Series in grades four and five finds good response. . . . The Directed Spelling Activities Workbook has been placed in grades one through six at Greenwood Park School and in grades seven and eight at the Factory School, with the view of experimenting for possible improvement in both spelling and vocabulary, our two weak points in all grades."

"Suggestions have been given to elementary school teachers for activities along lines of safety education. Each pupil has been familiarized with the set of bus rules which the School Committee prepared, and at

the Factory School a system of bus monitorship has been in operation since September. These pupils share the responsibility of bus safety and conduct. As bus complaints have been fewer than in past years up to the present time, perhaps there is merit in these plans."

At the Factory School "manual training continues to prove a great attraction to the boys, and Mr. Pierce is obtaining good results. . . . We regret that we are unable to offer some manual or domestic type of training for our girls."

"Handwriting tests, which are given in cities and towns representing all parts of the country, were taken by the eighth grade class last Spring, and results, very similar to those of the year before, showed our pupils to rate slightly above the average for their grade."

"Certificates denoting completion of the eighth grade were not awarded this year, in conformity with the ruling set forth by the School Committee. Parents were notified of the change of policy at the beginning of the year."

Diplomas are presented only to those who complete the high school course, but a certificate showing the grade completed may be secured by any ex-pupil of our school system.

"Music honors were attained last May by a group of seventh and eighth grade pupils who represented the Factory School at the Massachusetts Music Festival held in Plymouth, Massachusetts. This group received the highest rating in the junior high division." Miss Pluta and Miss Harrison directed this effort.

"Unusually good dramatic work under Miss Shay's capable direction was exhibited in the presentation of the three-act play, 'Good Night, Uncle George,' which was performed on May 23, 1941 by a group of Factory School pupils."

"During necessary absences from the school during part of the school day from September, 1941 to January, 1942, Mr. Sydney Pierce has served as Principal of the Factory School. Mr. Pierce's fitness in this capacity has been manifested in the efficient operation of the school and in the unusually fine attitude obvious among pupils and teachers. Miss Sullivan, Miss Shay, and Miss Harrison have taken over additional duties cheerfully and often voluntarily. This type of contribution, which each teacher of the Factory School has offered, is of inestimable worth to our school system."

"Our greatest need in all schools is the subject of citizenship, which actually should be the common objective of all teaching. In our quest for so-called 'progressiveness' in teaching with its accompanying twisting of techniques, mix-up of methods, and switching of subject matter, we have neglected the way to the most important end of all teaching — the preparation of our pupils for their places as good moral citizens in the community."

"Today we are members of a nation which is at war on the side of 'freedom.' In accepting the numerous 'freedoms' which are ours, we mistakenly include one which is ours by adoption rather than heritage — 'freedom from responsibility.' If this philosophy persists our pupils shall fail as we have failed in disciplining ourselves for the acceptance of the moral responsibilities which our *true* 'freedoms' impose."

The High School program is similar to that of previous years. We are making an effort to make our subject matter more practical and to continue and expand our small but well intentioned guidance program.

All regular pupils carry four subjects and usually have three study periods a day. An activities period

provides time for assemblies, class meetings, music and club activities. All boys and girls have an opportunity to use the gym twice a week during the cold months, and daily out-of-door activities are available during the warm months. Extra periods are used for detention study for those who for any reason are behind in their regular work.

The Student Council has been free with advice, suggestions and ideas. On the other hand, the members have accepted changes and modifications which seemed to me necessary. Both they and their fellow pupils have "played the game." No one is perfect and we have our problems, but I believe the spirit of fair play predominates.

Last Spring our Orchestra played at the Plymouth Music Festival and again received the highest award for schools in our classification. This fall we attempted our first operetta, "H. M. S. Pinafore." The results were gratifying but the production was so time-consuming that I feel inclined to advise against future efforts in this direction.

Boys' athletics have continued to play an important role in our program — I believe that they should. Properly supervised and held in proper relationship to the entire school program, they can be used to build character as well as brawn. Our boys know that they must meet their other school obligations if they are to represent us in competitive sports. Our numbers are small — ours is the smallest school in the league — and our record of victories a short one but we can lose and come back fighting. This past fall we had a football game with our rival, Dartmouth, and followed it with a joint dance that evening. Good fellowship prevailed and we proved that rowdyism need not accompany red-blooded competitive sports. The pupils of the two schools have set

a splendid example — may it be a guide to us all in our future associations.

We believe that in addition to the knowledge to be obtained from books, high school should provide youth with chances to accept responsibility, teach them to realize and respect the opportunities provided them at public expense, and provide them opportunities to serve their school, community and nation. Many of our girls and boys are serving in the office, on traffic duty in the school, assisting in the care of the yard, athletic field and auditorium-gymnasium, and helping in the preparation of hot lunches. Others are doing typing and mimeograph work both for the school system and civic groups within the town. Some have served with the local observation post and a group has been knitting sweaters for the army and navy personnel. Several girls assisted in the Annual Red Cross Roll Call.

The Federal Government, working through the Vocational Division of the State Department of Education, has established a Defense Training Unit at the Agricultural Shop. This course operates evenings four times each week and is open to boys between the ages of 17 and 24. We have been supplied with forges, a machine lathe, grinding machine, portable electric drill, a stationary vertical drill press, bench and hand tools, equipment for cutting thread, soldering, plumbing and simple sheet metal work. Our third group is now making cold chisels to be used in defense work. All operating expenses are paid from Federal Funds.

The Calendar which you have adopted for the school year 1942-1943 will provide for two rather than one vacation period after Christmas. This so-called eight weeks' system is widely followed throughout the State and a survey of our teachers and parents last year indicated that a substantial majority

wished to try the plan. 1943 provides a splendid opportunity as the extra week of vacation will only extend the school year two days at that time.

In the Elementary Schools as well as at the High School efforts to assist in the national defense are evident. Defense Savings Stamps are being purchased, metal collected, our own supplies conserved, and most of our pupils are looking for opportunities to help in every way they can.

In conjunction with the Chief Air Raid Warden, we have arranged at North Westport to place the children in nearby homes thus spreading the risk in case of an air attack. In the other schools the children will be taken into nearby woods in case of an actual raid. Our frame buildings offer no protection in case of direct bombing and we consider it safer to spread the risks.

The local Branch of the American Red Cross has continued its aid to our Health Department. Dr. Burt has again provided preventative diphtheria treatments, and the Board of Health has had a Dental Clinic in operation, which is much needed and greatly appreciated.

Added to your usual responsibilities has been the emergency involving the High School water system. The cheerful manner in which you have given unstintingly of your time and advice has been an inspiration to me which I cherish and appreciate. The cooperation of our Fire Department and our good neighbor, Albert Wood, made it possible for us to continue school. I take this opportunity to thank you and them for the service rendered this community.

Much there is that might have been done, much that remains to be done. School Department employees, pupils, parents and interested citizens, including your

own body, are to be commended for what has been accomplished.

May we continue to work together effectively to do our small but necessary parts in winning the war, securing the peace, and safeguarding the Republic of the United States of America.

REPORT OF SCHOOL PHYSICIAN

January 27, 1942

Dear Sirs:

The following is submitted as a report of the School Physician for 1941.

The routine examinations of pupils were made and the proportion of defects seems large but the number of serious conditions is very small, the largest number being for teeth needing correction, and round shoulders. While these two conditions are not serious they certainly need attention. So far as the teeth are concerned, the Dental Clinic is working on these defects.

There have been two epidemics, one of chicken pox and one of scarlet fever, which have interfered considerably with the attendance. However, these cases have been extremely light with no complications.

I note with pleasure that all school teachers are to be instructed in first aid. I think this will be of great value to the schools and it is hoped that those teachers that live in town will be available for Civilian Defense.
