



Edward L. Macomber was appointed Agent of the Board to receive reports of contagious diseases.

Mrs. Sybil L. Mercer was re-engaged as Community Nurse, and Miss Elizabeth A. Davis and Mrs. Grace DeAndrade as substitute nurses.

For Inspectors of Slaughtering, John C. Partington, John L. Duffany, and Edward S. Francis were reappointed.

Forty-three (43) burial permits, thirty-six (36) milk licenses, eleven (11) alcohol licenses, and fourteen (14) licenses for transportation of garbage were issued during the year.

It has been a difficult year for the Dental Clinic. In the beginning of the fall schedule several school days were not in session due to registration for draft, sugar, oil and gas. Therefore, we were late in starting. Early in December, it was found advisable to discontinue the clinic because of the difficulty in heating the Board of Health Rooms.

It will be noted that there are 33 examinations listed. This means that 33 children were brought to the clinic who did not need dental care. A dental survey would clear up this situation and should in my opinion be considered, or a system established whereby these children could be weeded out.

Please note that extractions have fallen off since our service was first established, demonstrating that early care does save these teeth.

As supervisor of the Nursing Service, I wish to call attention to the fact that in addition to the usual bedside nursing, there were 680 calls for Social Service to the needy. Beside this the nurse transports patients to the clinics and hospitals, not only local ones but as far away as Tewksbury or Pondville. She also assists at the vaccination, dental and T. A. T. clinics, transports children to and from summer camps and many other miscellaneous services. As supervisor of the Dental Clinic, I regret to report that because of lack of heat we are unable to report as many cases as for-

merly but this deficit will be made up as soon as it is possible to use the Dental room.

BOARD OF PUBLIC WELFARE

The Board met March 12, 1942, and organized by appointing Samuel A. Boan, Chairman. Regular meetings have been held on the first Saturday of each month, with such special meetings as were necessary from time to time.

Thelma McHugh and Jessica E. Cornell have continued to serve as Welfare Agent and Clerk-Typist, respectively. The Agent was also appointed to act as Referral Agent for the Works Progress Administration and as Certifying Officer for Federal Surplus Commodities.

The operation of the Commodity Center was transferred to the Welfare Department after the annual Town Meeting and it continued to distribute surplus commodities until the expiration of the contract in June. It was felt that employment conditions and wages were much better and that the project could be discontinued at that time without causing undue hardship to the recipients. We wish to express our appreciation for the manner in which Warren Tripp and Emily Sisson operated the commodity center.

The welfare case load decreased slightly during the year and aid is now granted to persons who are unemployable, due to physical incapacity.

The State Department furnished local Boards of Public Welfare with detailed budget schedules which are changed from time to time to meet the increased cost of living and which are a valuable means of insuring a more equitable treatment of needy persons throughout the State.

Total expenditures for Public Welfare aid, including Commissary and Infirmary costs, were \$11,858.68. Reimbursements from State, cities and towns were \$3,383.11, leaving a net cost to the town of \$8,475.57.

The total cost of administration for all types of relief has been \$4,085.28. The Federal reimbursement from Aid to Dependent Children is one-half of the actual expenditures figured on a case load basis and we received \$99.82 during 1942. We have received \$814.11 from Federal funds for administration of Old Age Assistance. Net cost to the town — \$3,171.35 for administering \$72,617.20 in assistance.

The war has also broadened the scope of activity of local Welfare departments. The Governor has issued

Executive Orders No. 30 and No. 45 which provide Civilian War Assistance and a Civilian Emergency Relief Fund to be distributed by the Massachusetts Department of Public Welfare to civilians who need assistance as a result of enemy action, the threat thereof or inability to secure adequate fuel by reason of the scarcity thereof.

Thelma McHugh has been appointed by the State to act as Welfare Representative and Authorized Agent in the town of Westport. Plans for mass evacuation as well as for individual case care, call for close cooperation between the Selectmen, the Evacuation Officer, the Health and Social Service Committee, the Red Cross, the State and local Welfare Departments. Volunteer workers are urgently needed to be trained to meet any such emergency.

The services of the Agent have also been used by the Selective Service Board to supplement the usual questionnaires and by the Red Cross, to supplement its Home Service. We trust that any home contacts which we have made for the members of the armed services have helped to relieve the anxiety of both our service men and their families.

We wish to extend our sincere appreciation for the cooperation shown by all departments in carrying on our varied programs.

The local Bureau adjusted all grants as of May 1, 1942, to conform to the minimum requirements as required by the new Old Age Assistance law. The State Department of Public Welfare has furnished detailed schedules covering both the needs of an individual applying for assistance as well as a schedule of deductions to be used in determining a reasonable contribution from legally liable relatives. These schedules are based on state-wide surveys of usual living conditions and are the result of careful study and planning by trained workers. As such, they are a valuable basis for determining need of public assistance.

The increased cost of living, necessitated a revision of the State budget effective in August, 1942. It is the intention of the State Department to submit new schedules every six months with such other special policies as are indicated from time to time.

The Federal reimbursement on administration from Old Age Assistance is figured as 2/3 of the 5% of the total Federal reimbursement for aid and amounted to \$814.11 during 1942.

The Trustees of the Free Public Library submit the following report for the year ending December 31, 1942:

Early last year, Ruth M. Davis was chosen as a member of our Board of Trustees to fill a vacancy caused by the resignation of Louise A. Feenan.

Because of the gasoline shortage the Library hours were changed during March to Saturdays from 2:30 to 6:30 P. M. inclusive. The Library was open every Saturday except when it came on a holiday, in which case, it was open the preceeding Friday, and due notice was posted on the bulletin board.

No assistant Librarian was appointed, as the Secretary volunteered her services, without pay, when an assistant was needed. In case she was not available, the Librarian was authorized to hire an assistant, the pay to be twenty-five cents per hour.

During September, we discussed the advisability of closing the Library every other Saturday. This was tried for one week, but the demand of our readers was so great that we opened it again as usual. This showed us that they did and would read the books even though they might have to go without some other things. Now, during the cold months, we are forced, through

oil shortage, to open but once a month, and even then the Library is heated none too warmly.

In spite of these difficulties, the circulation has been maintained for the past year by allowing our patrons four or five books per card instead of three, as before. We have not had the help of the Bookmobile as often as in the last last year. The circulation is as follows:

We still have three book deposits, one at the Factory Junior High School, under the direction of Miss Bessie Shay. The pupils show great interest in the books and have had from 50 to 75 books four times during the year. The increasing interest in books is shown by the growing number of state certificates for reading twenty books. In previous years, we have given the names of pupils receiving these certificates, but this year, there are so many that this is impracticable.

They are as follows: For reading 5 books, 204; for reading 20 books, 25; for reading more than the prescribed number, 7 honorary certificates.

The second book deposit is at Brownell's Corner and the third at North Westport. As we stated last year, these children are much younger and are not required to write book reports. Their interest in books is very good and we hope that their early interest will show results by the time they reach the Junior High School.

As a number of people are interested in the way our appropriation is spent, we are, as usual, putting in the account.

For the purpose of binding the Geographics, we were granted an extra appropriation. As a result we have many beautiful and valuable books. We wish that more people would come in and look them over. Some of the pictures were taken before the war, in places that have since been taken by the Axis, and which can never be the same again.

The State Public Library Department is always very kind and generous in lending us any books which we do not have, and many people avail themselves of the service.

January, 1943

In accordance with custom I submit the fiftieth in the series of annual reports of the school superintendents of this town.

OUR TEACHERS

Mr. Norman L. Gifford continues on leave of absence through June, 1943.

Lieutenant John Dolan, U. S. Army, is on military leave of absence.

Mr. David Pierce has transferred to the faculty of the Providence Country Day School.

Mr. Sydney Pierce is teaching science at the High School and acting as Principal of the Factory School.

Miss Pauline Smith, State Teachers College, Salem, Class of 1942, is regularly employed as commercial teacher at the High School.

Mr. Hector Brabant left to engage in an important war activity.

Miss Jean F. Marks, a graduate of Boston University in June, 1942, was appointed Vocal Music Supervisor, to replace Miss Dorothy Pluta, who married.

Mr. Charles J. Kulick, Principal of the Greenwood Park School, is now in the Army and on military leave of absence. Miss Hazel Tripp is acting as Principal during his absence.

Miss Eunice Harrison and Miss Harriett Welch left our system to accept teaching positions elsewhere.

Mrs. Dorothy Smith and Mrs. Marion King are serving as military substitutes and teach at the Factory School. Mrs. Catharine Lomax, a former principal at the Factory School, is now teaching there and is in charge during Mr. Pierce's periods at the High School.

Miss Audrey Tripp is devoting full time to the supervision of grades 1-8 and otherwise assisting the superintendent during this period of never-ending change and uncertainty.

The automatic increases have now restored our teachers' salaries in elementary grades to the pre-depression level. In addition a \$50 bonus proposed by you and approved by the Finance Committee and the Town Meeting was paid during the fiscal year 1942.

Living costs have continued to advance and I am pleased that you have accepted my recommendation for a \$100 bonus during the fiscal year 1943. I hope that the Town Meeting will support this request. Even if such a bonus is allowed, our teachers will receive less than neighboring towns in Bristol County are paying for similar services.

THE HIGH SCHOOL

As is true everywhere, our school population has decreased. Employment and service opportunities account for this. The war demands on teachers have more than offset the smaller pupil load but the members of our faculty are working faithfully and cheerfully and I am pleased to commend them. In response to the demands of the armed services and because we believe them desirable subjects for our high school to offer, this year we are offering physics, trigonometry, and solid geometry.

A physical education program is in process of materialization for all of our pupils. Sewing, knitting, and bandage rolling as a part of our war service are supervised by our teachers, and Miss Doyle and Miss Cahoon are now taking a "Teacher Training Course" so that they may offer Red Cross First Aid Courses to our pupils. Several of our boys are Volunteer Firemen subject to call during school hours. This has the approval of their parents and is necessary due to the shortage of man power.

While our Agricultural group is smaller than usual, Mr. Wood has been kept well occupied with the Defense Training Courses conducted with the approval and support of the Government and designed to help our citizens keep their farm machinery and rolling stock in operation. He also put much time and effort into placing both agricultural and non-agricultural pupils where they could be of the most assistance to the greatest number of our farmers. Forty-five of our boys were employed on 51 different farms during the past year. The Agricultural Class produced \$6,167.74 in projects and in addition earned \$6,392.08 in farm or related activities.

THE ELEMENTARY SCHOOLS

Portions of the report of Miss Audrey Tripp follow:

"Two changes have occurred in the housing of some of our pupils. The class for ungraded pupils formerly held at Beulah Road School is located now in the portable at Greenwood Park School. Although the addition of this group has caused larger classes in the first six grades of the Greenwood Park School, where enrollment in September was larger than anticipated, no classroom is now overcrowded. Furthermore, in addition to the financial saving and transportation conservation realized, the ungraded class are enjoying the social benefits of companionship with other pupils of their age which their previous isolation did not allow.

As only eight pupils had entered the third and fourth grades at Brownell's Corner School by September 16, and as we knew of no others who planned to enroll, this room was closed for the remainder of the school year. In all cases parents of the pupils affected were given an opportunity to name, from one of two schools to which transportation would be provided, the school to which their child was transferred. (Mrs. Hattie Norton served as teacher of grades three and four at Brownell's Corner School until the room was closed).

A uniform marking system for all schools (including High School) was put into effect in September. The system is as follows:

A=Honor Work (for outstanding achievement).

B=Creditable Work (for work that can be certified to other schools).

C=Passing Work (for credit toward promotion).

F=Failing Work (no credit toward promotion).
No plus or minus signs are to be used.

The exponents 1, 2, 3, shall be used in connection with all grades to indicate the attitude and effort of pupils in the subjects graded.

The following principles in marking have been forwarded to all teachers:

1. Marks should be **cumulative** from term to term throughout the school year. (Not just the final mark).
2. Marks should represent the actual progress the pupil has shown while under **our guidance** during the **present school year**.

The above system and suggestions are by no means the answer to the marking problem. However, the simplicity of the plan makes less complex than formerly the interpretation of the position of the individual pupil.

The McConnell Geography Series is now complete in all schools, with the addition this year of the assigned texts in grades three, six, and seven.

The adoption of the McGuire History Series in grades four through six, which will be ready for class use this month, now makes our history and geography program complete and uniform in the elementary schools.

Music training, from the standpoint of both technique and appreciation, is progressing effectively this year under the direction of Miss Jean F. Marks, who was appointed Supervisor of Music in September. Miss Marks has demonstrated her fitness for this position by combining the advantages of an excellent academic background and native ability with a manner modest

yet confident, to win hearty response from pupils and genuine approval from teachers.

War bonds and stamps are now sold directly through every school (including the High School) and since the beginning of the present school year pupils and teachers have bought bonds and stamps to the amount of \$1,149.99.

Many pupils participated in the 4-H Victory Garden program during the summer and boys in the upper grades assisted in local harvesting this fall.

All pupils took part in the National Scrap Drive in October and as a result were awarded a prize of seventy-five dollars. This prize was presented by the New Bedford Standard-Times to the group who was responsible for the collection of the second largest amount of scrap metal in the towns of Bristol County. Mr. Loren W. Park was Chairman of the Westport Salvage Committee and headed this project.

The majority of pupils in all schools are members of the Junior Red Cross and some schools have organized units active throughout the year. All schools voted to contribute their share of the Scrap Drive Award to the Junior Red Cross to be used to outfit overseas kits for men in the armed services of our country.

The 'School at War' project sponsored by the Treasury Department is being carried on in every school.

During the present conflict, if our schools are to continue to function, our greatest job is, as ever, to produce in every individual a free mind, yet a trained one; a free hand, yet a skilled one; a free heart, yet a tolerant one, and the understanding that these freedoms must come only through discipline and hard work."

Our schools know there is a war. Our pupils are missing much of the good time features of the usual school year. They are also losing some educational opportunities due to time lost in handling the rationing program. The high school program has been hard hit by both rationing and our efforts to supply our farmers with much needed assistance. Our pupils are accepting conditions cheerfully and their sacrifices should pay dividends in the years to come.

Both older pupils and our teachers have given liberally of their own, as well as school time, in meeting the special demands of the Draft Registration, the several rationing programs, the war-time courses, and the Civilian Defense activities that now abound in every community. These responses are only what we have a right to expect from all good citizens; nevertheless, I know that you and all of our citizens appreciate their offerings and on your behalf as well as my own I compliment them.

Mr. John Cunningham, who has been janitor at the Head School for more than 28 years, resigned on January 20th. He worked during that day but was obliged to resign that evening and is (at the time of writing) confined at Truesdale's Hospital in Fall River. Mr. Cunningham's service has been most faithful, we shall miss him at the school. I know that we all wish him a speedy and complete recovery.

School Department activities bring us in contact with all the other Town Departments. Their co-operation is splendid. Conditions are unusual and the public's continued patience proves very helpful. I take this opportunity for all School Department employees to thank you. We shall endeavor to prove worthy of your trust.
