Library hours for 1948 which were every Monday evening from 7:00 to 9:00 P. M. and Saturday afternoons from 2:00 to 5:00 P. M. have been successful as has been proven by greatly increased circulation. Mrs. Mildred A. Brightman continued as librarian and Charles A. Brightman, assistant librarian.

Due to a small increase in our appropriation the committee was able to purchase a number of good books and we have hopes that at least the same amount will be granted in order to keep our shelves as up to date as possible.

Again we, who are on the committee, wish to say any suggestions for new books will be welcome and will do our best to have them placed in our library.

The pictures are not only entertaining in themselves, but are a means toward visual education for children.

The other service is the start of a library of phonograph records. This is to be the library's contribution toward music appreciation, wholesome entertainment, and education in the sciences of health, safety and general knowledge.

Many of the records will be the unbreakable type and will be available for home use. They will be loaned just as we now loan books with the same precautions and care given them by the borrower.

By this means will be an opportunity for audio education created by artists in their own particular field, yet the method will be fun for the children and create constructive thinking. This plan will be especially offered to the schools.

How these services will be received lies in their trial and use. We invite suggestions, hoping the patrons might enthuse us further by their own enthusiasm.

REPORT OF ELEMENTARY SUPERVISOR

Mr. Milton E. Earle Superintendent of Schools Westport, Massachusetts

My dear Mr. Earle:

The following is my report for the year 1948.

Changes in the teaching staff of the elementary schools 'have been excessive, with only the North Westport and Point Schools-retaining their teachers of the previous year.

In addition to numerous transfers of teachers already in the system (these changes may be noted in the Directory of Teachers), the following new teachers were appointed:

Miss Angela Perry of Fairhaven, a 1947 graduate of the State Teachers College at Worcester, with one year's teaching experience in Ashfield, Massachusetts, is teaching social studies in Grades 7 and 8 at the Factory School.

Mrs. Mary Wilkinson of Fall River, who had previously served as teacher in the Westport Schools, returned to the staff during September and is teaching the Pre-Primary Class at Greenwood Park School.

Mrs. Mildred H. Gifford of Westport, a graduate of Salem Normal School and with teaching experience in Somerville and Westport, is teaching Grades 1 and 2 at Brownell's Corner School.

Mrs. Ruth Pilkington of Westport, a graduate of Bridgewater Normal School and a former teacher in Oak Bluffs, is teaching Grade 5 at Greenwood Park School. Mrs. Marion S. S. Reed was granted a leave of absence until September, 1949. Mrs. Reed spent the summer studying at the University of Wyoming, taught in Wyoming schools through December and will further her studies at the Rhode Island College of Education in February.

Mr. John Donald, Jr. of Osterville, a graduate of the State Teachers College at Hyannis, and with teaching experience in Brewster and Orleans, was appointed to teach Grade 5 at Greenwood Park School in September. Mr. Donald resigned in November because of ill health and died on January 19, 1949. During his short stay in Westport, Mr. Donald was well received by both pupils and fellow teachers and in his passing both we and the teaching profession have realized a distinct loss.

Mrs. Kate W. Tallman retired in June and the Special Class was discontinued. Her death so soon after retirement was a tragic shock to pupils, teachers, and citizens of Westport who knew of her good work with children. Mrs. Tallman's devotion to the children of Westport extended beyond the classroom and she was known throughout our county for her outstanding leadership in Church, Grange and 4H work.

Our enrollment in the Pre-Primary group was larger this Fall and necessitated the reopening of Brownell's Corner School. Although this school was closed in June at the request of parents whose children attended this school last year, it was reopened during September after widespread requests of parents for admission of their children to school had been received.

Three rooms have over forty pupils enrolled and two rooms have less than twenty. As different group levels are represented, there is no practical way of equalizing classroom loads. If present trends toward increased school population continue, it is probable that double shifts will soon be necessary in some of our schools.

Our offerings to Westport pupils in the fields of art, vocal music and physical education are still meager, as we have still been unable to secure a supervisor for each of these fields.

A science program in the first six grades is underway. Commencing with Grades 5 and 6 at the Head School this month, we hope to extend this instruction to other classes in the Fall.

Thurstone's Tests of Primary Mental Abilities have been administered to 68 entering pupils. Besides indicating general intelligence, significant abilities are measured which are of importance to the teacher in predicting, to a certain extent, reading success, maturity in quantitative thinking, skill in handling spatial relations and readiness for manipulating pencils and other tools of the elementary grades.

The purchase of a 16 mm sound projector and transcription player for use in Elementary Schools has already made possible several worthwhile programs. A planned program of instruction to supplement classroom teachings through the use of these aids is underway.

Remarkable growth continues in the field of instrumental music under the leadership of Mr. Frank P. Gonsalves, Director of Instrumental Music. The opportunity to take lessons on the basic musical instruments has been extended to the pupils of every school. At the present time 76 pupils are taking these lessons in school.

Numerous achievements in the school health program were carried out largely through the efforts of Mrs. Lydia Mason, R. N., School Nurse. Highlighting her accomplishments are introduction of a School Entrance Clinic for beginning pupils, production of an "Off To School" booklet for parents of entering pupils, formation of a Health Council and preparation of a Health Bulletin for teachers.

With the assistance of Miss Margaret Bauer, Consultant Nutritionist for the Department of Public Health, surplus food commodities have been made available to Westport pupils.

Teachers are utilizing this situation, as well as the motivation of talks given by Miss Bauer in all schools, to carry on a program of improved nutrition. Art and language lessons are planned using this theme. Better school lunches are one significant result of this activity.

I recommend the further extension of this objective of improved nutrition by the introduction of the Type A Federal Lunch Program in one of our schools in the Fall. This program, financially assisted by the Federal Government, provides a complete school lunch for every child.

While there is some expense involved in initiating this project, in the purchase of equipment and material, in time the program should pay for itself. In some communities some profit is realized in this undertaking.

As the Head School is in the best physical condition of any of our elementary school buildings, and as some provision has already been made for such a project, I believe that our first attempt at carrying on this program should be made here.

The most serious problem confronting us at present and one which has always persisted to a certain extent is the unsatisfactory conduct of our pupils on the school buses. Some of our children ride on a school bus three hours each day—more than half the time which they spend in the classroom! Yet there is no direct supervision of the activity of these pupils.

Parents and teachers are not on the school bus and direction by remote control is ineffective. The school bus driver's first job is to operate the school bus in safety. Persisting reports from pupils, parents, teachers, and citizens of the town indicate that conditions detrimental to the health, safety and morals of our pupils now exist. Here is certainly a situation where self-control, respect for people and property should be practiced and mastered.

I recommend that matrons be employed by the School Department to ride on our school buses and be given the authority necessary to maintain proper behavior.

With each year our teachers are realizing the ever increasing scope of their responsibilities. The ability and devotion of our teachers is made evident in their acceptance of these added responsibilities which more and more call for a clearer understanding of the child. The child's problem, in whatever field it may be, is now the teacher's problem.

Only community support will make possible the objective of every good teacher—to so effectively guide the pupil that he may "make satisfactory adjustments to the society of which he is a part and so that he may contribute, to the best of his ability, to the common good".

TEACHER PROBLEM

The supply of elementary teachers is still very short. As our primary school population throughout the country is due for rapid expansion shortly, this shortage is likely to continue for some time.

More high school teachers are available now than during the war years but we have been unable to employ an agricultural teacher for this school year. I hope to have a satisfactory teacher for July 1st. Miss Mary Monti has replaced Miss McGorty as our commercial teacher and I am well pleased with the start she has made. Mr. Thomas Booth has just come in to help with our science problems until an agricultural teacher is available.

Expanding salary schedules, a single salary schedule for *all* teachers, and increases in current salaries for all teachers, is almost universal in this area. If Westport is to hold teachers and hire new ones something along the same lines must be done.

HIGH SCHOOL

The curriculum remains the same as last year and the 50 minute class periods are paying dividends.

The new bus program which you have approved allows all of our pupils to leave for home by 2:20 p.m. The increase in transportation costs will more than be met by the State Aid for transportation which we now receive. Not only does this program allow our pupils time for work at home but it has cut our disciplinary problems at the school to a minimum.

Of last year's graduating class, at least three are attending college, several have gone to Hospital Schools of Nursing, and at least four boys have entered the military service of the United States. Some war veterans from Westport continue to enter college and, to the best of my knowledge, none have dropped out to date.

PROMOTION OF HEALTH

Dr. Wilson E. Hughes, Pediatrician at the Truesdale Hospital, is now serving as our School Physician.

For information on the functioning of this Department, I refer you to the reports of the Elementary Supervisor and the School Physician and School Nurse.

THE SCHOOL PLANT

The Head School has been redecorated inside and all outside trim has been painted.

Inside decoration and the installation of storm sash at Booth's Corner and Brownell's Corner Schools is practically completed.

The Commercial Room at the High School and the two north rooms at the Factory School have been equipped with fluorescent strip lighting.

The oil burner at the North Westport School is functioning and we no longer have to contend with coal dust in the class rooms.

More land was purchased at Greenwood Park and a portion of the plot east and north of the Portable has been graded. To do a real job the grade of School Street should be established and an appropriation for grading and fill provided.

Plans for a real school plant are well in the making, and I should like at this time to sum up the activities of the School Department to this date.

At a Special Town Meeting held July 15, 1946, the Town authorized the School Committee to apply for Federal Funds for necessary surveys and architects' drawings of desirable school buildings to meet the needs of Westport.

Dr. Herbert H. Blair was employed to make the survey and his report was received May 14, 1947. As a result of this report, it was decided to select a site and draw plans for a six-year high school plant that would care for 350 to 400 pupils.

Federal Funds of \$11,750.00 were made available June 12, 1947 and an engineering survey of the land between the Town Office Building and the High School was made. This plot was Dr. Blair's recommendation as a site for the proposed building.

Architects were consulted and on July 30, 1947 a contract was executed with J. Williams Beal, Sons, of Boston, to serve as architects.

At an open meeting held at the High School Auditorium to discuss our school housing problems a volunteer committee was organized to work with the School Committee in selecting a High School site. Mrs. Frank Babbitt of Horseneck Road, Mrs. Harold Riendeau of Briggs Road, Mr. Douglas Borden of Old Bedford Road, Mr. Roland Imbeau of State Road, Mr. Frank De Andrade of Gifford Road, Mr. Isaac Tripp of Sodom Road, and Mr. Andrew Lees of south Drift Road worked with the School Committee and this group unanimously chose a site at Gifford's Corner. This selection followed an engineering survey and had the approval of Dr. Blair and the architects' representative, Mr. John Beal.

At a Special Town Meeting held November 3, 1948, the Town authorized the Selectmen to purchase this site (with the exception of the home of Mr. Rego). The voters assembled were advised that, should the building be constructed, it would also be necessary to purchase the home site of Mr. Rego.

)

The architects are now working as rapidly as is consistent with intelligent planning to draw the plans and specifications and it is expected that they can meet the Federal dead-line of June 30, 1949. At this date the general layout and type of construction has been determined and floor plans are outlined. The building proposed is functional and follows modern first class construction principles.

RECOMMENDATIONS

I beg to recommend to the School Committee:

- 1. Positive action in relation to a salary schedule that will keep us in at least as good a competitive position for securing teachers as now prevails.
- 2. The scrapping of the Portable Building at Greenwood Park even though it means a double shift school in the main building.
- 3. A complete interior decorating and lighting job for the main building at Greenwood Park and the development of a community play field at that site.
- 4. A complete interior decorating and floor refinishing job at the North Westport School.
- 5. Some interior decorating and fluorescent lights in the south rooms at the Factory School.

IN CONCLUSION
