On March 12th the Board Adopted without amendment, regulations for the control of Communicable Diseases as formulated by the State Department of Health.

Due to a series of nuisance complaints received in 1949 it was deemed necessary to adopt regulations for the control of Commercial Piggeries. These regulations become effective on January 1, 1950 and have been published in accordance with Chapter 111, Section 31.

On February 23, 1949 the State Department of Health advised of the termination of their program for the analysis of individual domestic water supplies, except in instances where suspected pollution may have caused sickness. However, the State Department will continue this program on schools, dairies, roadside stands and other semi public water supplies.

Persons effected by this change may have an analysis made for a nominal fee by a private laboratory of their choice, or by making inquiry to the Board.

Regular meetings have been held throughout the year. Complaints and other matters have been processed as promptly as possible.

For a financial report please refer to the report of the Town Accountant.

The Board wishes to thank the towns people, various organizations and all Departments concerned for their cooperation during the year.

REPORT OF THE TRUSTEES OF THE WESTPORT FREE PUBLIC LIBRARY

Regular library hours are Saturdays 2:00 P. M. to 5:00 P. M. and Mondays 7:00 P. M. to 9:00 P. M. When Holidays occur on these days, advance notice is given in the newspaper that the library will be closed, and due date of books is extended one week. The library is also opened each week of the school year for the convenience of high school pupils, and at various other times to permit loan and exchange of books among the elementary schools of the town.

An attempt has been made to keep our shelves as well stocked as available funds will permit, with books that comply with the interests of our readers, as indicated by their requests and by circulation statistics. Several times a year the trustees in charge of book buying go to the New Bedford and Fall River book stores to select new and best-seller books in non-fiction, adult fiction, and juvenile classifica-

tions. Occasionally some books of proven popularity, that had not been purchased previously, are picked up at the bargain counter. In addition we receive one love story, one western story, and one mystery story each month from a book-club subscription. Many of the leading magazines are available in the periodical section of our library, and the purchase of a few reference books, from time to time, is intended to make our library a place to which the townspeople may turn in search for diverse types of information.

With a view toward making our library a more comprehensive cultural institution, several innovations have been initiated in the past year or two. The increasing popularity of the albums of recordings is some indication of the value of this means of edification. More films have been purchased for the View Master, which has been received enthusiastically by library patrons of all ages. A projector-type View Master was obtained late in the year. This machine is designed to project the films on a screen for group viewing, and it, like the recordings, is available for loan to schools and community organizations. Mrs. Tripp deserves credit as the motivating force behind these innovations.

A reading table has been arranged in the library in the hope that patrons will be encouraged to peruse more extensively and at greater ease.

These figures show a marked general increase in circulation, due largely to the increased availability of books made to school children, and to the increased use made of the library by summer residents. Circulation of juvenile books for July and August of 1949 was 60% greater than for those months in the previous year.

Higher cost of books and new library services render insufficient the funds alloted to the library, but it is hoped that a larger appropriation may be forthcoming, to insure that the library may continue toward being an institution to which the people may point with pride.

The trustees are appreciative of the faithful efficient service of the librarian and assistant librarian.

Sir:

As directed by you, I have made an audit of the books and accounts of the Town of Westport for the period from October 26, 1947, the date of the previous examination, to June 6, 1949, the following report being submitted thereon:

The financial transactions, as recorded on the books of the several departments receiving or disbursing money for the town or committing bills for collection, were examined and checked with the books of the town accountant and the town treasurer.

The books and accounts of the town accountant were examined. The receipts, as recorded, were checked with the treasurer's books and with the records of the several

departments collecting money for the town, while the payments were checked with the treasury warrants and with the books of the treasurer.

The appropriations as listed from the town clerk's records of town meetings were checked to the town accountant's ledgers. The ledger accounts were analyzed, the necessary adjusting entries were made, and a balance sheet, which is appended to this report, was prepared showing the financial condition of the town on June 6, 1949.

Attention is called to the delinquent tax accounts dating back to 1941, as appearing on the balance sheet. There are sufficient remedies under the Law with which a collector may clear his warrants, and it is therefore urged that prompt action be taken to obtain a settlement of all prior years' taxes, as such action will improve the financial condition of the town.

The books and accounts of the town treasurer were examined and checked in detail. The cash book was footed throughout, the recorded receipts were analyzed and compared with the departmental records of payments to the treasurer and with other sources from which money was paid into the town treasury, while the disbursements were compared with the town accountant's books and with the treasury warrants. The cash balance on June 6, 1949 was proved by reconciliation of the bank balance with a statement furnished by the bank of deposit and by actual count of the cash in the office.

The recorded payments on account of maturing debt and interest were verified by comparison with the amounts falling due and checked with the cancelled securities on file.

The savings bank books and securities representing the investments of the trust and investment funds in the custody of the town treasurer were examined and listed, the income being proved and the transfers to the town being checked with the treasurer's recorded receipts.

The records of tax titles held by the town were examined and reconciled with the tax collector's books and with the accountant's ledger, while the redemptions were checked with the treasurer's cash book. The tax possessions were examined and listed, the additions as a result of tax title foreclosures being proved and the sales being compared with the treasurer's recorded receipts. The tax title and tax possession transactions were further verified by comparison with the records in the Registry of Deeds.

The books and records relative to the public landing in custody of the town treasurer, as treasurer of the Town Landing Commission, were examined and checked in detail. The charges representing the leases of the several properties were examined and the payments to the treasurer were checked. The cash book was footed, and the cash balance on June 6, 1949 was verified by actual count of the cash in the office and by examination of the savings bank book.

The books and accounts of the tax collector were examined and checked in detail. The tax and motor vehicle and trailer excise accounts outstanding at the time of the previous examination and all subsequent commitment lists were proved to the warrants issued for their collection. The recorded receipts were checked with the payments to the treasurer and with the accountant's books, the abatements as recorded were compared with the assessors' record of abatements granted, and the outstanding accounts were listed and reconciled with the accountant's ledger accounts.

The records of departmental accounts receivable were examined and checked. The commitments were proved, the payments to the treasurer were compared with the treasurer's cash book, and the outstanding accounts were listed and proved.

The outstanding tax, excise, and departmental accounts were verified by mailing notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

The town clerk's records of dog, sporting, and town licenses issued were examined, the payments to the State being verified by comparison with the receipts on file and the payments to the town treasurer being compared with the treasurer's cash book.

The surety bonds furnished by the town officials bonded for the faithful performance of their duties were examined and found to be in proper form.

The records of licenses and permits issued by the selectmen and by the police and health departments were examined and checked, the recorded collections being compared with the payments to the treasurer.

The records of the sealer of weights and measures, as well as of all other departments collecting money for the town or committing bills for collection, were examined and checked in detail.

In addition to the balance sheet, there are appended to this report tables showing a reconciliation of the treasurer's and the collector's cash, summaries of the tax, excise, tax title, tax possession, departmental, and public landing accounts, together with tables showing the condition and transactions of the trust and investment funds.

For the cooperation extended by the various town officials during the progress of the audit, I wish, on behalf of my assistants and for myself, to express appreciation.

The balance of this report comprises the combined efforts of the Elementary Supervisor and your Superintendent and is presented in this form in an attempt to conserve time and avoid repetition.

MUSIC

Miss Barbara S. O'Neil was named Supervisor of Vocal Music on a part-time basis and has been working in all our schools since September. She is a graduate of Marymount College, Tarrytown, New York, with a B. A. degree in music.

Mr. Frank P. Gonsalves continues as director of Instrumental Music and there are now more than 100 of our school pupils training on musical instruments. Orchestras are established at the Booth's Corner, Head of Westport, Factory and High Schools and group work as well as individual study is operating in all of Westport's schools.

OUR ELEMENTARY SCHOOLS

On April 25, 1949 the Westport School Committee voted to discontinue the Pre-Primary classification for beginning pupils. All pupils entering school for the first time are now classified as first graders. 90 children entered in first grade in September and census figures indicate that at least 115 can be expected in September, 1950.

September saw the return of all regularly employed elementary school teachers to their teaching positions in Westport.

Mrs. Marion S. S. Reed returned to the fifth grade at Greenwood Park School after a year's leave of absence devoted to teaching and further study.

On September 28th, Mrs. Ruth Pilkington replaced Mrs. Irene Caswell at the Head School and was assigned to teach grades 4 and 5.

Mrs. Caswell accepted a transfer to the Brownell's Corner School as teacher of grade 3. (This room was reopened because of overcrowded conditions at the Head and Greenwood Park Schools). Pupils in grade 3 at the Head School were transferred to Brownell's Corner School and some sixth grade pupils were transferred from Greenwood Park School to the Head School. A sixth grade, and a fourth and fifth grade combination, in addition to grades 1 and 2, now make up the Head School population.

This is the second successive year in which it has been necessary to reopen a room and reassign pupils after our schools opened in the fall. Only the double shift remains as an immediate means of carrying the increasing pupil load.

The larger the class, the more difficult it becomes for our teachers to meet the main objective of our educational program, i. e. the recognition of and provision for the individual needs of every pupil in the class — physical, mental, social, and emotional. However, our teachers are still making extraordinary efforts to carry out this purpose.

To those citizens who continue to keep faith in our teachers and their work in the schools, we are most thankful.

Not only do our teachers deserve this backing, but this support will also help them to continue to have faith in themselves and their profession, teacher attitudes which are so clearly reflected in the children whom they teach.

OUR HIGH SCHOOL

Once again we have an Agricultural Instructor. Mr. James G. Shaw, a graduate of Rhode Island State College, who for the past two years taught Agriculture at Bacon Academy, Colchester, Connecticut, joined our faculty last July. We have 19 boys enrolled in this Department. They spend one-half of their classroom time with Mr. Shaw studying Agriculture and the other half with Mr. Sisson at the shop, where they work at farm mechanics.

This year we have established a course in Driver Training. Mr. Clayton Sisson, our shop instructor, took the State approved Teacher-Training Course and is in charge of instruction. Boys and girls who are sixteen or over can take the course and we have sixteen in our first class. These youngsters receive classroom instruction in highway safety, care of the automobile, rules for driving and also receive behind the wheel training in preparation for taking their examination for a driving license. Mr. John H. Davis has made a Chevrolet Sedan with dual controls available for the driving instruction. The Town simply insures and maintains the car while we have the use of it. Mr. Rudolph King, Registrar of Motor Vehicles for Massachusetts, states that, where these courses have been well established, accidents for the 16-18 year old group have dropped 46% and that the driving record for this age group compares favorably with that of the 21-25 year group.

In other respects the curriculum is unchanged, but we are trying to differentiate more in our college preparatory and civic groups.

Last fall one of our boys from the class of 1949 entered Boston University, a second entered Brown University. Six other boys and girls out of a class of 28 continued their studies beyond the high school level and two of the girls entered schools for nursing training.

TEACHERS' SALARIES

While our salary schedule is still lower than those of neighboring towns, we have made definite gains in recent years and should not lose ground in 1950 if the present policy of the School Committee continues. Secondary school teachers are now available but if we find it necessary to take on new teachers in the lower elementary grades a difficult task confronts us. The present starting salary of \$2,200 does not put us in a good competitive position in 1950.

THE SCHOOL PLANT

During the year we have made repairs to the Greenwood Portable. The entire building has been strengthened and the roof newly shingled. A complete painting job is next. We would have preferred to scrap this building but our rapidly increasing school population makes it impossible.

The main building at Greenwood was redecorated inside and the south end was newly shingled.

At the Factory it is planned to complete the artificial lighting program in the south rooms early in the new year. This building should be redecorated before another school year opens.

At the North Westport building redecorating is also in order and modern toilets and urinals should be installed. This building must be used while the present surge in elementary school population is active or until a central elementary school for the north end of Westport has been constructed.

The Head School was reconditioned last year except for floor finish and chalk board refinishing. I propose that this work be done as soon as possible. The building is maintained in good condition and I commend Mr. Reynolds as a school custodian.

At the High School the floors have been refinished in all but one room and the Commercial Room has been redecorated in line with modern practice. The ceiling and walls of the auditorium have also been painted and the new pastel shades make it a much lighter and more attractive room.

At Booth's Corner, Brownell's Corner and the Point there is much that could be done and should be done if we are to continue the buildings in active service. It is our hope that the Town will vote the construction of a six year high school thereby eliminating the use of these buildings and the Greenwood Portable by the fall of 1951.

OUR MAJOR PROBLEM

We are now feeling the effects of the population increase of the war years and the home building boom in our town. Not only are our school buildings inadequate and antiquated but they will no longer accommodate the numbers of pupils who are at their doors.

New school house construction as well as improvements in so much of the present school plant as we must retain are no longer a dream but a must if we are to properly care for our increasing school population.

The following table clearly shows that we are already much overloaded in our elementary buildings:

Anticipated enrollments in the preceding table are based on birth records plus 40% to cover children from new families moving in. This is some 7% less than are the first grade figures for 1950 based on an actual count.

New homes in Westport averaged 8.5 per year from 1942 through 1945 and 54.25 from 1946 through 1949. 1950-1953 estimates for the first grades are based on children born since 1943. The birth rate averaged 76 annually from 1942 through 1945 and 93 annually from 1946 through 1949. For 1949 it will probably exceed 90.

105 home building permits have been granted in the past two years so the present birth rate will in all probability more than hold up and the 40% allowance for new families should not be extreme.

At the Annual Meeting in March you will present to the Town the proposition that a new six year high school building be constructed at the earliest possible moment. This building is designed to handle up to 400 pupils in grades 7-12 and may be expanded if the need ever exists.

This building will not only provide a real high school educational opportunity for *all* the children in Westport from grade 7 through 12, but will make additional room for at least 360 pupils in grades 1 through 6. Without using the Greenwood Portable and the Brownell's Corner and Booth's Corner buildings 745 pupils in grades 1-6 could be cared for under reasonable educational and health conditions.

Our only alternative is an inadequate high school plant, and in our elementary schools the double shift and the continued use of school buildings no longer to be found in most communities in Massachusetts. We would expend many thousands of dollars attempting to improvise, and in the improvement of our present buildings. We would have nothing worthwhile when we had finished.

To all who have helped us in the past and to all those who look forward to a real educational opportunity for our children that spells a better citizenship for future generations, we offer our thanks and appreciation.
