It was with regret that the Board accepted the resignation of John C. Partington, Inspector of Slaughtering, due to ill health. Mr. Manuel Amaral was appointed on August 1st to succeed Mr. Partington.

Mrs. Evelyn Reed and Mrs. Charlotte Wood have served as substitute nurses and also on occasions when extra service was required.

On November 20th a meeting was held concerning the possibilities of conducting a Chest X-ray Clinic in Westport, under the sponsorship of the Board of Health. Mr. Wesley C. Vokey, Executive Director of the Bristol County Health Association, presided and outlined the purposes and procedures. The greater portion of the expense for a project of this nature is financed by the proceeds from the sale of Christmas Seals. Community interest and support in such a project has been excellent. As of December 31st the program was well organized and the Clinic is scheduled for the period, February 19, 1951 to March 2, 1951. The Clinic is to be conducted for five days at the Town Hall and for a similar period of time at the Greenwood Park School.

Dr. Lepreau, Medical Advisor has been consulted by the Board and the Board of Health Nurse as necessary.

Regular Board meetings, with the exception of omissions for particular reasons, have been conducted throughout the year.

For a financial report on expenditures and receipts, please refer to the report of the Town Accountant.

The Board wishes to thank the towns people, various organizations and all Departments concerned, for their cooperation during the year.

Regular library hours have been as follows: Saturday afternoons 2-5 P.M. Monday nights 7-9 P.M.

During the year we have endeavored to purchase the best and most wanted books for our patrons.

All realize books make an expensive item, and if more funds were available we could have a larger and more comprehensive collection. However, we feel we have kept in line with the "best-seller" lists both in fiction and nonfiction, for adult and juvenile readers. We have tried to meet the varied tastes and preferences of our patrons. Some reference material has been added, along with books that do not become quickly out-moded.

In checking circulation, a slight drop is noted over that of 1949. This, we feel, is due in part to changes in use of the library by High School students, and to a general tendency to lowered circulation over a wide area. Television may be a factor in this showing.

It has been circulated to shut-ins to bring them cheer, entertainment and education. We would be pleased if more might request its use for this particular purpose.

It is also available to clubs, church groups, 4-H etc. for program fillers.

Many times the public is not fully aware of services offered by their library. If the above outline does not meet your special need, we can always suggest Bookmobile service, The Division of Public Libraries, Boston, play and film-lending service and others. It is through your requests that we can remain alert to your needs.

Do not hesitate to patronize your library's services. By so-doing you help your library grow.

Appreciation is given our efficient librarian and assistant librarian, and all others who have helped make this a successful 1950.

I submit herewith my report of an audit of the books and accounts of the town of Westport for the period from June 7, 1949 to July 24, 1950, made in accordance with the provisions of Chapter 44, General Laws. This is in the form of a report made to me by Mr. Herman B. Dine, Assistant Director of Accounts.

Sir:

In accordance with your instructions, I have made an audit of the books and accounts of the town of Westport for the period from June 7, 1949, the date of the previous examination, to July 24, 1950, and report thereon as follows:

The records of financial transactions of the several departments receiving or disbursing money for the town or committing bills for collection were examined, checked, and verified by comparison with the reports and the records of the town accountant.

The books and accounts in the office of the town accountant were examined, checked, and compared with the records of the several departments of the town and with the town treasurer's books. The receipts, as recorded, were compared with the town treasurer's record of receipts and checked with the departmental records of payments to the treasurer, while the recorded payments were checked with the treasurer's record of disbursements and with the treasury warrants.

The ledger accounts were analyzed, the appropriations, loans authorized, and transfers being checked with the town clerk's records of town meetings and with the records of the finance committee, the necessary correcting and adjusting entries were made, and a balance sheet, which is appended to this report, was prepared showing the financial condition of the town on July 24, 1950.

It is recommended that the finance committee designate some person to act as clerk of the committee, who shall enter all its votes and proceedings in books and have custody of such books.

The books and records of the treasurer were examined and checked in detail. The recorded receipts were analyzed and checked with the town accountant's books, with the departmental records of payments to the treasurer, and with the other sources from which money was paid into the town treasury, while the disbursements were checked with the treasury warrants.

The cash balance on July 24, 1950 was proved by actual count of the cash in the office and by reconciliation of the bank balances with statements furnished by the banks of deposit.

The payments on account of debt and interest were verified by comparison with the cancelled securities on file.

The savings bank books and securities representing the investment of the trust and investment funds in the custody of the town treasurer were listed, the income was proved, and the transfers to the town verified.

It is recommended that income accrued on cemetery perpetual care funds be withdrawn from savings banks before expenditures chargeable to income are approved.

The records of tax titles and tax possessions held by

the town were examined and checked. The amounts transferred to the tax title account were compared with the collector's books, the amounts received from the redemption of tax titles and the sale of tax possessions were checked to the treasurer's recorded receipts, the foreclosures were verified, and the tax titles and tax possessions on hand were listed, reconciled with the accountant' ledger, and compared with the records in the Registry of Deeds.

The public landing accounts in the custody of the town treasurer, as treasurer of the Town Landing Commission, were examined and checked in detail. The receipts from leases of the several properties were examined and compared with the treasurer's cash book, the cash book was footed, and the cash balance on July 24, 1950 was verified by examination of the savings bank book.

The books and accounts of the tax collectors were examined and checked in detail. The tax and excise accounts outstanding at the time of the previous examination and all subsequent commitments were audited and proved to the warrants issued for their collection. The recorded receipts were checked with the payments to the treasurer and with the town accountant's books, the abatements as recorded were compared with the assessors' records of abatements granted, and the outstanding accounts were listed and reconciled with the town accountant's ledger.

The commitments of departmental accounts receivable were examined and checked. The recorded receipts were checked with the payments to the treasurer and with the town accountant's books, and the oustanding accounts were listed and reconciled withe the respective ledger accounts.

Verification of the outstanding tax, excise, and departmental accounts was obtained by mailing notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

It is again recommended that action be taken at once

to secure prompt settlement of the delinquent tax and motor vehicle and trailer excise accounts of prior years, which on the audit date were as far back as 1942. There are sufficient remedies under the tax laws with which a tax collector may clear his warrants, and unless he performs his duties faithfully action should be taken on the tax collector's surety bonds.

The records of licenses and permits issued by the selectmen, the town clerk, the building inspector, and the health department were examined and checked, and the payments to the State and to the town were verified.

The surety bonds of the several town officials required by law to furnish them for the faithful performance of their duties were examined and found to be in proper form.

The records of the sealer of weights and measures, as well as of all other departments collecting money for the town or committing bills for collection, were examined and checked in detail.

Attention is called to the provisions of Section 34, Chapter 98, General Laws, which require that the sealer of weights and measures shall account for and pay into the town treasury monthly all fees received.

Appended to this report, in addition to the balance sheet, are tables showing a reconciliation of the treasurer's and the collector's cash, summaries of the tax, excise, tax title, and departmental accounts, together with tables showing the condition and transactions of the trust and investment funds.

While engaged in making the audit, cooperation was received from the officials of the town, for which, on behalf of my assistants and for myself, I wish to express appreciation.

EXTRACTS FROM ELEMENTARY SUPERVISOR'S REPORT

"At the Factory School, Miss Angela Perry was granted a leave of absence and was replaced by Miss Barbara Henry, a substitute teacher. In June Miss Perry, now Sister Mary Ancella, resigned to enter the Nazareth Novitiate at Leicester, Mass. In September Mr. Cornelius Sullivan of Worcester was appointed to fill this vacancy. Mr. Sullivan a graduate of State Teachers College at Worcester, received an M. A. in Ed. from Columbia University in December."

"At the North Westport School an enrollment of fifty-five pupils in grades one and two at school's opening in September necessitated the employment of an additional teacher here. Mrs. Marion Pettey, who had done considerable work in Westport Elementary Schools the past few years, was named teacher of grade 2. Mrs. Pettey graduated from Plymouth Teachers College, Plymouth, New Hampshire in 1941 with the degree of B. S. in Ed."

"Mrs. Ada S. Macomber, a former teacher in the Westport Schools, died October 26, 1950. Those of us who were fellow teachers with Mrs. Macomber knew of her fine qualities of scholarship and thoroughness which distinguished her teaching service." "Insufficient housing to accommodate increases in school population brought about the need not only for further changes in the distribution of pupils, but also a change in promotion policy.

In June all pupils were moved to the next grade either by promotion or assignment (where not promoted). This policy was adopted by the Westport School Committee on a trial basis for the school year 1950-1951 as an emergency measure."

"In 1950 two Parent Teacher Associations were organized in the Westport Elementary Schools, i. e. the Head — Brownell's Corner Schools and the North Westport School. They are local units of the Massachusetts Branch of the National Congress of Parents and Teachers. Both associations have adopted the following objectives:

- '1. To promote the welfare of children and youth in home, school, Church and Community.
- 2. To raise the standards of home life.
- 3. To secure adequate laws for the care and protection of children and youth.
- 4. To bring into closer relation the home and the school, that parents and teachers may cooperate intelligently in the training of the child.
- To develop between educators and the general public such united efforts as will secure for every child the highest advantages in physical, mental, social and spiritual education,'

The elementary school personnel involved in these two Parent Teacher Associations have become active members and will continue full support as long as continuous intelligent and inspiring leadership carries forth these objectives. For in this way, such organizations can be of tremendous service in helping to meet the educational needs of the children of Westport."

"Realizing the concern for the welfare of our pupils, it may be of considerable encouragement to some to note the opinions of two outstanding educators in Massachusetts who have visited our elementary schools from time to time over the past few years.

Concerning the elementary teachers of Westport and their work, Dr. Elizabeth V. Foster, Director of Teacher Training, State Teachers College at Worcester, says:

'The general attitude and behavior of the children are superior. Individual and group needs are being met. The children are not taught to measure up to a course of study, but rather to measure up to their own capacities.'

Miss Alice B. Beal, formerly Supervisor of Elementary Education in Massachusetts, in her report says:

'The professional attitude of the teachers and their interest in teaching and in children is above the average.'"

EXTRACTS FROM HIGH SCHOOL PRINCIPAL'S REPORT

"When school opened in September, our enrollment was 180. This included thirty-three 8th grade pupils who, because of lack of space at the Factory Junior High, were transferred to the high school. This increase in enrollment created an overcrowded condition in the high school. For example, our study hall contains seats for 45 pupils, but our study groups ran as high as 95. To provide seats for such large groups we were forced to use classrooms in which classes were being conducted.

This is not a satisfactory arrangement for either the teacher or the pupil. It means that the teacher must at least keep the study group under control and at the same time attempt to teach the subject matter to those taking the course. The average study pupil will spend much of the study period listening to the discussion and instruction of the subject being taught."

"In September, Mr. Downing joined our teaching staff as our social studies instructor. He was assigned to teach Guidance and Civics, World History, U. S. History, Problems of Democracy, and English 10B. Mr. Downing is proving fully capable of handling these subjects well. I am certain he will make an excellent teacher." (Mr. Downing is a graduate of the University of Massachusetts, 1950 with the Bachelor of Arts Degree).

"As part of the H. A. II course, Mrs. Mason is teaching Home Nursing two periods a week for approximately ten weeks. This should be of great value to the girls taking this course.

Miss Cahoon and I agree that elective courses in sewing and cooking should be made available for girls who do not take H. A. under the state supervision which requires double periods."

"I am certain most 9th grade boys would profit greatly by having some shop work, especially in the care and use of hand tools. This need should be given careful thought when considering the curriculum for the six year high school."

"Our Girls' Glee Club received honors at music festivals held at Durfee Tech. and Attleboro. The girls of Westport High furnished the vocal music at the Teachers' Convention held in New Bedford last fall. In November, the combined glee clubs put on an assembly program at Dighton High School."

"The teachers have spent some time on courses of study which should be helpful in the future. We realize that there are many phases of our work that could be improved upon, and we welcome criticisms from parents and interested people. I believe there should be more selective grouping of pupils, but this requires more teachers and space than we have at the present time.

It is of interest to note that nine members of last year's graduating class have continued their education in institutions of higher learning. This should indicate that Westport High School does offer some preparation for advanced study.

Our Student Council has been active and deserves credit for helping in solving many of the school problems. Council meetings have been held during the lunch period as this seems to be the only period in which all can get together when a room for the meeting is available.

The Driver Education course was discontinued because only 14 pupils were interested. The requirement is for at least 20. Most of our sixteen-year old pupils have their licenses to operate an automobile and these, of course, would not be interested. The course could be of great value, as insurance figures show that a high percentage of accidents are caused by teen-age drivers.

In closing, I would like to mention some of the things I believe we should strive for:

- 1. Shop work for more of the boys.
- 2. Physical education classes for both boys and girls.
- 3. Selective grouping of pupils to enable college preparatory and vocational students to cover subject matter according to their interests and abilities.
- 4. Effective use of visual aid material.
- 5. Expanded Household Arts course in which junior and senior girls could receive instruction in sewing and cooking.
- 6. Library.

There is need for an experienced librarian to catalog the present collection of books, set up the new library, and provide class instruction in the effective use of library materials."

THE SCHOOL PLANT

At the present High School site we have graded and seeded the two lots north of the school. This should pro-

vide a play area for grades 1—6 another year. It is undesirable to have children of this age group walking the highway to a play area and our savings in field rental will ultimately offset the cost of this work.

At the Factory building we have completed the installation of fluorescent lights, re-decorated the classrooms and corridor, and shingled the south side of the building. Further repairs are desirable and a play area adjacent to the school site will be much needed for the 1–6 grade group.

At the Greenwood Park School electric clocks were installed, the outside of the building was painted and the floors in the corridor and two classrooms were refinished. The floors in the other two rooms should be refinished and modern fluorescent lighting installed in each of the four classrooms.

At the North Westport School the interior of the building (classroom level) was re-decorated, the floor and steps of the front porch replaced, a deep well driven, and the roof repaired. A new toilet system is badly needed and the school play area should be fenced.

At the Head School all wood floors were refinished, tack boards were installed, and the foundation walls pointed.

At the High School we shingled the south side of the old section, put in a dry well to care for roof water at the northwest corner and cared for the regular maintenance. The front of this building should be shingled, trim painted, and some of the classrooms re-decorated.

Chalk boards in all our schools are now green. We find this color easier on the eyes.

Only absolutely essential repairs were made to the Portable, Booth's Corner, Brownell's Corner, and Point School buildings as we expect to discontinue their use with the opening of the new building. It is desirable to

retain the Point building until we are assured that we can accommodate all pupils on one shift but the other buildings should be disposed of as antiquated and definitely lacking in sanitary and healthy living conditions.

THE NEW HIGH SCHOOL

Last March the Town voted \$800,000 to construct a new high school. The need for such a building, both for educational reasons and housing needs, was forecasted in our annual report and at several open meetings. Our actual enrollment figures for this year support our forecast, and it is fortunate that we can reasonably expect to occupy the new building next fall.

Construction is not up to the schedule anticipated. Shortages of cement and steel last summer held the work back. Recently steel deliveries have improved and all roofs are now framed. Further deliveries are promised and I still feel that we have time to complete the building prior to Labor Day.

As in every other field, costs have been and are advancing. We find that there will not be sufficient funds to completely equip the building and finish the grading of the athletic field. The Building Committee has contracted for every piece of equipment for which funds are definitely available. While it is regrettable that an additional appropriation will be necessary, no apology is offered. The original estimates proved sound for the time when they were made and the changes in market conditions and prices have been beyond our control. The State is now going to pay for about 34% of all the equipment. This was not the case when the building was started. In view of our problem, we can be doubly grateful for this unexpected aid.

Mr. Harold Wood was made Acting Principal of the Westport High School, effective September 1, 1950.

His ability to understand and handle youth of high school age is being well demonstrated. His willingness to attack the problems presented in caring for the present enrollment and the development of a suitable program for the new six year high school warrant my recommendation that he be named the Principal of our New High School.

Miss Audrey L. Tripp has continued to serve Westport well as Elementary Supervisor. Miss Alice B. Beal, then Supervisor of Elementary Education for the State of Massachusetts, states in her survey report, October, 1950, "Too great credit cannot be given to Miss Audrey Tripp for the high standards in these grades." (Grades 1–8). Other outside educators who have occasion to work with Miss Tripp or observe the work in the elementary grades of Westport have the same high opinions of her ability. We are fortunate to have Miss Tripp as her opportunities for advancement in other school systems are not few.

Since January 1, 1950 I have been well occupied with the business affairs of the School Department including the building and equipping of the new High School.

I appreciate the cooperation of not only Miss Tripp and Mr. Wood but of all the School Department employees, bus drivers, other department heads and employees, the Parent-Teacher organizations and those citizens who have worked for better buildings and school opportunities for the children of Westport.

The School Committee members, also functioning as a Building Committee, have cheerfully accepted the many additional hours of free service that their dual position has demanded. I cannot praise them too highly and can only hope that Westport may always be served as well.
