

1951 has seen an increase of 1,481 in a circulation over that of 1950. We are gratified we still have a reading and listening public.

I would like to give in part the Librarian's report to the Trustees.

"The circulation of juvenile, adult and non-fiction books shows a substantial increase over last year. Much of the increase was due to increased use of the library facilities by High School students. Moving the High School to it's present location will undoubtedly cut the circulation this year."

We hope this might not take place. With the advent of the elementary group in the former High School circulation should continue accordingly. Miss Audrey Tripp, Principal, plans to have these new students make use of the library either through supervised visits or through a sub-branch arrangement.

Miss Tripp also tells me our record collection and Viewmaster films will be welcomed by the children during inclement weather.

Perhaps some of you have wondered just how we go about purchasing your books.

For the most part, books are purchased in Fall River where we make personal selection. We do buy a few from publishing houses, but have found personal selection quite satisfactory.

When delivering books to our librarian, if it is found we have duplicates, they are exchanged. If, upon closer examination, others are undesirable, we are privileged to return these.

The librarian indicates Westport seems to hunger for mystery stories. We try to supply many of this type, yet often question if some would enjoy selections along the line of arts and crafts?

There are many beautiful books for those interested in handicrafts, decoration, collecting, sewing, cooking, painting, and music. Usually, these are more expensive. Accordingly, if we feel a book will not circulate enough to warrant purchase, we refrain from adding it to your shelves.

We consider handling your library dollar a responsibility.

One often wonders if some of these reports to the townspeople prove interesting enough to be read. To

satisfy my curiosity, I'll invite you to call me (15-4) if you have suggestions or requests. I, in turn, will carry your requests to the other members.

Sometime in 1952 we expect to have a set of authentic bird-call recordings. When available inquire about them from the librarian.

We are appreciative of our librarian and assistant librarian's efforts, and express gratitude to any others who have helped our library in 1951.

Make use of our services, visit us. Keep our library alert and ever-growing.

I submit herewith my report of an audit of the books and accounts of the town of Westport for the period from July 25, 1950 to June 8, 1951, made in accordance with the provisions of Chapter 44, General Laws. This is the form of a report made to me by Mr. Herman B. Dine, Assistant Director of Accounts.

Sir:

As directed by you, I have made an audit of the books and accounts of the town of Westport for the period from July 25, 1950, the date of the previous examination, to June 8, 1951, the following report being submitted thereon:

The financial transactions, as recorded on the books of the several departments receiving or disbursing money for the town or committing bills for collection, were examined and checked with the books of the town accountant and the town treasurer.

The books and accounts of the town accountant were examined. The receipts, as recorded, were checked with the treasurer's books and with the records of the several

departments collecting money for the town, while the payments were checked with the treasury warrants and with the books of the treasurer.

The appropriations as listed from the town clerk's records of town meetings were checked to the town accountant's ledgers. The ledger accounts were analyzed, the necessary adjusting entries were made, and a balance sheet, which is appended to this report was prepared showing the financial condition of the town on June 8, 1951.

As may be seen from the appended balance sheet, there are overue tax accounts dating back to 1942 and overdue motor vehicle and trailer excise accounts dating back to 1943. The reports of previous audits have called attention to these uncollected accounts, and it is urged that action be taken by the selectmen to protect the interests of the town.

The books and accounts of the town treasurer were examined and checked in detail. The cash book was footed throughout, the recorded receipts were analyzed and compared with the departmental records of payments to the treasurer and with the other sources from which money was paid into the town treasury, while the disbursements were compared with the town accountant's books and with the treasury warrants. The cash balance on June 8, 1951 was proved by reconciliation of the bank balances with statements furnished by the banks of deposit and by actual count of the cash in the office.

The recorded payments on account of maturing debt and interest were verified by comparison with the amounts falling due and checked with the cancelled securities on file.

The saving bank books and securities representing the investments of the trust and investment funds in the custody of the town treasurer were examined and listed, the

income being proved and the transfers to the town being checked with the treasurer's recorded receipts.

The records of tax titles held by the town were examined and reconciled with the tax collector's books and with the accountant's ledger, while the redemptions were checked with the treasurer's cash book. The tax possessions were examined and listed, the additions as a result of tax title foreclosures being proved and the sales being compared with the treasurer's recorded receipts. The tax title and tax possession transactions were further verified by comparison with the records in the Registry of Deeds.

The books and records relative to the public landing in custody of the town treasurer, as treasurer of the Town Landing Commission, were examined and checked in detail. The charges representing the leases of the several properties were examined and the payments to the treasurer were checked. The cash book was footed, and the cash balance on June 8, 1951 was verified by examination of the savings bank book.

The books and accounts of the tax collector were examined and checked in detail. The tax and motor vehicle and trailer excise accounts outstanding at the time of the previous examination and all subsequent commitment lists were proved to the warrants issued for their collection. The recorded receipts were checked with the payments to the treasurer and with the accountant's books, the abatements as recorded were compared withe the assessor's record of abatements granted, and the outstanding accounts were listed and reconciled with the respective ledger accounts.

The records of departmental accounts receivable were examined and checked. The commitments were added, the payments to the treasurer were compared with the treasurer's cash book, and the outstanding accounts were listed and proved.

The outstanding tax, excise, and departmental accounts were verified by mailing notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

The town clerk's records of dog, sporting, and town licenses, together with town permits, were examined, the payments to the State being verified by comparison with the receipts on file and the payments to the town treasurer being compared with the treasurer's cash book.

The surety bonds furnished by the town officials bonded for the faithful performance of their duties were examined and found to be in proper form.

The records of licenses and permits issued by the selectmen and by the police and health departments were examined and checked, the recorded collections being compared with the payments to the treasurer.

The records of the sealer of weights and measures, as well as of all other departments collecting money for the town or committing bills for collection, were examined and checked in detail.

To the School Committee of the Town of Westport Gentlemen:

In accordance with custom I submit my twenty-fourth annual report, the sixty-third in the series of annual reports of the school superintendents of this town.

During the entire year of 1951 I have devoted a large portion of my time to the building and equipping of our new high school. Any time left over has gone into the business management of the system and checking and advising with Miss Audrey Tripp, Mr. Harold Wood and Miss Ruth Collins. I am indebted to their cooperation and achievement for any progress that has been made toward our goal of bigger and better opportunities for Westport's children.

During the year four elementary class room teachers and our vocal music supervisor left. It was necessary to find replacements for these teachers and add five new ones to take care of our increased enrollment and our broader Secondary Program.

I now quote from the reports of Miss Audrey Tripp, Elementary Supervisor, and Mr. Harold Wood, High School Principal.

Miss Tripp states:

"The Curriculum Guide for Grades 4-6 has been made available, so that now there is a continuous planned program of instruction in grades 1-6. The reorganization of our school system, as well as the complete adoption of the Guide, will call for some complete changes and many adjustments in so far as allotments of subject matter are concerned.

Audio-visual aids library additions include an opaque projector and a 16 mm sound projector. The North Westport P.T.A. purchased a filmstrip projector and presented it to the North Westport School. This is an excellent aid and a filmstrip projector for use in each school should be an objective of our audio-visual aids program.

With the further improvement of our school program in mind, I now repeat recommendations that have been made in previous reports, but which we have been unable to realize primarily because of budget limitations, i.e. that we secure as soon as possible an art supervisor and a physical education supervisor for our elementary schools.

This is my final report as Elementary Supervisor in Westport. I know that I have never been a "Supervisor" as the term is defined educationally, although I have tried to keep to the basic function of the supervisor—"the improvement of the learning situation for children". My role has been similar to that of the utility player on a baseball team. While realizing only occasional usefulness, there have been with me, as there are with the utility player on the team, those moments when some satisfaction of achievement has been experienced.

For instance, I do "point with pride" to our accomplishments in the field of school health. I feel that Westport children in most instances are living in class rooms where good mental health is in evidence among both pupils and teachers. Our school nurse, Mrs. Mason, has worked diligently and intelligently and, largely through her efforts, Westport has a very fine school health program. We are fortunate, too, in having an outstanding pediatrician, Dr. Wilson E. Hughes, serving as School Physician.

Health is still the first objective in the aims of public school education and I am pleased that so much has been accomplished to this end these past few years.

At this time I acknowledge my indebtedness to the following persons for the help they have given me:

The members of the Westport School Committee for their confidence and support.

All Westport teachers who have shared their experiences so willingly and worked together so harmoniously in the interests of better schools for their pupils. At no time in history has the importance of a good teacher been realized more than now. How fortunate are we in Westport to have so many good teachers!

Mr. Milton E. Earle, Superintendent of Schools, for his practical advice and constant encouragement."

Mr. Wood writes of the High School:

"Our agricultural enrollment, which remained almost the same as last year, has very few boys who come from established farms. Many of the group seem more interested in shop work, but would like some part time farming. With this in mind, we hired Mr. Shaw on a half time agricultural basis to handle the project phase, and Mr. Sisson on a half time basis to teach the shop work. The boys have two weeks with Mr. Sisson and two weeks with Mr. Shaw. This gives all agricultural boys 50 per cent project work and 50 per cent shop work. As farming is becoming more and more mechanized, the care and operation of farm machinery is an important factor in the success of the enterprise. This added shop work should better prepare the boys of the department for the vocation of their choice.

To offer a better college preparation, solid geometry and trigonometry were added to our curriculum. Our Industrial Arts courses and our mechanical drawing have proved popular with the non-college groups. I would like to include mechanical drawing for all boys regardless of their selected courses, as several of our graduates who have gone on to school have found that this course would have been of benefit to them. The value of shop work, sewing and cooking for our seventh and eighth grade people is self-evident.

New equipment for our science classes has been purchased, and at the present time I believe we have as modern a laboratory as there is in this area."

"We have added to our film strip library and have encourage more and more use of these valuable tools."

"Twelve members of the graduating class of 1951 continued their education. Several are doing outstanding work. To give some worthy senior financial aid, the Woman's Club of Central Village gave, last year, a hundred dollar scholarship. The award went to Edward Sharples. It is gratifying to know that there are people in the town who are interested in the affairs of the high school. A short time ago representatives of the Woman's Club discussed the possibility of their buying some fiction for our new library. On behalf of the faculty and students of Westport High School, I wish to thank the Woman's Club for their generosity and good will.

As I look back over the past year, I do find that some progress has been made.

- 1. We have been able to offer more boys shop work.
- 2. We have expanded our physical education program so that most boys and girls are getting some gym.
- 3. The Household Arts course includes more girls in grades eleven and twelve.

- 4. We have made more effective use of Visual-Aid Material.
- There has been progress in the organizing of the library.

While some things have been accomplished, there is still much to do; but we have better facilities now than at any time in the past, so that if we do not accomplish more, the fault will lie largely with us.

In closing, may I thank the School Committee and the Faculty for their cooperation. To you, Mr. Earle, I wish to express my sincerest gratitude. Any success that I may have achieved could not have been possible without your helpful advice and careful guidance."

Miss Tripp is, in my opinion, a successful Supervisor. I believe her own doubts are without foundation. She has not only worked faithfully and successfully for "the improvement of the learning situation for children" but has been in every respect, except the title, an efficient and friendly Assistant Superintendent of Schools.

Mr. Wood has supported my faith in him as the man for Principal of our High School. Growing enrollment and preparation for our six-year program has made his task anything but an easy one. A larger school requires more "red tape" than a small one. I have so advised him, and I, not Mr. Wood, will take the responsibility for any irritating restrictions that our present high school pupils have to bear.

Under our new set-up Miss Audrey Tripp will serve as Principal of the Village School and Supervisor of Audio-Visual Education for the entire school system. If the new building project can be cleaned up before next September first, I believe your next Superintendent of Schools can supervise the other elementary schools and handle the business and other educational details of his office.

We anticipated not more than thirty pupils per teacher in grades one through six would follow the opening of our new building. Population growth has been so rapid during the past two years that we actually find eight of twenty rooms carrying more than thirty pupils and three rooms definitely overloaded.

In the School Report for 1949, on page 11, we anticipated a 1950 enrollment of 905 pupils. On October 1, 1950 we actually had 907 pupils. In the same report we anticipated a 1951 enrollment of 935 pupils (85 new first graders). On October 1, 1951 we actually had 974 pupils. There were only 82 first graders, so 42 additional pupils either moved into Westport during the last half of the year or transferred from private schools. Using the same system, our expectation for 1952 was 1,004 pupils. Of these, 127 would be new first graders. Our latest census, just tabulated, indicates a new first grade of 122 pupils and shows 59 pupils in private school attendance. Next fall we must be prepared to admit at least 140 additional pupils in Grades 1-6.

At the High School we will probably graduate 17 and must be prepared to admit a seventh grade of at least 80. This means a probable High School enrollment of 400 plus, next fall.

It can readily be seen that if Westport just maintains the present potential school population, housing problems still confront us. The Point School can be re-opened, but the real shortage of pupil stations is in the north half of our town. Already we are taking pupils from Precinct A and transporting them to Central Village. Until additional class rooms are provided in Precinct A, it will be necessary to transport more and more pupils south to the Village School. The only alternative is a double-shift for schools in Precinct A.

The heating plant and toilets at the Head were planned to care for at least one additional room. Such an addition might help the situation. Extensive repairs at Booth's and Brownell's Corner buildings, including new heating and toilet systems, would care for 100 additional pupils. These buildings are not where they are really needed and the cost of making them serviceable, in my opinion, far exceeds their potential value as school houses.

What is really needed is one central school for Precinct A. I believe a site should be selected and purchased at the earliest moment possible. Plans might well be drawn

that would permit of construction in units so that the cost of such a building could be spread over a longer period than 20 years if same seems necessary.

In any event, a real housing problem still exists and immediate steps should be taken to make a comprehensive and professional study.

Dr. Herbert Blair's School Housing Survey, the first step in our building program, which was published in 1947, stated, "It is not a question of whether it is most important that Westport should build first an elementary school or first a high school. It is essential that Westport should provide both."

He felt a new elementary building was needed because our present buildings in the north precinct were ill suited for providing the education our times call for. He anticipated some growth in school population but nothing like what has happened. Today a building is needed just to put a roof over the heads of our school children.

This is my last annual report as your Superintendent of Schools. As is true in all walks of life, I have had my troublesome as well as pleasant moments, but I do most sincerely appreciate the kindly and considerate treatment that I have received from Westport's citizens these many years. I cannot find the words to express my thanks to those who have served with me. I shall be always grateful to those School Committee members who have unselfishly served the Town of Westport and have challenged, advised, and supported me in my efforts to serve the Youth of Westport. May God bless you all.
