

#### **Board of Health**

The Board of Health respectfully submits the following report for the year ending December 31, 1953:

At the organization meeting held in March, Charles R. Wood was elected Chairman and Milton E. Earle Secretary. Mr. Wood was appointed the Supervisor of slaughter, garbage collection and to issue licenses pertaining thereto. Mr. Norman C. Gifford was appointed to issue milk, alcohol and camp licenses and to serve jointly with Mr. Wood on the supervision of dumping and the processing of complaints. Mr. Earle was appointed to receive reports on Communicable Diseases, the proper reporting thereof and to conduct other procedures relating thereto.

Mr. Charles R. Wood resigned effective May 1, 1953. On May 9, 1953, the Selectmen and the remaining members of the Board of Health voted unanimously to elect Mr. Harry Morrison to fill the vacancy caused by Mr. Wood's resignation. On May 11, 1953, the Board organized with Mr. Morrison as Chairman.

The Board divided the Town into three districts and each member was responsible for issuing sewage permits in his district. On the 18th of May, 1953, Mr. John Barboza, Building Inspector, as such, was appointed agent of this Board to issue sewage disposal permits on all disposals associated with the issuance of building permits. One hundred sewage disposal permits have been issued during the year and twenty-five changes were made in sewage disposal to keep same from entering our streams.

Mr. Morrison and Mr. Earle, as members of the Board of Health, have served as members of the Soil Conservation Board.

During the summer, concessions at Horseneck Beach were inspected and with the cooperation of operators, sanitary conditions were improved. We are looking forward to further improvement in the coming year.

Mrs. Grace DeAndrade was appointed Board of Health Nurse and several Substitute Nurses have served during the year (as available at time needed). Dr. Frank J. Lepreau, Jr., was appointed Medical Advisor and has been consulted by the Board and the Nurse as necessary. Mrs. Jessica E. Pearce was appointed to serve as Clerk to the Board as needed.

Manuel Amaral and Manuel Raposa, Jr., were appointed Inspectors of Slaughtering. Elmer B. Manchester, Jr., was appointed Agent to issue Burial Permits. Kenneth A. Potter and Jonathan H. Potter were licensed as Funeral Directors.

41 Burial permits, 42 milk licenses, 15 alcohol licenses, 4 camp licenses, 6 licenses for transportation of garbage, 7 oleo permits, 1 permit to manufacture or bottle non-alcoholic beverages were issued during the year.

The following Diseases classified as Dangerous to the Public Health were reported:

An eye-catching caption from the October 3, 1953 Fall River Herald-News stated "Librarians Hear Readers Losing Interest in TV". The article was in reference to the conference of 1000 librarians of the New England Library Association.

Its president, Miss Louisa B. Day of Lynn suggested book readers had been lured away for a time by television, "Now they are coming back eager for books again".

This statement seems to have proven itself in our own librarian's report, for circulation has increased by 1200, with an all-over increase of juvenile, adult fiction, non-fiction, magazines and records. The largest increase was in adult fiction—more than 900. However, it is interesting to note here increased requests for non-fiction and travel books.

This indicates in my opinion, television helps rather than hinders, as interest is now divided. Each has its important place and is dependent upon the other. Each is the nucleus around which education for the masses continues to grow.

Our librarian reports summer visitors as an important factor in this increased circulation, as was the new Wednesday afternoon session. The summer visitor is credited with probably 60% of the circulation

We are happy to realize this appreciation of the library's services by our visitors, and invite permanent residents to look in upon the library more frequently.

During the year, the library was the recipient of a gift, part of which was used to purchase a subscription to the fine historical magazine "American Heritage".

We are to present the possibility of our Trustees joining the Massachusetts Library Trustees Association during the coming year, at our next meeting.

We are appreciative of the Librarian's and Assistant Librarian's services, and thank all who have made this an inspiring year.

Our rapidly increasing school population made it necessary to reopen the Westport Point School, which had been closed since the opening of the new high school one and one-half years earlier. To staff the school Mrs. Ruth Pilkington was transferred from the Head School and Miss Ethelyn Tripp was newly employed. Miss Tripp teaches grades one and two, and Mrs. Pilkington teaches grades three and four.

This school serves children in the first four grades who live on the lower Drift Road, lower Main Road, Cornell Road and the Harbor area.

Children from these locations had been attending the Milton E. Earle School, and the space they occupied is now filled by children from Gifford Road, East Briggs Road and Sanford Road.

Another population development that wrought a change was a large number of first-grade pupils in the Greenwood Park area and along the State Road. As a result of this the Greenwood Park School now houses lower elementary children only. Since the transporting of many children away from that area is necessitated by shortage of space, it seemed proper to plan an arrangement under which older children would ride the greater distances in most cases. This arrangement finds upper elementary grades located at the Factory and Head Schools.

To accommodate these changes Miss Elizabeth Gifford was transferred from Greenwood Park to the Head and Mrs. Mary Hurley moved from the Head to Greenwood Park. Mrs. Dorothy Wescott, who had done substitute work for several years in Westport, was elected to fill the vacancy created by Mrs. Pilkington's transfer from the Head to the Point.

At the present time eighteen of our twenty-nine elementary (grades 1-8) classrooms are crowded (over 30) with an average of 15-20 percent overload; eight others have a proper load (average 27.5); and the remaining three, due to uneven grade-enrollments, could accommodate several (6-8) more pupils each.

Future enrollments seem likely to worsen this situation seriously, making imperative the provision of additional classroom space. The town has secured land for this purpose and appropriated money for planning a school building. It is hoped that the plans will be approved and money raised for construction, at the annual town meeting in March, 1954.

In long-range planning, I believe it would be desirable to provide a separate school for junior high school grades, if money were not a consideration. Since cost is important, and since it seems likely to be many years before enrollments in grades 9-12 will justify assigning the present high school for use of those grades only, an alternate arrangement is needed.

# Two possibilities appear:

- 1. Housing part of our seventh and eighth-graders at a new building on the Gifford Road and the remainder at the High School (as at present) as a permanent arrangement.
- 2. Building a smaller building on the Gifford Road which would house some seventh and eighth-graders temporarily, and planning an addition to the High School, where, eventually, all seventh and eighth-graders would attend.

I believe the educational and administrative problems inherent in the second plan to be less formidable. Preliminary study indicates that the special facilities at the High School, excepting shop and art space, are adequate for as many as six hundred pupils; which number will not be reached this decade by grades 7-12 at the present rate of growth.

The shop and art facilities mentioned above are inadequate for the respective programs carried on at present enrollment. When the building was designed our present art and agriculture programs were not anticipated.

If adequate facilities are to be had for current curriculum and for the increased enrollment under plan 2 above, a shop addition which also will make the present agricultural room available for art classes should be considered. Concerning Westport High School Harold Wood, Principal, reports as follows:

"Several new teachers were employed as of September, 1953.

Mr. Ulysses R. Souza replaced Mr. Paul Couture. Mr. Souza is a graduate of Bridgewater State Teachers College. He is teaching seventh and eighth grade social studies.

Mr. Francisco R. Souza, a graduate of Bridgewater State Teachers College, was assigned to teach science and mathematics.

Mr. Joseph Papandrea, a graduate of Bryant College, teaches commercial subjects and French.

Mr. Gary Hall, a graduate of Utica College, was assigned to teach English and Physical Education.

Mr. Alfred Martel, a graduate of Stonehill College, was assigned to teach science and mathematics.

Miss Helen Noonan, a graduate of Bouve' College, replaced Miss Virginia Smith as physical education supervisor.

Miss Helen Tripp was assigned librarian, replacing Mrs. Stone. Miss Tripp also teaches two English classes and a French class.

Mr. Thomas Slowe replaced Mr. Edmund Medeiros. Mr. Slowe teaches industrial arts and mechanical drawing.

Mr. Francis Martineau was granted a leave of absence to continue his studies.

Miss Paoli was appointed vice-principal. I consider Miss Paoli one of our best teachers. She is exceptionally well-gifted in the understanding of children, and has been a tremendous help particularly in our seventh and eighth grade program."

A guidance department has been organized by Mr. Norman L. Gifford, who reports of it:

"Its aim is to help the pupil discover and prepare for the kind of work best suited to him in order to make him happier and also more useful to himself and society. In line with this purpose we are trying to assist each pupil to acquire such information and, if possible, such experience as will enable him, with the help of his family, to choose a suitable life-work and to make a practical approach to it. By practical approach is meant the selection of appropriate studies and their successful completion, along with whatever part-time work experience seems feasible."

Mr. Wood reports further:

"Mr. Brightman became full-time Guidance Supervisor upon retirement of Mr. Gifford. Mr. Gifford's work in the field of guidance has been outstanding, and under his supervision I believe that we have established the foundation necessary for a good guidance program. Much has been accomplished in this field, but we still have a long way to go before we can compare favorably with other schools in the area. I have confidence that Mr. Brightman will develop into an excellent supervisor.

Two new courses were added to this year's program of study — French III and Office Practice. We feel that French III is necessary, as certain colleges require three years of one foreign language and two years of another. An office practice course better prepares our commercial students who enter this field.

A driver-training course should be included in our curriculum. Several years ago such a course was offered, but due to a misunderstanding of state requirements pertaining to enrollment, this course was discontinued.

Our agricultural course is expanding both in our in-school and out-of-school groups. Mr. McGarr took on twelve more adult farmers, which brings the enrollment of the out-of-school group to twenty-four.

Our shop facilities are inadequate for our present agricultural and industrial arts program. I have talked this matter over with the Committee, and I am sure that they understand the feelings of both Mr. McGarr and myself regarding the need of a new shop. Mr. McGarr is doing an outstanding piece of work, and we should encourage him to stay with us.

Our extra-curricular activities are somewhat restricted because of the transportation program. Late busses are probably the answer to more group activity.

At the present time we have an art club, an orchestra and vocal music groups. Our orchestra has made wonderful progress under the direction of Mr. Braga, and our vocal music groups have performed well under the supervision of Mrs. Hemingway.

I believe foreign language clubs, photography clubs and science clubs should be given more attention. It does not seem possible to schedule these during the regular school day, and without late busses the transportation home after the regular closing time makes it impossible to organize such clubs."

Audrey L. Tripp, Principal at the Milton E. Earle School, has mentioned the following matters in her report:

"The teaching staff at the Milton E. Earle School has remained intact except for one temporary change in

which Mrs. Elizabeth Moran replaced Mrs. Ann Smith who was granted a leave of absence from January through June. The stability of our group is quite remarkable, I believe, in these days of almost continual teacher turnover.

The excellent attitudes of all of our teachers and our janitor are still in evidence and, I believe, we are indeed fortunate to have our pupils come under the influence of such fine people.

Mrs. Lydia Mason has not let up in her vigorous pursuit of the health problems of our school. She has been of inestimable help to pupil, parent and teacher in a number of cases where specialized training was necessary for the child.

There are two emergency needs which we feel require immediate attention because they directly concern the health and safety of our pupils. We refer, of course, to the heating problem which still persists here, and the unhealthful toilet facilities.

The extension of fluorescent lighting throughout the building, inside painting, installation of bubblers in each classroom, and improved playground facilities are improvements which we anticipate as soon as funds will allow."

Miss Tripp's comment concerning repairs and upkeep could be echoed in behalf of all elementary schools. At North Westport and Westport Point also the toilet facilities need modernization; extensive shingling is needed at the Head and Westport Point; new floors are needed at Westport Point and at the Factory, if that latter school is to remain in commission. Among our schools, however, the Factory seems to be the first that should be closed.

The benefits to be derived from kindergarten and from a program of adult education classes are of sufficient value that this community may wish to sponsor them sometime in the future. That there is much of good in our schools is evident, I believe, from the general mental attitude of our children, the significance of which is seen not only as a means to greater scholastic attainment, but also as a worthwhile end in itself.

For the cooperation and forbearance of many, both within and outside the School Department, I am grateful.

#### PROMOTION OF HEALTH

The following is our sixth annual report. In other years, the material submitted was mostly statistical, but this year, it would seem in view of the changes made by the Massachusetts Department of Public Health, that a narrative report will serve better.

In compliance with the revised Massachusetts School Health Laws, all pupils in Grades 1, 4, 7, and 10 have had a health appraisal by the School Physician or by the child's family doctor. In the High School 253 children and in the Elementary grades, 392 children were examined. Children in other grades were examined according to the needs of the individual child. Hearing and Vision tests were given to each child and the results of these procedures were reported to the parents. Complete records of these examinations and other pertinent data were kept for each pupil in Grades one through twelve.

The School Entrance Conference was held the first Wednesday of May at the Greenwood Park School and the Town Office Building, for children who entered school the following September. Fifty-four children were examined by the School Physician. Forty-eight were vaccinated. Twenty-five children were given Booster Doses to reenforce their immunization to Diphtheria, Whooping Cough and Tetanus. The Town Nurse and members of the P-T. A.'s assisted with the detailed work of registering, weighing and measuring, vaccinating and immunizing.

Children have been accompanied, when necessary, to clinics for eye examinations, x-rays, mental or other social service work that was needed.

Conferences were held with teachers and parents in order that the children's problems be better understood or solved. Some of these problems required study by specialists and for this work the School Department made use of the services of the Fall River Mental Health Clinic.

The teachers continued to be most cooperative in the exclusion of children who exhibited symptons of Communicable Diseases, or the reporting of conditions which required further work by the School Nurse.

The Board of Health operated the Dental Clinic to help with our greatest single defect. Many children were prevented from losing valuable teeth. The Board has been alert to our need of knowing about cases of reportable Communicable Disease.

The P-T. A. Organizations were most generous in maintaining our Health Service Fund. This fund was used for any health need that could not be cared for in any other way.

In the past six years, the number of pupils under our care has increased fifty per cent. Three small schools have been closed, but the High School and the Point School have been opened. These changes accommodate the increased enrollment. They also increased the work and travel of the School Physician and the School Nurse. Despite these changes, the School Health Program has maintained or improved its standards wherever changes were advisable.

We wish to thank the School Committee, the Superintendent, the Board of Health, the Town Nurse, the Board of Public Welfare, the Agent and Social Worker, the P-T. A.'s, Teachers, Parents and all who helped to promote the Health work in the Schools of Westport.
