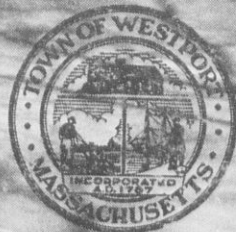

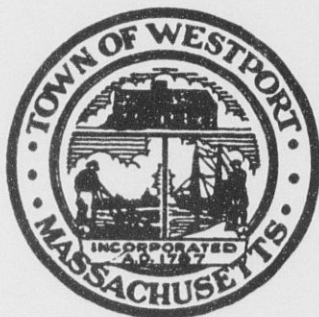

A TRIBUTE

DR. BERNARD WEISER

Dr. Weiser is an outstanding example of a devoted man dedicated to public service to the Town and professional service to our children. His service to our community takes on more significance when you realize that he resides in another town.

He was appointed as the School Dentist by the Westport Board of Health in 1946 and continued to serve and perform dental services for the following twenty-six years until his retirement in May of 1973.

He was a native of New Jersey and attended Marquette University (Dental school) in Wisconsin and practiced Dentistry in New York City until entering the Armed Forces in World War II. After serving in the Dental Corps in the Pacific Area under General MacArthur, he settled in Swansea, Massachusetts.

Dr. Weiser gave many hours of his time conducting Dental Surveys and clinics and performing dental services for our children at a very minimal compensation. In addition, Dr. Weiser obtained and provided supplies for the Dental Clinics at little or no cost to the Town.

Dr. Weiser has not only served our children, but is a modest man devoted to helping others as can be exemplified by the fact that he has served as District Governor for this Area's Lions Clubs and has served with the Salvation Army for twenty years, three of which he was Chairman of the Board.

On behalf of the citizens of Westport we offer this tribute to Dr. Weiser for the service he has rendered to the community and wish him good health and happiness in his retirement.

March 20, 1973

Agreeable to the warrant calling said meeting, the voters of the Town of Westport assembled at the Middle School Auditorium on the above date. The meeting was called to order by Stafford Sheehan, Moderator, who appointed six registered voters who were duly sworn before the Town Clerk. Althea M. Manchester, Assistant Town Clerk, acted as timekeeper for the meeting in accordance with a by-law adopted under Article 45 of the Annual Town Meeting warrant of 1963.

or damages incurred by him in the defense or settlement of a claim against
him in an amount not to exceed one hundred thousand dollars which claim
arose out of acts preformed by such officer while acting within the scope
of his official duties or employment, provided that the defense or settle-
ment of such claim shall have been made by the city solicitor or town
counsel, or by an attorney legally employed for the purpose by a city or
town, or by an attorney furnished by an insurer obligated under the terms
of a policy insurance to defend the city or town against such claim, retro-
active to January 1, 1973, was carried. Yes 195 No 112.

Article 2. Voted: (Unanimously) to accept the layout of Morency Avenue from Plymouth Blvd., continuing easterly for 500 feet, as made by the Selectmen and on file in the office of the Town Clerk, to raise and appropriate \$850.00 therefor and also that the land be donated, at no cost to the Town.

Article 3. Voted: (Unanimously) to accept the layout of Old Bedford Road, as made by the Selectmen, and on file in the office of the Town Clerk, provided it be donated to the town.

Voted: to adjourn the Special Meeting at 9:23 P. M., at which time the Annual Town Meeting was again called to order.

The Annual Town Meeting was adjourned at 10:45 P. M. until Tuesday, April 3, 1973 at 7:30 P. M.

The adjourned Annual Town Meeting was called to order at 7:30 P. M. by Moderator Stafford Sheehan.

Article 4. Voted: (Unanimously) to authorize the Treasurer, with the approval of the Selectmen to borrow in anticipation of the revenue for the eighteen month period beginning January 1, 1973 in accordance with General Laws, Chapter 44, Section 4, and acts in amendment thereof, and including

in addition thereto, Chapter 849 of the Acts of 1969, as amended, and to renew any note or notes as may be given for a period of less than one year in accordance with General Laws, Chapter 44, Section 17.

Article 5. Voted: (Unanimously) that the sum of \$4,000.00 be raised and appropriated to meet the town's share of the cost of Chapter 90 Highway Maintenance, and that the additional sum of \$8,000.00 be transferred from unappropriated available funds in the treasury to meet the State's and County's share of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt to unappropriated available funds in the treasury.

Article 6. Voted: (Unanimously) that the sum of \$12,000.00 be appropriated to meet the Town's share of the cost of Chapter 90 Highway Construction on Adamsville Road, Old County Road and/or Old Bedford Road, in the town and to be used where determined by the Board of Selectmen and to meet said appropriation the sum of \$12,000.00 be taken from the Revenue of the current year, and that in addition, the sum of \$36,000.00 be transferred from Free Cash in the treasury to meet the State's and County's share of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the treasury.

Article 7. Voted: (Unanimously) to authorize the Board of Selectmen to enter into a contract with the Department of Public Works and the County Commissioners for the construction and maintenance of public highways for the ensuing year.

Article 8. Voted: (Unanimously) to pass over Article 8.

Article 9. A motion to appropriate the sum of \$2,202.98 for its share of the Southeastern Regional Planning and Economic Development District operations for the fiscal 1973 (which encompasses calendar 1973 and January 1, to June 30, 1974) as in accordance with Chapter 663 of the Acts of 1968, was carried. Yes 105 No 90.

Article 10. A motion to authorize the Selectmen to take action to post speed limits and traffic warning signs throughout the Town was carried.

Article 11. Voted: (Unanimously) to pass over Article 11.

Article 12. A motion to postpone Article 12 until Article 34 has been considered, was carried.

Article 13. Voted: (Unanimously) to pass over Article 13.

Article 14. Voted: (Unanimously) to continue the present 5 member Police Station Study Committee appointed by Selectmen, to appropriate \$12,000.00 for use of Committee for preliminary plans, report to be filed not later than next Annual Town Meeting.

Article 15. A motion to pass over Article 15 was carried.

Article 16. Voted: (Unanimously) to pass over Article 16.

Article 17. Voted: (Unanimously) to amend its By-Laws pertaining to Town Meetings by striking out Article 1, Section 2, which reads as follows: "The annual meeting for the consideration of all matters not covered by Section 1 shall be held the second Tuesday following the second Monday in March." and insert thereof "Article 1, Section 2 - "The annual meeting for consideration of all matters not covered by Section 1 shall be held on the first Tuesday in April." Such change in the Annual Town Meeting date shall be effective July 1, 1973 in accordance with M. G. L., Chapter 39, Section 9 as amended.

Article 18. Voted: (Unanimously) to authorize the Selectmen to execute a deed, or other release of right, title and interest, in land shown as Assessors Plot 8, Lot 211, to Clarence and Lorraine Bettencourt, for the purpose of clarifying title to such property.

Article 19. Voted: (Unanimously) to accept Chapter 40, Section 6B, Chapter 40, Section 6J and Chapter 40, Section 6K, all providing for the purchase of clothing and uniforms for various employees.

Article 20. Voted: (Unanimously) that a special committee investigate a proper site for a new elementary school building and report the committee's findings back to the 1974 Annual Town Meeting. This committee shall consist of seven members to be appointed by the Moderator; two members shall be from the School Committee and one member from each voting precinct in the Town.

Article 21. Voted: (Unanimously) to transfer the sum of \$1,855.09 from the sale of Cemetery Lots and Graves for the purpose of preparing sites for new graves and lots.

Article 22. Voted: (Unanimously) to authorize the Selectmen to petition the Director of the Division of Marine Fisheries, for the right to control and regulate the public fishery for alewives within the Town of Westport.

Article 23. Voted: (Unanimously) to raise and appropriate \$33,000.00 for the purchase of a Fire Apparatus for the Fire Department and to raise said appropriation the foregoing sum be taken from Revenue Sharing Funds.

Article 24. Voted: (Unanimously) that the Town of Westport adopt the provisions of Mass. General Laws Annotated Chapter 41, Sec. 100G which provides "the Town of Westport shall pay the reasonable expenses, not exceeding \$2,000.00, of the funeral and burial of any firefighter, who while in the performance of his duties or as a result of an accident while responding to or returning from an alarm of fire, or while at the scene of the fire is killed or sustains injuries which result in his death, or of any police officer who while in the performance of his duties or as a result of an assault on his person, is killed or sustains injuries which result in his death.

Article 25. Voted: (Unanimously) to accept the final report of the

Historic District Committee on file in the office of the Town Clerk together with the map of the proposed Historic Districts accompanying such report.

Article 26. Voted: (Unanimously) to take up each section separately as pertinent to the historic district mentioned in Article 26.

A motion to accept that portion of Westport Point designated as an Historic District was carried. Yes 175 No 18.

A motion to accept that portion of Head of Westport designated as an Historic District was lost. Yes 105 No 67. This action required a 2/3 vote.

Article 27. Voted: (Unanimously) to pass over Article 27.

Article 28. A motion to adopt the provisions of Article 28 was lost. Yes. 93 No 121.

Voted: (Unanimously) that we adjourn until next Tuesday, April 10, 1973.

April 10, 1973

The adjourned Town Meeting was called to order at 7:30 P. M. by Moderator Stafford Sheehan.

Article 29. Voted: (Unanimously) to adopt the following by-law, to be added to Article 11. "No appropriation of more than \$500.00 shall be voted at any Special Town Meeting, except by at least a 2/3 majority of the Town Meeting members present and voting."

Article 30. A motion to adopt the following by-law to be added to Article 11; "The quorum required for any session of any annual town meeting shall be 4% and any special town meeting shall be 2% of the total number of registered voters at the time of the most recent preceding town election as determined by the Registrars of Voters. The numerical quorum requirement for each annual or special town meeting shall be published as a part of the warrant for that meeting," was carried. Yes 184 No 47.

Article 31. A motion to adopt the following By-Law, "No member of a municipal commission or board shall be eligible for appointment or election by the members of such commission or board to any office or position under the supervision of such commission or board unless such appointment or election has first been approved at an annual town meeting. No former member of any such commission or board shall be eligible for appointment to any paid office or position by such commission or board, until the expiration of 6 months from the termination of his service as a member of such commission or board." was carried.

Article 32. A motion to adopt the following By-Law to be added to the Article XII Building Regulations: "The Building Inspector shall post a

copy of each building permit application on the Town Hall bulletin board, within 24 hours following the issuance of any building permit based on such application, and such copy shall remain posted for at least 10 days," was carried. Yes 175 No 77.

Voted: (Unanimously) to amend Article III, Section 3 of the By-Laws as revised November 1972 to read as follows: Section 3, the Finance Committee shall prior to each annual town meeting, prepare and distribute to the voters of the town a budget showing in detail, when available, and anticipated expenditures of the town for the coming fiscal year together with its advice and recommendations with reference to the various appropriations of town funds and other municipal matters coming before such town meeting at least one week prior to each town meeting. The Selectmen, School Committee and all departments required to hold public hearings relating to town meeting warrant articles, including budgets, shall hold such hearings and furnish reports thereon to the Finance Committee not less than five (5) weeks prior to the Town Meeting.

Article 41. Voted: (Unanimously) to pass over Article 41.

Article 42. Voted: (Unanimously) to pass over Article 42.

Article 43. A motion to install a pipe line along Drift Road from the property of Manuel Cabral, 1665 Drift Road to Roger Reed's property 1600 Drift Road to alleviate the flooding of land and roads in this specified area, and appropriate the sum of \$13,250.00 therefor and further recommend the Selectmen be required to exhaust all means to collect damages from the party or parties at fault for this condition, was carried.

Article 44. Voted: (Unanimously) to pass over Article 44.

Article 45. Voted: (Unanimously) to pass over Article 45.

Article 46. A motion to pass over Article 46 was carried.

Article 47. A motion to accept the provisions of Article 47 was lost.

Article 48. A motion to accept the provisions of Article 48 was lost.

Voted: (Unanimously) that we adjourn this meeting until next Tuesday, April 17, 1973 at 7:30 P. M.

April 17, 1973

The adjourned meeting was called to order by Moderator Stafford Sheehan.

Article 49. Voted: (Unanimously) to pass over Article 49.

Article 50. Voted: (Unanimously) to pass over Article 50.

Article 51. A motion to accept "C" Street a distance of 250' east of Sanford Road and raise and appropriate \$500.00 for grading and asphaltting same was carried.

Article 52. A motion to accept the layout of "O" Drive a distance of 1,400 feet extension, on file in the office of the Town Clerk, said way to be donated at no cost to the Town and to raise and appropriate \$600.00 therefor, and that no major construction be done until the Selectmen have determined if there will be any violations of the Wet Lands Act, was carried.

Voted: (Unanimously) that Article 59 be taken up at this time.

Article 59. A motion to accept the following regulations relative to street lighting was carried by voice vote.

Section 1. A five (5) member Street Lighting Committee for three (3) years term, is hereby established, consisting of one (1) member from each voting precinct of the town, and to be appointed by the Moderator. The initial appointments, to be made within ninety (90) days of adoption of this by-law, shall be two (2) for three (3) years, two (2) for two (2) years, and one (1) for one (1) year. Annually thereafter there shall be as many members appointed as there are terms which expire, all for a period of three (3) years.

Section 2. It shall be the responsibility of said committee to: (a) Review all petitions or requests for street lighting, hold public hearings thereon, and determine, within the limits of available appropriations, the number, size, and locations of street lights to be installed: (b) Examine existing street lighting and determine, after public hearings, if any lights should be relocated increased in size, or discontinued: (c) Determine on its own motion and after public hearing thereon, that street lighting is

necessary at any location even though no request has been received therefor: (d) Notify the Board of Selectmen and petitioners for street lighting, in writing, of the committee's determinations.

Section 3. The Street Lighting Budget appropriated by the Annual Town Meeting shall include such sum of money for new street lighting as the meeting, on recommendation of the Finance Committee provides and no street lighting shall be ordered installed unless the Street Lighting Budget contains funds adequate to cover the cost thereof.

Section 4. The Board of Selectmen shall order installation, relocation, or removal of street lights as determined by the Street Lighting Committee, but only when provisions of Section 3 above have been satisfied, and to take any other action relative thereto.

Articles 53-58 inc. Voted: (Unanimously) to pass over Articles 53-58 inc. and that the provisions of these articles be referred to the committee to be appointed under Article 59.

Article 60. Voted: (Unanimously) to pass over Article 60.

Article 61. Voted: (Unanimously) to raise and appropriate \$960.00 additional to the amount appropriated in Article 3 to increase the pensions of Norman Hopkinson, Lyman Crapo and Alexander Walsh.

Article 62. A motion to raise and appropriate \$5,500.00 for the purpose of maintaining during the ensuing year the mosquito control works as estimated and certified by the State Reclamation Board in accordance with the provisions of Chapter 112, Acts of 1931 and to include the naming of a study committee, by the Moderator, to obtain full information as to the nature of and necessity for the Mosquito Control Work by the State Reclamation Board, was carried.

Article 63. Voted: (Unanimously) to pass over Article 63.

Article 64. A motion to raise and appropriate \$3,000.00 in accordance with Section 13, Chapter 761 Acts of 1949 for Dutch Elm Work, was carried.

Article 65. Voted: (Unanimously) to pass over Article 65.

Article 66. Voted: (Unanimously) to pass over Article 66.

Article 67. Voted: (Unanimously) to pass over Article 67.

Article 68. Voted: (Unanimously) to pass over Article 68.

Article 69. Voted: (Unanimously) to raise and appropriate \$65,000.00 for the Reserve Fund.

Article 70. Voted: (Unanimously) that the appropriations that have been made by this meeting be raised by taxation in the tax levy for the 18 month fiscal period, except for such sums as have already been voted to be transferred from available in the treasury and Federal Revenue Sharing

Funds.

SPECIAL TOWN MEETING

Westport, Mass. July 31, 1973

Agreeable to the warrant calling said meeting the voters of the Town of Westport assembled at the High School Auditorium on the above date. The meeting was called to order by Stafford Sheehan, Moderator. Althea M. Manchester, Assistant Town Clerk acted as timekeeper for the meeting in accordance with a by-law adopted under Article 45 of the Annual Town Meeting warrant of 1963.

Voted: (unanimously) to dispense with the reading of the warrant.

Article 1. Voted: (Unanimously) to have the Selectmen dismiss the present Fire Station Building Committee, with thanks.

Article 2. Voted: (Unanimously) to have the Selectmen dispose of the Factory School, land and building, by auction, or sealed bids.

Article 3. Voted: (Unanimously) to dispose of the cottage on Partington's property on Old County Road, by auction, or sealed bids with the condition that it be removed from the land within 60 days.

Article 4. Voted: (Unanimously) to appropriate, for the support of schools only, the sum of \$18,086.00, which sum has already been received, and is presently available, in the account "Title I, Federal Funds, PL 874, PL 88-210 Federal Funds."

Article 5. Voted: (Unanimously) to pass over Article 5.

Article 6. Voted: (Unanimously) to pass over Article 6.

Article 7. Voted: (Unanimously) to accept the layout of "C" Street easterly from Sanford Road approximately 430 feet, as shown on the plan on file with the Town Clerk, and to utilize the sum of \$500.00 for grading and asphalt as previously voted on Article #51 at the Annual Town Meeting, provided the street is acquired by donation without cost to the Town for land damage, and provided further that the Town is granted an easement without cost to the Town on land beyond the ease end of the street which land will be used for street drainage from Sanford Road.

Article 8. Voted: (Unanimously) to authorize the Selectmen to dis-

pose by auction, surplus school equipment.

Article 9. A motion to authorize the Police Station Building Committee, to have construction plans prepared for a new police station to be located on Town owned land at the Town Hall, was carried.

Article 13. A motion to adopt the following by-law: "No person shall make any indecent, profane, or obscene figure, diagram or word upon any sidewalk, fence, building, post, street or other object within or along any street or public way," was carried.

Article 14. A motion to repeal all existing Zoning By-Laws was lost.
Yes 82 No 480.

Article 15. A motion to adopt the provisions of Article 15 was lost.
Yes 163 No 347.

Article 16. A motion to amend the Zoning By-Law of the Town of Westport by deleting the present non-conforming use regulation under Section VI-A and adopting the following new regulations:

Section VI. General Regulations

VI-A. Non-conforming uses.

1. The lawful use of any structure or land existing at the time of the enactment or subsequent amendment of this By-Law may be continued although such structure or use does not conform with the regulations of the district in which it is located and allow the right to be sold to any equal or similar business.
2. Abandonment. A non-conforming use which has been abandoned four years shall not be re-established and any future use shall conform with this By-Law.
3. Changes. A non-conforming use may be changed so as to conform to this By-Law but once changed to a conforming use, no structure or land shall be permitted to revert to a non-conforming use. A non-conforming use may be changed to another use not substantially different in character or not more detrimental to the district upon approval by the Board of Appeals.
4. Alteration. A non-conforming structure may be altered or reconstructed or replaced.

5. Extension. A non-conforming use may be expanded in size or scope of the activity within the confines of the lot used therefor and to the extent permitted by the building regulation by-law.
6. Restoration. A non-conforming structure damaged or destroyed by fire or other causes may be repaired or rebuilt, was carried,

The adjourned Town Meeting was called to order on the above date at 7:30 P. M. by Moderator Stafford Sheehan.

Section V. Intensity Regulations

V-A Except as is otherwise permitted under the provisions of Section 5a or Section 7A of Chapter 40a of the General Laws, a dwelling hereafter erected or placed in any district shall be located on a lot having not less than 60,000 square feet of area and 150 feet of frontage. No existing lot shall be changed as to size or shape so as to result in the violation of such area or frontage requirements. And no more than one dwelling shall be built on any such lot. Provisions of this section V-A shall not apply to any existing lot, which complied with previously approved intensity regulations as to area and frontage, if such lot was recorded in the Registry of Deeds at the effective date of this regulation.

V-B A dwelling hereafter erected or placed in the Residence District or in the Business District shall not exceed either 2½ stories or 40 feet in height.

V-C No dwelling for occupancy by two families shall hereafter be built, erected or located on a lot having an area of less than 80,000 square feet and 200 feet frontage. For each additional 20,000 square feet of area and 50 feet of frontage in the lot, the size of the dwelling may be increased to accommodate one additional family or dwelling unit, was carried. Yes 237 No 104.

Article 18. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by adding the following as a permitted use under Section IV-A (1):

(f) Two family dwelling

Article 19. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by deleting the present definitions of lot and street,

line in paragraphs 6 and 8 of Section II and adopting the following new definitions as paragraphs 6, 8 and 11 of Section II:

- 6. Lot: An area of land in one ownership with definite boundaries, used, or available for use, as the site of one or more buildings.
- 8. Street: Any duly accepted public way, any way not less than 40 feet wide shown on a plan duly recorded after April 10, 1920, or any other way equivalent to a public way for the purposes of subdivision control as specified in General Laws, Chapter 41, Section 81L.
- 11. Way: Same as street.

Article 20. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by including in the Business District under Section III-B (2) the portion of the Town bounded and described as follows:

Southerly by the American Legion Highway (Route 177)
Westerly by Forge Road
Northeasterly by the State Highway (Route 6)
Easterly by the Westport-Dartmouth boundary line.

Article 21. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by including in the Business District under Section III-B (2) the portion of the Town bounded and described as follows:

Beginning at the intersection of the west line of Forge Road with the north line of the American Legion Highway (Route 177); Thence proceeding northerly along said west line of Forge Road five hundred (500) feet; Thence proceeding westerly along a line, which line is five hundred (500) feet northerly from, and parallel to the north line of the American Legion Highway, to a point on the east line of Sanford Road; Thence proceeding southerly along said east line of Sanford Road five hundred (500) feet to the north line of the American Legion Highway (Route 177); Thence proceeding easterly along said north line of the American Legion Highway to the point of the beginning.

Article 22. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by including in the Business District under Section III-B (2) the land bounded and described as follows:

Beginning at the intersection of the south line of the American Legion Highway (Route 177) with the west line of Beeden Road; Thence proceeding westerly along the south line of said American Legion Highway to a point two thousand (2,000) feet west of the southerly extension of the west line of Sanford Road; Thence proceeding south five hundred (500) feet; Thence proceeding easterly along a line, which line is five hundred (500) feet southerly from, and parallel to the south line of the American Legion Highway, to a point on the west line of Beeden Road; Thence proceeding northerly five hundred (500) feet along the west line of Beeden Road to the point of

beginning. Beginning at the intersection of the west line of the Old County Road with the north line of Mouse Mill Road; Thence proceeding westerly four hundred (400) feet; Thence southerly and parallel to the west line of Old County Road four hundred (400) feet; Thence easterly four hundred (400) feet to the west line of Old County Road; Thence proceeding northerly four hundred (400) feet along the west line of Old County Road to the point of beginning.

Article 23. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by including in the Business District under Section III-B (2) the land bounded and described as follows:

Beginning at the intersection of the south line of the State Highway (Route 6) with the Westport-Fall River boundary line; Thence southeasterly along said south line of said State Highway (Route 6) to the west line of Forge Road; Thence southerly along said west line of Forge Road to a point five hundred (500) feet northerly of the north line of the American Legion Highway (Route 177); Thence westerly along a line, which line is five hundred (500) feet northerly from, and parallel to the north line of the American Legion Highway, one thousand (1,000) feet; Thence northerly to a point, which is five hundred (500) feet east of the end of the east line of Center Street, to a point five hundred (500) feet southerly from the south line of the State Highway (Route 6); Thence northwesterly along a line, which line is five hundred (500) feet southerly from, and parallel to the south line of the State Highway, to the Westport-Fall River boundary line; Thence northerly five hundred (500) feet along said boundary line to the point of beginning.

Article 24. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by including in the Business District under Section III-B (2) the land bounded and described as follows:

Beginning at the intersection of the north line of the State Highway (Route 6) with the Westport-Dartmouth boundary line; Thence northwesterly along said north line of the State Highway (Route 6) to the east line of Washington Street; Thence northerly along said east line of Washington Street five hundred (500) feet; Thence southeasterly along a line, which line is five hundred (500) feet northerly from and parallel to the north line of State Highway (Route 6) to a point on the Westport-Dartmouth boundary line; Thence southerly along said boundary line to the point of beginning.

Article 25. Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by including in the Business District under Section III-B (2) the portion of the Town bounded and described as follows:

Beginning at the intersection of the north line of the American Legion Highway (Route 177) with the west line of Sanford Road; Thence northerly along the west line of Sanford Road one thousand (1,000) feet; Thence westerly along a line, which line is northerly from, and parallel to the north line of the American Legion Highway, two thousand (2,000) feet; Thence southerly along a line, which line is parallel to the west line of Sanford Road, one thousand (1,000) feet

to a point on the north line of the American Legion Highway (Route 177); Thence easterly along said north line of the American Legion Highway (Route 177) to the point of beginning.

Voted: (Unanimously) to amend the Zoning By-Law of the Town of Westport by including in the Residence District under Section III-B (1) all of that portion of the Town not previously voted by a two-thirds vote of a Town Meeting to be included in the Business District, bounded and described as follows:

Southerly by the American Legion Highway (Route 177); Westerly by the Westport-Fall River boundary line and the South Watuppa Pond; North-easterly by the State Highway (Route 6); Easterly by the Westport-Dartmouth boundary line.

The many problems facing the Board of Selectmen have increased with the rapid growth of our Town.

One of the major problems was the need of zoning regulations for everyone's protection. As a result of numerous meetings and hearings, the Special Town Meeting in July of 1973 adopted zoning regulations for the entire town. Hopefully these regulations will protect the investment of home owner and businessmen of any severe loss, or depreciation in value of their property.

The Highlights of the Selectmens' meetings have been published bi-weekly in your local newspaper to keep you abreast of the many problems of Town Government.

Road drainage has been a serious problem for many years. Due to the increase of funds in the drainage account, and the excellent cooperation of the Highway Surveyor, many of these drainage problems have been solved.

The need for a new Police Station is long overdue. We realize your awareness of this by your approval of a building committee, and funds for planning. We hope you will give this serious consideration at the Annual Town Meeting, so it may become a reality in 1974.

We as members of the Board of Selectmen spend considerable time appointing and establishing committees; taking part in their activities, while also trying to solve many of the Town problems.

In conclusion, we wish to thank our many citizens who serve on our committees, appointed by our board, for the many hours they spend in the interest of the community. Also, to our Secretary, Mrs. Phyllis Bernier, for her efficient administration of her duties in our office. Our thanks to all elected and appointed officials for their cooperation in the past year.

MASTER PLAN UPDATING COMMITTEE

REPORT FOR THE CALENDAR YEAR 1973

The Westport Master Plan Updating Committee held continual meetings during the early part of the year in preparation for a Special Town Meeting which was held in July to act upon the recommendations of the Committee relative to the acceptance of a Master Zoning Plan for the Town.

Prior to the Special Town Meeting, several public hearings were held by the Committee to discuss with concerned citizens the nature and intent of the proposed zoning regulations.

The Special Town Meeting was 100 percent successful in that our goal was attained--namely, to completely zone the Town of Westport for the first time in its history. Of 29 agenda items presented, the townspeople accepted 21 of these items as basically proposed. Furthermore, rejection of the eight remaining proposals did not in any way defeat the ultimate goal of this Committee, which was to completely zone the Town. These eight items dealt with specific types of zoning in certain areas and the resultant effect of their defeat at the Meeting was not to defeat zoning as a whole, but only to change the classification of the type of zoning in certain areas affected by these items.

From this foundation, the Committee feels that future Master Plan Updating Committees will have a framework within which to work successfully toward those goals that will continue to improve and modernize the operational characteristics of our Town.

Staff meetings are also held weekly when possible, for patient discussion and other nursing data that may assist the nurses in areas where required.

During the past year, four men have been attending Bristol Community College Fire Science classes.

Four men, including myself, attended a three day Arson investigation Seminar in Worcester, Mass, co-sponsored by the Massachusetts Department of Public Safety and the Massachusetts Fire Chiefs' Association.

Also during the past year, four men successfully completed an Emergency Medical Technition (Ambulance) course at Diman Regional Vocatioal School, two of whom successfully completed the Federal Register exam.

On April 1, 1973, the Department organized a Fire Prevention Bureau, consisting of one man. I believe very strongly in Fire Prevention and what it teaches, and believe that with stronger Federal and State Regulations, enforced at the local level that losses to life and property will finally take a downward trend.

While I am on the subject of loss of life and property, I wish every family in the Town would seriously consider the purchase of at least one combination heat and smoke detector for their home. The prevention of all fires is literally impossible, regardless of how careful we are, but the early or quick detection of a fire will absolutely reduce the losses to a minumun.

As of April 1, 1973, Chris Cariglia was hired by the board as Program Director.

A boy's basketball league was again successful under the direction of Mr. William Baraby. Games were played 2 nights a week for 10 weeks, with six teams participating. We thank all those who assisted.

40 boys and girls entered our 2nd Annual Chess Tournament, held in the Middle School Cafeteria, under the direction of Mr. Emery Gomes. It was an elimination type tournament, divided into two divisions. Students in grades 1-8 were in the junior division; and those in grades 9-12 in the Senior division.

The Giants, managed by Bruce Alves and Gerry Thomas were champions of the Junior Baseball League. Our thanks to all the managers and their assistants.

Our Swimming Program was again directed by Mrs. Joan Flathers, and conducted at the Town Beach on the river. It may be again necessary to expand the program hours to accomodate the anticipated increase in enrollment for 1974.

HOUSING AUTHORITY

Gentlemen:

We are pleased to report to you that we anticipate tenants moving into the elderly housing on State Road in the early part of 1974.

It was necessary to make many revisions resulting in greatly increased costs for the Project, particularly for site clearance, filling, and the elaborate sewage system required by the State Department of Public Health.

In attempting to retain the architectural integrity of materials most commonly used in the Town of Westport, the Housing Authority chose natural white cedar shingles, instead of brick, for exterior walls. The substantial depth of fill resulted in the death of several trees which we had attempted to retain. The Authority requested the State Department of Public Works to designate a cross walk area near the site across State Road. The request was denied.

In 1973 the Massachusetts Department of Community Affairs increased our funding level by \$400,000 to \$1,365,000 for the completion of the 48 one-bedroom units.

The application for occupancy process was begun in July with the posting of notices in the four newspapers that serve the Town, in the Town Hall, Post Offices, churches and local businesses. As of December 31, 1973, 106 applications had been received and all applicants interviewed. Preference for occupancy is given to present and former residents of Westport. Townspeople will be invited to attend open-house and dedication ceremonies to be held in the Spring of 1974.

According to present plans, the community building will be utilized for the activities of all senior citizens of the Town. We again wish to thank the people of Westport for their assistance and support during the planning and construction of this Project. We now look forward to a successful management phase in 1974.

BRISTOL COUNTY MOSQUITO CONTROL PROJECT

Gentlemen:

The Bristol County Mosquito Control Project has completed fourteen years of service to the Town of Westport and eighteen other communities within Bristol County. The entire county will be serviced by the Project this year with the rejoining of the Town of Dartmouth on July 1, 1973.

The Project was again plagued by the appearance of equine encephalitis. The first case was reported on August 13th, and the last on September 16th. The communities involved were: Acushnet (1), Taunton (1), Dartmouth (3), Westport (2), Freetown (1), Berkley (2), Somerset (1), Dighton (1), and Seekonk (1), a total of 13 cases.

The State Department of Public Health aerial sprayed the entire County in an effort to prevent an encephalitis epidemic. Our spray trucks were also alerted to each case as it appeared and the immediate area was also sprayed from the ground.

In March our larvicide program got underway and 35 acres were treated before our mist blowers were mounted on the first of May. Adult mosquitoes were on the wing very early this year and our spraying season did not terminate until October 1st.

With the spraying season over, the mist blowers were removed and all crews turned to our brook and ditch maintenance program. This resulted in the removal of 3,980 feet of debris and obstructions from existing brooks and ditches. 2,810 feet of brush was also removed to allow proper drainage and to aid in preventing unnecessary flooding.

All our personnel are licensed for the application of pesticides and use only those approved for mosquito control by the State Pesticide Board.

We want to thank the residents of Westport for their continued cooperation.

REPORT OF THE WESTPORT CONSERVATION COMMISSION

Gentlemen:

At its annual election held at the May meeting, the following slate of officers was elected: Normand Sasseville, Chairman; Sat Khanna, Vice Chairman; and Virginia Guptill, Secretary.

It was with deep regret that the Commission accepted the resignation of two faithful and long serving members, George Medeiros and Rev. Jones B. Shannon. Howard Burbank and James Cronin were appointed to fill the vacancies.

The Commission continued an improvement and maintenance program for the Horseneck Conservation Area. Included in the work done this year was the planting of beach grass and pine, fertilizing, and fence repairs.

The Soil Conservation Service has started the soil survey that was sponsored by the Commission and passed at the 1972 Town Meeting.

The passage of the Wetlands Protection Act, Chapter 784 in the Fall of 1972 has given us the essential authority to effectively control the development of wetlands in the town. This legislation has increased the Commission's work load appreciably. The Act requires any person wishing to fill, dredge, remove any bank, flat, marsh, meadow or swamp bordering on inland waters to file a Notice of Intent with the Commission.

This year Albert Palmer began his duties as a part-time Conservation Officer. His services have been essential to the Commission's ability to discharge its duties.

A high priority goal of the Commission for the coming year is the need to devote more time and effort to long range development in town.

The Commission meets every third Monday of the month at the Town Hall.

We wish to thank all who have assisted us during the year.

CIVIL DEFENSE

Gentlemen:

I hereby submit the following as the report of the office of Civil Defense for the year 1973.

During the past year approximately 75 high school students completed the medical self-help and first-aid courses administered by this department. These courses were also offered to numerous Civil Defense volunteers as part of a continuing program of emergency preparedness.

The Civil Defense Director, Mr. Charles M. Arruda, and various CD personnel attended monthly meetings at Segregansett and Bridgewater where area directors congregated to discuss emergency preparedness and compare related community problems. Mr. Arruda and staff were also in attendance at meetings in Framingham and elsewhere throughout the sector.

Since the onset of the energy crisis, Civil Defense has been instructed to make emergency preparations and revitalize the Rationing Boards that come under its jurisdiction should their services be needed. Chairman of the Rationing Board, Mr. Norman Michaud, and his fellow members have already begun working to alleviate energy problems affecting the town and its residents.

Director Arruda attended the University of Massachusetts seminars on energy conservation and rationing and completed various courses that aid him in his effort to help the community.

Classes in Radiological Training, Shelter Management, Medical Self-Help, First-Aid and Civil Defense Nursing Care are once again being offered to individuals, groups and organizations. Contact Director Arruda for further information.

The town's emergency warning systems and sirens are tested each Wednesday at 11:15 A.M. throughout the year to ensure their operation readiness.

The state radio drill is conducted on the first Monday of each month to ensure continuing radio network operation and contact throughout Massachusetts Sector 2-A.

Civil Defense equipment is stored and maintained at the following locations: one jeep and one automobile at the Fire Department; one generator at the Fire Department; one automobile as needed by the Fish Warden; one generator at the Highway Department which also houses and maintains the second jeep and the amphibious duck used in rescue operations.

The CD office has acquired equipment through Federal surplus and excess property during the course of the year amounting to some \$661.00. The town's share of the equipment cost was less than half that amount. Through Public Law 606 some \$702.00 was returned to the town as a result of Civil Defense actions.

In cooperation with new Federal policy, Westport Civil Defense is in the process of converting to a six-meter Gonset Communicator system with half of the estimated \$750 to \$1,000 cost being assumed by Federal as this is a mandatory conversion.

In 1973, the Master Plan Committee after many months of concentrated activity, turned over to the Planning Board proposals for completely zoning the town. In July, the board presented these proposals at a special town meeting and the large turnout of Westport voters indicated their concern for the future of the town by passing the majority of the recommended articles.

We await with interest the Soils interpretive Report being compiled by the Soils Conservation Service. This will be an important tool for the board in making future land use recommendations.

Mr. Harold Sanford was the Board's delegate to the Southeastern Regional Planning and Economic Development District.

Warren M. Messier was the Board's delegate to the Conservation Committee.

Antone Gracia was the Board's delegate to the Soil Conservation Board.

The board acknowledges with thanks the assistance and cooperation given throughout the year by the various town offices, particularly the Board of Health, the Conservation Commission and the Highway Surveyor.

It is essential that orderly and progressive development of the town under the supervision and approval of the Planning Board and other agencies within the town continue if the town is to improve to the best of its potential.

ANNUAL REPORT
OF THE
GREATER FALL RIVER VOCATIONAL SCHOOL DISTRICT

Starting January 1, 1973, every community in the Commonwealth of Massachusetts initiated an eighteen-month budget in order that they might comply with state law enacted by the legislature that all communities set up budgets on a fiscal year rather than a calendar year. However, as town meetings are for the most part still being held in April and as it would be impossible to submit an annual report based on the fiscal year when this report must be published for the town meetings in April annual reports will still be a record of events for the calendar year January 1, through December 31.

The Greater Fall River Vocational School District Committee can be proud of its record of accomplishment during 1973. A significant achievement in this period occurred when the school was accredited by the New England Association of Schools and Colleges for a ten-year period as a result of a survey conducted by a team of evaluators on April 3, 4, and 5, 1973. This accreditation covered the high school, technical institute, and school of practical nursing. While the ten-year accreditation was extremely important, the side effects of accreditation such as self evaluation, teams of teachers working together, and the updating and development of courses of studies in vocational and academic areas were equally important.

During this same period, Diman Regional School of Practical Nursing was also evaluated and accredited by the Massachusetts Board of Registration in Nursing. The demand for people in the health related fields is a continuing one. Representatives from hospitals and nursing homes met with the administration at Diman relative to initiating a program to train nurse assistants. As a result of these meetings, a program was developed and started on December 10, 1973. It is a twelve-week program, thirty hours per week with students spending four weeks in school and eight weeks in affiliation. Three classes per year will be admitted and enrollment is open to high school seniors and interested adults; twelve students will be accepted in each class. The training of nurse assistants at Diman is the only such formal training available in the area and hospitals and nursing homes have agreed to refer applicants interested in this work to Diman for training.

The Homemaker-Home Health Aide program continues to grow. Three forty-five hour courses were held and forty-four students completed the program. In our Practical Nursing program sixty-seven students graduated and passed their state board examinations and all are working.

An eighty-one hour course for Emergency Medical Technicians to upgrade the skills of ambulance service personnel was also held this past year. Sixteen men completed the program and five of the seven men in the course who took the national examination passed and are certified as Emergency Medical Technicians. There is an urgent need for more of this training in the area and recently passed legislation mandates that by 1977 all personnel in ambulance service work must complete this type of training. It can truly be said that in the area of training personnel for health services field, the contribution of Diman Regional is indeed significant.

Day school enrollment as of October 1, 1973, totalled 1067 students with 904 enrolled in high school programs; 88 in practical nursing program; and 75 in the technical institute programs. Our evening school program had an enrollment of 368 students in twenty areas. The most popular courses were fireman second class, fireman first class, and welding. In addition to this, 804 adults completed a Food Handlers program in order to obtain a certificate from the Board of Health to work in establishments dispensing or serving foods and liquor.

The Coast Guard Auxiliary and the Power Squadron made use of our facilities to offer courses in Seamanship, Navigation and Safe Boat Handling to 200 adults. Under a Jobs-Nabs program sponsored by the Fall River Area Chamber of Commerce, 18 students received job related instruction after school hours during the year. During the summer of 1973, the Regional School Committee approved a seven-week program to train high school graduates as machine operators. Nine students were enrolled and completed the program and eight of these students were placed in machine shops as operators immediately after completing the course. It is interesting to note that five of these student returned to Diman to register in an evening school program for numerical tape control.

For the first time, the school initiated a cooperative program which enabled senior students to work in industry for the two-week period they were scheduled to be in the school shop. Academic and vocational requirements were established to define how seniors would be eligible to participate in the program and the cooperative job had to be in the area the senior was studying. The program started the third term of the school year and thirty-nine seniors participated in it. The purpose of the program, which is optional for seniors, is to give them actual job experience in an industrial setting; to get a reaction from employers as to the relevancy and quality of the training we provide our students; and to open up opportunities for vocational training in our school to seniors from area high schools who could be accepted to fill openings in shops where students are working on cooperative jobs.

In 1973, 195 students were graduated from our high school programs; 140 are working in the trade or allied fields; 24 are in the armed services; 24 are continuing their education; and 7 are unaccounted for. Forty students graduated from the technical institute programs; 37 students are working in the field they studied; 2 are continuing their education; and 1 is working out of his field. The excellent placement record we have enjoyed with our graduates over the years is an indication of the recognition industry gives to graduates of Diman when hiring new employees.

Professional development and degree courses are offered Tuesday evenings and Saturday mornings throughout the school year. To meet the educational needs of the area, the school is open Monday through Thursday from 8:00 a.m. to 10:00 p.m.; Friday from 8:00 a.m. to 5:00 p.m.; and Saturday from 7:00 a.m. to 1:00 p.m.

It is worthy to note that the school has added a guidance counselor to provide more and better services for our student body; that our guidance department in conjunction with our academic department heads has initiated a standardized testing program for freshmen and junior students to help us

better evaluate our students and our programs; that four of our students won top awards in the Regional Science Fair and that three of our students were selected to participate in the State Science Fair at M.I.T.; that eleven of our students in the Electronics Department received F.C.C. licenses and two of these included Broadcast Endorsement; that our carpentry students have started construction of a field house which will be a welcome addition to our athletic fields; that a systems analyst has been hired who will meet with representatives of various school and and municipal departments in the region to explain how our computer can help them and work with them to develop programs which can be run on our computer; that because of the development of the cooperative program at Diman steps are now being taken by the Guidance Department and administration at Diman to accept senior students from the area high schools into vocational education programs; that the principals of the high schools meet periodically with the superintendent director in order that they will know what vocational offerings are given and are available and to exchange ideas and discuss mutual problems.

It is important to know also that because of the nature of vocational education in the training of our students many agencies benefit through the work of our students. The Boys Club, YMCA, United Fund, Nazareth Hall, Credence House, Public Works, Water Board, Cancer Home, Senior Citizens, Park Department, and Police Departments are some of these agencies.

An Annual Report would not be complete without projecting some goals or some objectives for the future. It is a good way to insure progress. During this year, we will be working to:

1. Develop electives in math and English for seniors.
2. Institute closed circuit TV as a tool for better teaching in all areas of the curriculum.
3. Initiate a program in structural drafting at the high school level in order to accept more high school students in the program.
4. Obtain accreditation of the Medical Assistant Program by the American Association of Medical Assistants.
5. Implement the recommendations of the evening committee from the New England Association of Schools and Colleges.
6. Continue the joint meetings with the school committees of Fall River, Somerset, Swansea, and Westport.

In closing this report, your superintendent-director deeply appreciates the support of the administrative staff, the Guidance Department, the department heads, the faculty, and the entire cafeteria, clerical, and custodial staff. It is only with your continuing cooperation and dedication that we can provide the highest type of vocational education to all the people in the area.

Your superintendent-director is ever grateful to the Regional School District Committee. The demands placed on their time in running a modern vocational-technical school are tremendous, and I would be remiss if I did not commend them for their work.

COMMITTEE FOR COMMERCE AND INDUSTRY

FOR THE CALENDAR YEAR 1973

This Committee held several meetings during 1973, the resultant effect of which was to determine our goals for the year, which were (a) implementation of an acceptable zoning plan for the Town; and (b) an investigation into the procurement of a municipal water system, initially in those areas where commercial and industrial considerations are paramount, as well as those portions of the Town (primarily the northern sections) where a public water system would be beneficial for public health reasons in densely populated areas.

Goal No. 1, the implementation of an acceptable Zoning Plan was successfully carried out by the Master Plan Updating Committee at the Special Town Meeting held in July, 1973. The major commercially-oriented areas--namely, Route 6 and Route 177, were appropriately zoned as such by the Town in accordance with the Updating Committee's recommendations. Other aspects of the accepted Zoning Plan will also contribute to a successful future for commercial and industrial growth within specified areas of the Town.

Goal No. 2, investigation into the procurement of municipal water system, was formally authorized by your Board of Selectmen and was assigned to this Committee for further action. As of the end of 1973, research conducted by the Committee and by Camp, Dresser, and McKee, Consulting Engineers of Boston, Massachusetts, revealed that the most practical method for acquiring such a System would be through the purchase of water from the City of Fall River.

Concurrent with this investigation will be research into the availability of regional, state, and federal funds to assist with such a program.

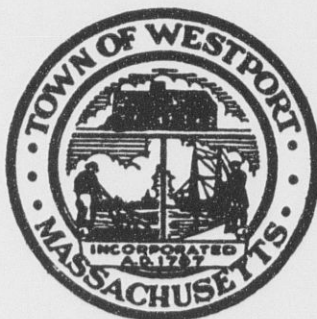

It is the policy of the School Department to issue no-school bulletins or announcements through Radio Stations WALE and WSAR, FALL RIVER: WNBH and WBSM, NEW BEDFORD: WPRO PROVIDENCE, whenever driving conditions are, or seem likely to be, dangerous. On doubtful mornings, the family radio should be tuned to one of the above station for the no-school announcements. Please depend upon your radio rather than your phone for obtaining this information as telephone lines have to be kept open.

Parents must use their own judgment, in regard to whether it is suitable for their children to attend school in stormy weather.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

I would like to submit our annual report for the school year 1973.

This year was a year of identification, trying to ascertain our needs as far as curriculum development, assessing our strengths regarding staff members, implementing more student services, and identifying areas of specific and special needs.

We and our guidance and administrative departments are trying to ascertain through appropriate tests, field trips, and conferences the various aptitudes, interest areas, ability levels and desires of our undergraduate. When we have ascertained these needs, we then try to group them according to their abilities. We would like to do this in all subject matter disciplines, and this is what we are working toward. We do group them according to their mathematics and language arts ability at the moment. We have to take a long look at the economic picture in our area and in Massachusetts and in general the United States for our graduates do not of necessity always stay in this immediate area. We are trying to encourage and establish career occupation needs and abilities at the earliest possible age and hopefully in the near future we will be offering courses to meet these needs. This is a long range program and cannot be done overnight. I feel that we are doing a reasonably good job with our college prep students but I feel there is a great need for doing more for our terminal and general students for the bulk of our students come from this area and we must meet their needs as soon as possible. This is our ultimate goal and again we cannot accomplish this overnight but through our curriculum development and guidance and testing program we are making definite inroads.

In the Middle School we are identifying the needs of our students especially in the transition from primary to the Middle School area. This was brought about with our new "Project Beacon." In this we have used a random means of selecting our students and a complete heterogeneous form of grouping. We also use flexible scheduling and a very definite concentrated grouping and team approach therefore meeting the needs of each individual student and allowing them to work in many cases in independent study groups. To further implement their future exposure to the economic world, we are organizing a Junior Achievement program whereby students will get firsthand information and experience in a variety of areas pertaining to manufacturing, packaging, salesmanship, selling, display, and other types of management.

In the High School we offer a work study program where students get firsthand information and are freed for a part of the school day to actually work on the job. This of course gives them the student, the opportunity of knowing more about a specific job venture and in turn gives the employer the chance to study at first hand the employee for possible hiring at a later date.

This year our high school had its accreditation renewed for a period of 2 years at which time new facilities and educational programs will be in full gear and the chairman of the Evaluating committee from New England Association of Schools and Colleges will visit us again. We are very hopeful that we will get a full accreditation.

This year we have had the good fortune of having a full time school Psychologist whose major responsibility is to work with the Special Education, Learning Disabilities and emotionally disturbed students. This is done so that we can use preventive measures along with our corrective measures with students who have special problems. We have also added two new guidance personnel--one at the High School and one at the Middle School--to identify and work with student

problems and to assist them in the selection of courses and career studies. We for the first time adopted through the use of released time and complete staff involvement basal texts for our Science, Reading, spelling and academic disciplines. We are again this year studying the other subject disciplines to develop basals in other areas such as Mathematics, Social Studies, etc. We have a long way to go for we not only want to adopt basals for the students but we also want to identify with advance placement and the slow learner so that these needs may be met. It is not possible to take any one text and have this meet the needs of all of our students.

I am sure it is not necessary to remind the people of Westport of the overcrowding of our schools and that it is absolutely mandatory to provide spaces for additional elementary students as soon as possible. This is not only the school committee's feelings but it is also strongly urged by the State Department of Education because they felt that it is impossible for us at the present moment to offer to our elementary students the programs that they are entitled to especially in our special areas. The overcrowded conditions are going to get worse not better as our projections clearly indicate by the State Department and by educational consultants and by the administration. We therefore would appreciate when the appropriate site has been selected, your cooperation in taking the necessary steps to alleviate this overcrowded condition and to meet the needs of our students.

I would also like to express my appreciation to the School Committee for their continued support, interest and encouragement which again has been shown and given to me this year, for without a united and team approach to education with the administration and School Committee, education can and will remain stagnant. I would also like to express my appreciation to the School Building Committee for their cooperation and patience in the purchasing of equipment and following through with the High School Building program. It has been an enormous task and has meant many many hours and involved many people but the end result is more than worthwhile for we feel we have saved the town thousands of dollars by doing the work ourselves and not spending the townspeople's money by hiring outside consultants. May we also thank you the parents and the students for your support, cooperation and understanding for again we are all working for a common goal that of providing the best educational climate for our total student body and by your support it is making this possible.

WESTPORT HIGH SCHOOL

This year the High School was accredited by the New England Association of Schools and Colleges and reflected a full year plus of study and self-evaluation of the entire plant. We were very pleased to receive a two year accreditation and with every hope that at the end of two years when our program has been completely implemented that we will receive an additional eighth years to get the regular ten year approval. This is a continuation for Westport High School has always been approved and every ten years we must be reevaluated.

We should also like to mention that this is a very trying year for the administration, teachers and especially students because of the construction that had to go on to complete the physical plant. Our appreciation is certainly offered to the students, teachers and of course parents for their understanding and cooperation. We have had several innovations in the High School level -- one being that of the non-college student where during the summer months the Math Department coordinator worked out several programs for the non-college student in a lab math program. It meets the needs of the terminal and identifies in a much more practical way the values and necessities of Math. Another change has been the interest and the encouraging of the girls to participate in what has normally been male classes such as shop and mechanical drawing. The boys have shown an interest in Home Economics whereby they have had boys working in the cooking and clothing areas with great success. We would like to acknowledge the retirement of Dr. Martineau and Miss Cahoon and Mrs. Webb. Mr. Menard has filled in during the year due to Dr. Martineau's illness and now has been officially elected as Vice principal, Mr. Menard understands the students and has worked with them in the capacity of coach and teacher. He has respect of faculty students and administration alike.

WESTPORT MIDDLE SCHOOL

The Westport Middle School continues to grow with the influx of students. Our student population is nearing eight hundred and seventy which is an increase of seventy-one students since the close of school last June. The expected enrollment for September, 1974, will be nine hundred and thirty-four.

Our major efforts this year have been concentrated on improving the curriculum, updating textbooks, and supplementary materials as needed.

One of the concerns we are attempting to resolve is centered around, "Keeping a large school small enough so that a student can feel he is a very important part of it." We have taken a big step toward that end by establishing a pilot program called "Project Beacon." "Project Beacon" is a small school within the school for one hundred and forty-five fifth graders. It has been a successful adventure to date. We will continue this effort in the Fall of 1974 to include all incoming fifth graders.

This year we have had the pleasure of hosting a number of Westport High School activities while they are undergoing construction, expansion, and refurbishing. The Middle School continues to provide many extra-curricular programs which are an extension of the regular program. These programs are a direct result of extra involvement on the part of many staff members. Some examples are Foreign Language students cooking and serving dinner to parents, Rainbow Art Festival, Music Concerts (225 member chorus and 55 member band),

Girls Gymnastics Club (approximately 100 members), 5th and 6th grade plays, Boys and Girls physical education after school programs, i.e. Softball (boys and girls), field hockey (girls), tennis (boys and girls), soccer (boys and girls), gymnastics (girls), flag football (boys), volleyball (girls), basketball (boys), cheerleaders (girls), gym hockey (boys.)

The continued growth and development of the total educational process is the result of staff involvement, student desire, parent support, the cooperation of the Superintendent of schools and the School Committee. My sincere thanks to everyone on behalf of the students and staff at the Middle School.

PAUL WILBER, PRINCIPAL

MILTON E. EARLE SCHOOL

With the retirement of Miss Audrey Tripp, this has left a very serious and definite void in our elementary program. Miss Tripp was not only a dedicated Principal, but extremely knowledgeable, interested and a vital part of our elementary program here in Westport for many many years. She had 38 years of dedicated service to the Town, twenty one of which she spent as Principal of the Earle School and we wish her well. It was a very difficult task trying to find someone who would be able to carry on her very lofty and fine educational ideas and ideals.

It was an arduous and difficult task to interview, investigate and appoint a successor to Miss Tripp but we feel we have a gentleman who has the empathy, curriculum background, and a personality that will carry out the needs it dictates at the Earle School. This educator is Mr. Allen R. Flechsig, who is a former resident and who has had a great deal of work and experience in curriculum development in Michigan and the State of Florida. We welcome him and wish him all the best of luck in his new educational challenge.

It was with reluctance that we had to use the Earle School gymnasium for classrooms but due to the population explosion we had to equalize the enrollments from our other elementary schools. This has been done and at the present moment it is working out very satisfactorily. We are utilizing various phases of the open classroom and with a team teaching approach especially in the 3rd and 4th grade classes. The cooperation has been outstanding and the past experience that Miss Andrade and Miss desJardins who was the former lead teacher at the Howland Hall, has been invaluable in this transition period.

Mrs. Santarpia, former Principal at the Head School, was appointed Guidance and Reading teacher at the Earle School, due to the increased enrollment and also to meet the needs of the student body especially in the Guidance and Reading areas.

ALLEN R. FLECHSIG, PRINCIPAL

ALICE A. MACOMBER SCHOOL

All teachers are continuing to work to establish a curriculum to meet the needs of our students. This year the teachers of grades one to four are working in the areas of Language Arts, Mathematics, Science, and Social Studies. Basic texts were adopted in the areas of Reading, Spelling, Science, and mathematics last year, and they are now concentrating on multi-text supplements.

Since I am heading the curriculum in Social Studies in Grades 1-4, we have agreed and adopted a basal text in Social Studies in Grades 2 and 3 to be used throughout the Town. I will be meeting with teachers in Grades 1 and 4 in the future and hopefully will be coordinating all grades one to four in the area of social studies.

The other areas of the curriculum are headed by the following administrators: Mr. Flechsig--Mathematics; Mr. DeFusco--Science; Mrs. Stewart and Miss Stafford--Language Arts.

There has been no basic change in the curriculum at the Macomber School. Our reading levels, Math levels and the integration of children to the educational therapy class has proven to be very successful, and I have high praise for the dedicated teachers that have worked so hard to accomplish this.

Prospective teachers from S.M.U. and Westport High School are coming in as intern-teachers, working with some of our children on an individual basis. We find them very helpful and I am sure the children will benefit from this additional help.

MISS IRENE D. BOODRY, PRINCIPAL

HEAD SCHOOL

Curriculum changes include the adoption of new basal programs in spelling, reading, and mathematics.

In the area of physical plant changes, new furniture was acquired for the first and second grades.

This year saw the first fourth grade class to be housed at the Head School complete their year there and go on to the Middle School.

In order to expand their learning experience, students in all grades, from first through fourth were taken on field trips to both Fall River and New Bedford, where they visited museums, parks, and business establishments.

MRS. ELEANOR SANTARPIA, FORMER PRINCIPAL

We have no changes in the teaching staff at the Head School this year. There are four classrooms at the Head School and we remain a staff of four teachers, including myself. Being new to the position of lead teacher, I wish to thank and commend the other members of the staff for their help and cooperation. I feel we truly are a team.

At the beginning of the school year, we were faced with an overcrowded condition in Grade 4 with an enrollment of 38 students. However, Miss Goslin met the challenge and the educational program of these students did not appear to be impaired. I am happy to report, however, that the enrollment in the 4th grade has been lowered to thirty-three students with the transfer of several students to the Macomber School. Although still a very large class, the present enrollment makes it a little more possible for the teacher to meet the individual needs of more of the students.

Due to the limited number of personnel at the Head School, we have put in a request for a teacher's aide or volunteer aide and would hereby like to request a full-time experienced teacher's aide for next year. We have continued this year with the Parent Volunteer program, a program initiated last year. Under this program several parents come to the school on a regularly-scheduled basis and work within the classroom as aides to the teacher by correcting papers and workbooks, helping with art activities and helping to supervise at lunch time. This program has again proved to be quite successful from the viewpoint of all involved--teachers, parents, and children.

There have been several changes in the curriculum this year. These include the adoption of a new reading system, the Macmillan Reading program which became effective in all classes in September. A new basal spelling text, Silver-Burdett, has also been adopted to bring about uniformity in this area as well.

MISS LINDA STAFFORD, LEAD TEACHER

WESTPORT POINT SCHOOL

Once again, this year the Point school has been used as a Kindergarten facility. Three important changes have taken place at the school this year.

The special area teachers, Art, Music, and Physical Education, have included Kindergarten classes in their schedules.

There will be a change in sessions at mid-year where A.M. and P.M. classes will reverse.

On curriculum workshop days, when Kindergarten does not have any school, we have arranged for parent-teacher conferences. These have been very successful.

MISS NANCY RACZKA, LEAD TEACHER

GREENWOOD PARK SCHOOL

Greenwood Park School opened in September, 1973, with the same excellent staff as the previous year. Mrs. Constance Larkin and Mrs. Joann Moniz are the Kindergarten teachers, Mrs. Mary Hurley, Mrs. Maureen Pride, and Mrs. Laura Stewart teach first grade, Miss Sandra Cesolini has the Second grade and Mrs. Voyzie Costa is our efficient teaching aide. We are delighted to have Miss Mary Mello, Mrs. Linda Desmarais and Mrs. Janet Underwood worked with all our classes this year. Mr. Raymond Reyckert, custodian, keeps the building in good condition.

Greenwood Park School is filled to capacity and every bit of available space is used. Everyone works hard to keep our children happy and to maintain a high standard of teaching.

FEDERAL PROJECT COORDINATOR'S ANNUAL REPORT

This year we were again qualified for the reimbursement of public law 874 and received \$20,634.00 as a result of the employment of families in service connected or government installations. In Title I we were approved for a grant for a summer program which enabled us to continue our six week summer program. During this period 48 pre-Kindergarten students received instruction, 36 in the transitional Kindergarten and some 30 students at the early elementary level received remedial instruction. Also 10 students received individual instruction and training for perceptual difficulties.

This year we also were involved in the creating of the "Revival House" which is a cooperative educational venture for the emotionally disturbed in Somerset, Swansea, Fall River, Assonet and Westport. We were able to enroll 3 students from Westport in this program with very fine results. Nine students with physical handicaps were enrolled in a recreational program in Fall River. This program provides for social and rehabilitative remediation.

We also in the area of Special Education enrolled at the St. Vincent's state funded school four of our younger students. Our home instruction program has been expanded and we were able to provide services for 5 students.

Our Perceptually Handicapped program functioned very well and we now have an additional Learning Disabilities teacher at the Middle School. The teachers are working on a program of early identification and diagnosis so that we can identify the Perceptually handicapped child at the earliest level possible. Again, the emphasis being on preventive along with corrective measures.

Our reading program provides for children with high, average and low level abilities for each grade.

It is encouraging to note that the State Department figures released by the Boston Globe revealed that our 4th grade elementary students who participated in the state wide reading program test ran 10.5 points above the national average.

To achieve our goal of providing for students at any level of achievement in these subject areas, and supplementing instructional materials we have contacted many of the major publication companies in these subject fields. The four disciplines have received a complete instructional objectives synopsis published by the University of Massachusetts as a guide to basic instruction. In addition each area has received at least one major set of material from grades 106 that may be incorporated as supplementary instructional material. During the course of our remaining curriculum meetings teachers will have an opportunity to further evaluate these materials, and if requested meet with consultants and curriculum co-ordinators provided by the company.

MR. JOHN B. KELLY, FEDERAL PROJECTS
COORDINATOR

SCHOOL PSYCHOLOGIST

The work of the school psychologist is a constant search for knowledge about human behavior and the utilization of such knowledge for the promotion of human welfare. As such, psychology covers an extremely wide area of study and an amazing variety of activities. School psychology concerns itself, specifically, with the application of psychological knowledge to the problems of the schools, with special attention to the interactions among the school system, the teacher and the child.

The School psychologist helps to improve the school system through working in a variety of ways with parents, teachers, school administrators, community agencies and children.

To help parents, the school psychologist provides parents with information about the educational and psychological strengths and needs of their child. The parent counseling program will explore means by which parents and the school can more effectively work together to assist the child.

Parent counseling has been a strikingly successful program to raise grades of school children by counseling their parents, rather than the children themselves. The purpose of the program is to change the family environment so that a low achieving child can change and improve his grades and social functioning. This is done basically by creating or strengthening a sense of self-esteem in the child. By the end of the program, Dr. John V. Gilmore, professor of psychology, Boston University, School of Education, has found children develop the characteristics of productive people. "They express their feelings more easily, are less hostile to parents, get along better with others, and handle their problems better," he said.

SERVICES TO SCHOOLS THROUGH EFFORTS OF SCHOOL PSYCHOLOGIST

Pupil, parent and teacher counseling with emphasis upon parent counseling.

SPECIAL CLASS--High School senior acts as Big Brother to build self-esteem and thus improve grade standing.

REGULAR CLASS--High School senior as Big Brother through the vehicle of academic studies.

Behavior modification of students through parent and teacher counseling.

Use of weekly scheduled parent-counseling sessions.

In-service education through S.M.U. to assist school personnel understand and cope with educational problems of children.

POINT AND MACOMBER SCHOOLS

Referrals to Corrigan Mental Health Pre-school program.

Suggestion that speech therapist instruct kindergarten teachers of specific exercises to help correct speech difficulties, thereby including additional children by use of a small block of her very limited time.

Recommended use of high school seniors to act as student aides to teachers. The student aide program has proven helpful to the teachers and in their attempt to treat children on an individual basis.

A request for toy typewriters uncovered the availability of a number of government surplus typewriters at the Middle School which could be shared with the Special Class.

The Paul A. Dever State School through the initial efforts of Mr. Robert Dumas have shared their professional services with Westport schools.

GREENWOOD PARK SCHOOL

Has been serviced with parental and faculty counseling to effect appropriate placement within the school. There have also been referrals to the Fall River Mental Health Clinic.

HEAD SCHOOL

It has been appropriate to make referral to St. Vincent's Home and Mental Health Clinic.

The Meeting Street School has been available to a pre-school child upon request for a Westport Student.

These are some of the situations which have been serviced by the efforts of the school psychologist.

To continue to effect special attention to the interaction among the school system, the teachers, and the child and parent, there is a dire need of assigned clerical assistance to the School psychologist. The need for recording behavior and the increase in completing state forms, makes it obligatory to assign clerical help directly to this office. The lack of clerical help takes too much time from professional activities and necessarily reduces the quality of related performance.

MRS. ETHEL LIEBMANN, SCHOOL PSYCHOLOGIST

HIGH SCHOOL GUIDANCE

At the High School this year we were very fortunate in adding another person to our Guidance staff, Miss Elaine McLaughlin who comes very well qualified and who is working extremely well with the administration, students, teachers, and especially parents.

The following activities were directed by the Guidance Department during the 1972-1973 academic year.

1. Assisting the Principal and Assistant Principal in scheduling of classes.
2. Advising students in their course selections.
3. Counseling students on academic, vocational and emotional levels.
4. College and professional school advisement and placement.
5. Occupational advisement and placement.
6. Administering and supervising national testing programs.

7. Developing lines of communications between mental health centers and the Westport School System.
8. Introducing personnel on a part time basis from outside agencies to work with emotionally unstable individuals.
9. Introduction of Family Counseling wherein the counselor visits the home after the school day.
10. Introduction of group guidance programs.
11. Introduction of football as an after school intramural program.
12. Introduction of a Kick, Punt and Pass contest for both boys and girls.
13. Introduction of an activity club which offer dances, bowling, movies, weekend trips, etc., on an after school basis.
14. Introduction of an after school Ice Hockey Club.
15. Introduction of a "Drop-In Center" for high school drop-outs and potential drop-outs on an after school basis.
16. Introduction of a Centennial Day Committee and program.
17. Adviseement of Honor Society and Cheerleaders.
18. Introduction of photography and movie making on an after school basis.

ELEMENTARY GUIDANCE REPORT

For the first time, a screening test for first grade pupils was utilized by all administrators for the purpose of early detection of learning difficulties and for placement of students into reading groups.

The test is made up of several sub-tests which measure abilities in visual-motor coordination, mental ability, aural comprehension, letter recognition, color sense, following directions and auditory discrimination of consonant sounds.

The evaluation of the test result has proved to be most helpful in assisting teachers in meeting the needs of each individual child.

MIDDLE SCHOOL GUIDANCE REPORT

For the first time in any Middle School or Junior High School in the United States, Junior Achievement started a pilot Program of education at the Westport Middle School.

Through the efforts of the Guidance Department, two counselors from the Corrigan Mental Health Clinic have agreed to conduct group counseling sessions with two groups of students at the Middle School. To date a total of 4 groups have met with the counselors. (2 eighth grade groups, 1 seventh grade group and one sixth grade group). The group size varies in number from 5-10.

The Guidance Department is now conducting a formal career education program for the eighth grade students. All the eighth grade students will have the opportunity to explore over 50 different occupations.

In conjunction with the career education course, the Guidance Department organized a program which was conducted during National Career Education Week. Several guest speakers including a veterinarian, the manager of Sears, the manager of the Telephone Company business Office, an electrician and a male nurse spoke to all of the 8th grade students enrolled in the program. Most recently, a local barber came into school, shampooed and styled the hair of 3 eighth grade boys before an audience of 8th grade boys. 17

The guidance department has established screening processes for identifying students with Learning Disabilities. Students have been placed into various time slots with Miss Smith the new teacher for learning disabilities.

The Guidance Department has scheduled all students classified as M. R. into regular classes. Some are fully intergrated while others are 75%, 50% or 25% intergrated.

Through the efforts of the Guidance Department, a young college student has volunteered his time to tutor two groups of 5th graders needing help in Math. Tutoring is done twice per week for each group.

The Guidance Department has scheduled two programs for 8th grade students. Mr. Duval director of Guidance at Diman Regional Technical Vocational School presented a full hour slide program for the entire 8th grade describing the program at Diman. Mr. Witten and Mr. Moskol presented a similar program to a group of 15 interested 8th graders on Bristol County Agricultural School.

The Guidance Department plans on conducting a parent's night to explain the results of the differential Aptitude Tests which were administered to the 8th grade in November.
