All fees to be rounded to the nearest dollar.

ALL PERMITS NOT TAKEN IN A TIMELY MANNER WILL BE CHARGED A LATE FILING FEE AT A RATE OF UP TO FIVE TIMES THE AMOUNT OF THE ORIGINAL PERMIT.

PERMITS ARE NOT REFUNDABLE. ANY PERMIT CHANGING FROM ONE CONTRACTOR TO ANOTHER MUST BE INSPECTED BEFORE THE NEW CONTRACTOR CAN COMMENCE WORK.
