A. General Business

B. Public Hearing

1. Public hearing for 1881 Main Road. Owner Steven Ferrari presents, 6:15

-Proposing to demo the shed attached to the rear of the house in order to install a new septic system and future addition.

-BK went to site to understand historical qualities of existing attached shed. Guessing this attached shed was built around 1900 with some reclaimed structural members and materials. The chimney is modern. The attachment between the main house and the shed is not historic.

-Because half of the shed is one story and the other half is 2 stories, it is very difficult to move the whole structure in one.

-WHC agrees to approve to move and preserve the whole shed structure.

-Letter from abutter supporting owners request of demolition. Abutter, Barbara Brewer present at meeting, agrees with demolition request. Abutters repeat that this shed is a hodge-podge of construction and does not have specific historic significance.

-RL and HS do not see reason to preserve. GM requests a site visit before making a vote. BK asks to delay public hearing until February 5^{th} WHC meeting to allow time for member site visit. Member site visit to be on Sat. Jan. 13^{th} at 10am.

-If shed is to be moved, a site plan with proposed moved shed location is required.

RL motions to adjourn, GM 2nds. The meeting was adjourned at 6:50pm.
