### **B.** Public Hearings

- 1. Public hearing for 1991 Main Road. Owners Betsey LaMonte Haaland and Vidar Haaland present. 6:15pm
- a. Propose to change the existing color of the garage from faded gray to white, to match the main house on the property.
  - b. RL motions to approve as presented, DP 2nds. All in favor.

# C. Preliminary reviews

- 1. 1878C Drift Rd., Owner Marita Pinet presents plans for an addition to the existing house (built in 1950) 6:30pm
- a. The structure (or any building to the property) must also be approved by the Condo association prior to WHC approval.
  - b. Pinet introduces her and her husband.
- c. Owner proposes a 20'x20' addition to the house. It can be seen when looking beyond the Main Rd cemetery.
  - -Red cedar shingles painted white to match the rest of the house.
  - -The elevation is not visible from the public way.
- -BK sees no problem with the addition and it does not matter what is done about the shutters, for that house at that weather
- -Condo association members present had not seen any plans, on-going issues between Pinot's and condo association.
- -Condo association must approve any plan before WHC can and before a building permit can be issued.

#### 2. 1881 Main Rd.

- a. Plans and Elevations to show proposed moving of back addition as a single story storage-shed to West side of property.
  - b. Modern chimney will not be moved
  - c. Proposing concrete foundation with stone façade.
  - d. Shed replaced soffits and rake to match the main house.
  - e. White cedar shingles as siding.

Commission agrees that proposal looks appropriate and is a great solution to Demolition. Owner will come back for a public hearing.
