Meeting of June 3, 2019

Chair Rud Lawrence opened the meeting in the basement meeting room at Town Hall at 6 p.m.

Present: Chair Rud Lawrence, members Janet Jones (JJ), Geraldine Millham (GM), Bill Kendall (BK), and alternate Garrett Stuck (GS) serving as a voting member.

Others In Attendance: Jeanne Kendall.

Minutes: The minutes of the May 6, 2019 meeting were reviewed, with JJ making a motion to approve the minutes as submitted; seconded by GM; the vote was 5-0 in favor.

Treasurer's Report: GM presented an update on commission accounts and financial activity dated 5/31/19. JJ made a motion to accept the report as presented, seconded by BK; the vote was unanimous, 5-0 in favor.

Election of Officers:
