In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town of Westport, qualified to vote in elections and town affairs to meet at the Town Hall, in said town, on Monday, the twelfth day of March next, it being the second Monday of said month, at ten o'clock in the forenoon, then and there to act on the following articles, viz:-

- Art. 1st. To choose a Moderator to preside in said meeting.
- 2d. To see if the town will revoke its acceptance of the provisions of Chapter 374 of the Acts of the year 1895, relating to the office of single highway surveyor.
- 3d. To see if the Town will vote to elect a Board of Road Commissioners, consisting of three persons, one for the term of one year, one for the term of two years, and one for the term of three years, and if the Town so votes, then to determine when said Board shall be elected.
- 4th. To choose the following officers for three years, viz: one Selectman, one Assessor, one Overseer of the Poor, one member of the School Committee, one Fish Commissioner, one member of the Board of Health, and two Trustees of the Public Library; Also one Overseer of the Poor for two years, to fill a vacancy; also the following officers for the year ensuing, viz: Town Clerk, Town Treasurer, Collector of Taxes, Superintendent of Beech Grove Cemetery, one or more Constables, one or more Auditors, three Fence Viewers, four Landing Commissioners, a Single Highway Surveyor, a Draw Tider for Westport Point Bridge, a Tree Warden, and all other necessary Town Officers and Committees.
- 5th. To hear the reports of the Town Officers and Committees, and act thereon.
- 6th. To determine to what department or departments the money last received from the County Treasurer for Dog Fund shall be appropriated.
- 7th. To make appropriations for the following purposes, viz: Salary of the Superintendent of Schools, Services of Town Officers and Committees, Support of Schools, School Houses and Lots, School Furnishings, Highways and Bridges, Paupers, Public Library, Incidentally, Military Aid, State Aid, Soldiers'

Relief, Town Debt and Interest.

- 8th. To see if the Town will vote to finish macadamizing the highway leading from the store at Westport Factory to George E. Gifford's corner, so-called, and appropriate a sum of money for the same, and determine the manner of raising said appropriation.
- 9th. To see if the Town will vote to macadamize the highway at Westport Point, beginning at the Town Landing near Cooley's store, so-called, thence northerly for a distance of one mile, and make an appropriation therefor.
- 10th. To see if the Town will macadamize that portion of the Highway that begins at or near the top of "Wolf pit" hill, running down said hill through the "Head of the River", to the southeast corner of Joseph M. Horrocks house lot, or the Fall River road, so-called, and appropriate money for the same. Also to see what manner shall be determined upon to raise such appropriation.
- 11th. To see if the Town will vote to macadamize a portion of the road leading from the fork of the road near the residence of Edward Athington to Westport Harbor, and to make an appropriation therefor.
- 12th. To see if the Town will vote to continue the macadamizing of the road southerly from George H. Gifford's corner, beginning at the place where the present macadam leaves off, and make an appropriation therefor.
- 13th. To see if the Town will appropriate a sum of money not exceeding twenty dollars, to pay for shoveling gravel. Provided: that teams will work free of cost to the town to haul said gravel on the highway near the corner at South Westport.
- 14th. To see if the Town will appropriate the sum of Four hundred dollars for necessary repairs at the Alms house.
- 15th. To see if the Town will vote to authorize the Landing Commissioners to sell or lease that portion of the town landing at or near Hicks' Bridge on the north side of the highway east of the west line of Betsy Allen's barn.
- 16th. To see if the Town will purchase the land of Dr. J. B. Parris, and certain portion of Mrs. Lucy Adams' land, north of Linden Grove Cemetery for a Town Cemetery, and make appropriations therefor. And also if the Town so

- 21st. To see if the Town will authorize the School Committee, Overseers of the Poor, Single Highway Surveyor, or Road Commissioners, and Board of Health to older bills against the Town for and on account of their respective departments.
- 22d. To see if the inhabitants will authorize the Town Treasurer to hire such sums of money in anticipation of taxes as will be necessary to meet the current expenses of the year.
- 23d. To determine the salaries or commission of the Town Treasurer, Collector of Taxes, Sealer of Weights and Measures, Tree Warden and Draw Tender for the ensuing year.
- 24th. To see if the Town will appropriate a sum of money to be expended by the Tree Warden in planting shade trees, or exterminating insect pests within the limits of the public ways and places.
- 25th. To determine the wages for ordinary repairs on the highways for the ensuing year.
- 26th. To determine the wages for labor in connection with the stone crusher plant and macadamizing the highways for the ensuing year.
- 27th. To see if the Town will accept the list of names of jurors as prepared by the Selectmen.

28th. To determine the manner of raising the appropriations to defray the Town charges for the ensuing year.

29th. To see if the Town will vote to charge interest on all taxes remaining unpaid after a certain date and determine the rate per cent. of said interest.
