William H. Potter (Republican) and John F. Mac Donald (Democrat) having been appointed to serve as ballot clerks, and Frank A. Potter (Republican) Arthur E. Petley (Republican) and Charles R. Wood (Democrat) having been appointed to serve as tellers, all appeared before the Town Clerk and were sworn to faithfully perform their respective duties. William S. Head (Democrat), who had been appointed to serve as a teller, failed to appear.

Before the opening of the polls the ballot box was shown to be empty and the register stood at zero.

At 2.24 P.M. the polls were declared open.

Bristol, S.S.

To either of the Constables of the Town of Westport, in said County, Greeting:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town of Westport, qualified to vote in elections, to assemble at the Town Hall in said Town on Tuesday, the fifth day of November next, it being the Tuesday after the first Monday in said month, at ten o'clock in the forenoon.

To give in their votes for eighteen electors for President and Vice-President of the United States, viz: Two at large, and one for each Congressional district of the Commonwealth.

Also a Governor; Lieutenant Governor; Secretary; Treasurer; Auditor and Attorney-General of the Commonwealth; a Representative in Congress from the fifteenth district; a Councillor from the first district, a Senator from the third Bristol district; two Representatives in the General Court from the ninth Bristol district; a County Commissioner; a County Treasurer; and a Register of Probate and Insolvency (to fill a vacancy).

Also to vote on the following questions. Amendment to the Constitution Disqualifying from Voting Persons Convicted of Certain Offences (Chap. 21, Resolves of 1912) Amendment to the Constitution relative to the taxation of Wild or Forest Lands. (Chap. 115 Resolves of 1912) Acceptance of Chap. 503, Acts of 1912, entitled "An Act relative to pensioning laborers in the employ of cities and towns." Acceptance of Chap. 566 Acts of 1912, entitled "An act to provide for an independent agricultural school in the County of Bristol."

Greeting:

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Westport, qualified to vote in elections and town affairs to assemble at the Town Hall on Monday the tenth day of March next, it being the second Monday of said month at 9.30 o'clock in the forenoon, then and there to act on the following articles, viz:

Article 1st. To choose a Moderator to preside at said meeting.

Article 2nd. To choose the following officers for three years, viz: One Selectman, one Assessor, one Overseer of the Poor, one member of the School Committee, one Fish Commissioner, one member of the Board of Health and two trustees of the Public Library; also the following officers for the year ensuing, viz: Town Clerk, Town Treasurer, Collector of Taxes, one Overseer of the Poor (to fill a vacancy), Superintendent of Beech Grove Cemetery, five Constables, two Auditors, three Fence Viewers, four Landings Commissioners, a Single Highway Surveyor, a Tree Warden and a Draw Tender for Westport Point Bridge. All to be voted for on the Official Ballot, also on the same ballot "yes" or "no" on the following question. "Shall licenses be granted for the sale of intoxicating liquors in this Town?" And all other necessary Town Officers and Committees to be elected by hand ballot unless otherwise determined by the meeting.

Art 3rd. To hear the reports of the Town Officers and Committees and act thereon.

Art 4th. To determine to what department or departments the money last received from the County Treasurer for Dog Fund shall be appropriated.

Article 5th. To make appropriations for the following purposes, viz:

General Government, Protection to Life and Property, Health and Sanitation, Highways and Bridges, Charities, Soldiers Benefits, Education, Libraries, Recreation, Unclassified Bills, Cemeteries, Interest and Municipal Indebtedness.

Article 6th. To see if the Town will vote to erect a three-room school building at Central Village, make an appropriation therefor and take any further action that may be necessary.

Article 7th. To see if the Town will vote to build a room such as is needed on school house No. 2, otherwise known as the Horseneck school and take any other action necessary to complete the work.

Article 8th. To see if the Town will vote to dig a well at school house No. 2, and make an appropriation therefor.

Article 9th. To see if the Town will vote to move the wall surrounding the school house lot near Akins' Corner, providing Andrew Akin will give a strip of land on the north and east of the present lot, approximately 60 feet on North by 20 feet on the East. And take any other action necessary.

Article 10th. To see if the Town will vote to macadamize a portion of the Pine Hill road so called beginning at Elmer J. Sisson's Corner and continuing southerly to a point to be determined by the meeting. And if the Town so votes, make the necessary appropriation therefor.

Article 11th. To see if the Town will vote to repair with crushed stone the Sodom Road, so called, leading southerly from the old County Road at Lawton's corner to the road leading from Central Village to Adamsville, R. I. at Macomber's Corner, so called, and if the Town so votes to make the necessary appropriation therefor.

Article 12th. To see if the Town will vote to macadamize the Gifford Road so called beginning at Beulah corner and continuing southerly to the Head of Westport and to make the necessary appropriation therefor.

Article 13th. To see if the Town will continue the macadamizing of the road at Horseneck commencing where the present macadam leaves off and continuing westerly to the bar and make the necessary appropriation therefor.

Article 14th. To see if the Town will vote to repair with crushed stone the road from at or near George E. Handy's gate northerly and

westerly towards Central Village and make an appropriation therefor.

Article 15th. To see if the Town will vote to repair or re-surface with crushed stone the road-bed leading from Brownell's Corner to Central Village, beginning near the residence of Thomas A. Petley and continuing easterly and southerly to a point to be determined by the meeting; and if the Town so votes make the necessary appropriation therefor.

Article 16th. To see if the Town will vote to expend a certain sum of money, to resurface some portion of our macadam roads, and make an appropriation therefor.

Article 21st. To see if the Town will accept and allow the layout and relocation of the Horseneck road, known as the Let road beginning at station 4 in the old layout and continuing westerly and southerly to the Atlantic Ocean a distance of about six hundred feet as made by the Selectmen and on file with its accompanying plan in the office of the Town Clerk.

Article 22nd. To see if the Town will accept and allow the lay-

out of a road commencing at a point in the southerly line of the road leading from Hicks Bridge easterly to South Westport near the way leading to the Cadman's Neck Campground and continuing southerly to the river through land of John Smith, Cortez Allen, Joseph M. Horrock and others as made by the Selectmen and on file with its accompanying plan in the office of the Town Clerk.

23rd. To see if the Town will authorize the Selectmen to layout a public highway to cover the present road-bed beginning at Sanford road near the Advent Chapel continuing westerly to the Rhode Island line.

Article 24th. To see if the Town will make an appropriation for grading and surfacing some portion of the road located on West Beach at Horseneck being the same described in Article 19, provided the layout described in Article 19 is accepted by the Town, also to determine whether said work shall be done by contract or otherwise and to take any further action necessary.

Article 25th. To see if the Town will vote to furnish a new pump at Borden well so called on Sanford road and make the necessary appropriation therefor.

Article 26th. Shall an Act passed by the General Court in the year 1908, entitled "An Act to provide for the protection of forest or sprout lands from fire," be accepted by this town?

Article 27th. To appropriate the sum of \$347.75 to pay Aza R. Howland land damage on Section two caused by reason of layout of road through his land by the Selectmen, the same having been accepted by the town March 13, 1909.

Article 28th. To see if the Town will appropriate a sum of money to continue the wall on the south side of Beech Grove Cemetery. And if the Town so votes then to take any further action necessary in relation thereto.

Greeting:

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Westport qualified to vote in elections and town affairs to assemble at the Town Hall on Monday the Ninth day of March next, it being the second Monday of said month at 9.30 o'clock in the forenoon, then and there to act on the following articles, viz:

Article 1st. To choose a Moderator to preside at said meeting, who shall be chosen by ballot.

Article 2nd. To choose the following officers for three years, viz: one Selectman, one Assessor, one Overseer of the Poor, one member of the School Committee, one Fish Commissioner, one member of the Board of Health and two Trustees of the Public Library; Also the following officers for the year ensuing, viz: Town Clerk, Town Treasurer, Collector of Taxes, one member of the School Committee (to fill a vacancy), one Fish Commissioner (to fill a vacancy), Superintendent of Beech Grove Cemetery, five Constables, two Auditors, three Fence Viewers, four Landing Commissioners, a Single Highway Surveyor, a Tree Warden and a Draw Tender for Westport Point Bridge. All to be voted for on the Official Ballot, also on the same ballot "yes" or "no" on the following question, "Shall licensee be granted for the sale of intoxicating liquors in this Town?" And all other necessary Town Officers and Committees to be elected by hand ballot unless otherwise determined by the meeting.

Article 3rd. To hear the reports of the Town Officers and Committees and act thereon.

Article 4th. To determine to what department or departments the money last received from the County Treasurer for Dog Fund shall be appropriated.

Article 5th. To make appropriations for the following purposes, viz: General Government, Protection to Life and Property, Health and Sanitation,

Highways and Bridges, Charities, Soldier's Benefits, Education, Libraries, Recreations, Unclassified Bills, Cemeteries, Interest and Municipal Indebtedness.

Article 6th. To see if the town will vote to have a committee appointed to give information on the rate of taxation after the appropriations have been made for the current expenses of the present year. Also the amount of increase to the rate of taxation for each thousand dollars appropriated thereafter and this rule shall apply to all special town meetings.

Article 7th. To see if the town will vote to macadamize a portion of the Pine Hill Road, so called, beginning at Elmer J. Sisson's Corner and continuing southerly to a point to be determined by the meeting. And if the town so votes make the necessary appropriation therefor.

Article 8th. To see if the town will vote to continue the macadamizing of the Gifford Road from the present terminus southerly and make the necessary appropriation for the same.

Article 9th. To see if the town will vote to continue the macadamizing of the road leading from Central Village to Adamsville beginning where the present macadam leaves off near the residence of Manuel De Luz leading westerly to the Rhode Island line. Make an appropriation therefor and take any further necessary action.

Article 10th. To see if the town will vote to repair and annually maintain the street or way leading from Sanford road near the Advent Chapel and continuing westerly to a point at or near the "old wharf" so called, on the east shore of the South Watappa pond.

Article 11th. To see if the town will vote to tar the road on Horseneck beginning at the Town Landing and ending at Horseneck Point and make the necessary appropriation therefor.

Article 12th. To see if the town will vote to re-surface some portion or portions of the macadamized road between Central Village and the residence of Thomas A. Petley's, make an appropriation therefor and take any further action necessary.

Article 13th. To see if the town will vote to macadam or repair with crushed stone the Pine Hill Road, so called, from Elmer J. Sisson's Corner south and appropriate a sum of money therefor provided that the state appropriate three thousand dollars and determine how

the Town's appropriation shall be raised.

Article 14th. To see if the town will vote to complete the repairs on the road from State line near Adamsville, R. I. to Westport Harbor and make the necessary appropriation therefor.

Article 15th. To see if the town will vote to appropriate the sum of \$3,000.00 to resurface some portion of the main road between Borden Hill and Westport Point provided the State will appropriate a like sum.

Article 16th. To see if the town will vote to instruct the Selectmen to re-lay out the proposed road back of the Beach from near the end of the upper Horseneck Point westerly and northerly.

Article 17th. To appropriate a sum of money to construct a portion of the West Beach road back of the cottages on Horseneck.

Article 18th. To see if the town will authorize the Selectmen to lay out a public landing place on Horseneck Point at or near the northerly end of Gooseberry Neck Bar, so called, and take any further action necessary in relation thereto.

Article 19th. To see if the town will vote to purchase a portable stone crusher outfit, appropriate a sum of money therefor and take any other further action necessary.

Article 20th. To see if the town will vote to appropriate a sum of money to be used by the State toward the erection of a fire lookout tower on Copicut Hill.

Article 21st. To see if the town will petition the Director of the Bureau of Statistics for an audit of its account in accordance with the provisions of Chap. 598 Acts of 1910 and amendments thereof.

Article 22nd. To see if the town will vote to accept the following amendment to the By-laws of the town. A person shall not at the same time receive from the treasury of the town of Westport any compensation or salary for his services for more than one of the following offices, viz: Town Clerk, Selectman, Overseer of the Poor, Assessor, Member of the School Committee, Member of the Board of Health or Treasurer and Collector.

Article 23rd. To see if the Town will authorize the Auditors to

transfer the deficiencies in the several departments amounting to \$2,406.81 to the Excess and Deficiency Account and to transfer the following credit balances, viz: Soldiers Benefits \$300. Repairs of road from Gooseberry Neck Bar to Town Landing \$4.42, Macadamizing Horseneck Road to Bar \$79.59, Births Marriages & Deaths \$39.20, Moving Wall at Horseneck School \$200. to the Excess and Deficiency account.

Article 24th. To see if the town will appropriate the sum of \$1,783.60 or such sum as may be required to balance the Excess and Deficiency Account.

Article 25th. To see what compensation the town will pay for the collection of the balance of the uncollected tax (approximately \$4,700.) for the year 1912.

Article 26th. To see if the town will require all officers of the town elected & appointed to render a complete bill to the Selectmen on or before the fifth day of January of each year, for all salaries and other expenses due them for the preceding financial year.

Article 27th. To choose a committee to have charge of the Memorial Day exercises.

Article 28th. To see if the inhabitants will authorize the Town Treasurer to hire such sums of money in anticipation of revenue as will be necessary to meet the current expenses of the year.

Article 29th. To determine the salaries, compensation or commissions of the Town Treasurer, Collector of Taxes, Sealer of Weights and Measures, Tree Warden, School Committee, Draw Tender and Superintendent of Beech Grove Cemetery.

Article 30th. To determine the wages for labor in connection with the stone crusher plant and macadamizing the highways for the ensuing year.

Article 31st. To determine the wages for ordinary repairs of highways and bridges for the ensuing year.

Article 32nd. To determine the manner of raising the appropriations to defray the town charges for the year ensuing.

Article 33rd. To see if the Town will vote to allow discount on all taxes paid before a specified time and if so to fix the amount or rate per cent of discount.

Article 34th. To see if the Town will vote to charge interest on all taxes remaining unpaid after a specified time, if so to fix the time interest shall begin and determine the rate of interest to be paid.
