Bowers and continuing southerly, we transfer \$7,000. from the amount of \$10,000. appropriated at the last annual meeting for constructing the West Beach Road, beginning at Westport Point Bridge and continuing southerly and easterly to Horseneck Point.

Article 1st. To choose a Moderator to preside at said Meeting.

Article 2nd. To choose all other necessary officers and committees.

Article 3rd. To hear the report of the town officers

and committees and act thereon.

Article 4th. To determine to what department or departments the money last received from the County Treasurer for Dog Fund shall be appropriated.

Article 5th. To make appropriations for the following purposes, viz: General Government, Protection to Life and Property, Health and Sanitation, Highways and Bridges, Charities, Soldier's Benefits, Education, Libraries, Unclassified Bills, Vocational Schools, Cemeteries, Interest and Municipal Indebtedness.

Article 6th. To see if the town will choose a committee of nine persons to investigate the whole school situation and report to an adjournment of the Annual Meeting their opinion as to the need and advisability of the erection of new school buildings, including the number, necessary and ^{the} proper location for the same, together with any recommendations which shall tend to greater efficiency and economy of operation of our schools, or take any other action relative thereto.

Article 7th. To see if the town will appropriate the sum of \$14,000.00 to buy land, construct and equip a two room school house at or near Suburban Park; and authorize the School Committee to act as a purchasing, building and equipment committee and take any other action necessary.

Article 8th. To see if the town will appropriate the sum of \$7,000.00 and give the School Committee the authority to buy land, build a two room school house and equip the same at Booth's Corner and take any other action necessary.

Article 9th. To see if the town will appropriate the sum of \$4,000.00 and give the school committee the authority to use the same in erecting and equipping an additional room at the Brownell's Corner school and take any other action necessary.

Article 10th. To see if the town will appropriate the sum of \$1,200.00 to be used by the School Committee in adjusting the seating capacity of the High School as set forth in the Superintendent's report for 1922.

Article 11th. To see if the town will give the School Committee authority to cut the wood on the school house lot at the Head of Westport, the same to be used in the schools of the town.

Article 12th. To see if the town will vote to erect a new school building upon or near the state highway between Beulah and Westport Factory, appropriate a sum of money therefor and take any necessary action in relation thereto.

Article 13th. To see if the town will vote a sum of money for tar to be used on the town roads.

Article 14th. To see if the town will appropriate a sum of money to make the necessary repairs to Westport Point Bridge.

Article 15th. To see if the town will vote to repair with crushed stone the Line road, so called, beginning near the residence of Alfred Souza, continuing northerly to Sherman's corner, make an appropriation therefor and take any other necessary action.

It is recommended that the sense of this Committee is that we should as far as practicable strive for further elimination of all branches of transportation except High School, including the elimination of transportation of the seventh and eighth grades.
