1. <u>Hix Bridge Ecosystem Restoration Study</u>

The draft Detailed Project Report and Environmental Assessment for the Hix Bridge, Westport River Aquatic Ecosystem, Restoration Project has been cleared for public release and comment.

Comments are invited from all interested parties and should be directed to the U.S. Army Corps of Engineers. A copy of the draft report and public notice can be found on the Town's website.

The US Army Corps of Engineers did except the Town's documentation totaling \$10,126.63 to cover the required in-kind services.

2. Board of Health COVID ORDER
