Item #1 - Capital Improvement Planning

Department capital plans are to be submitted by today for the FY 18-27 Capital Improvement Plan. With the approval of the new police station and a possible new school, there is a need for a committee to develop a longer-term plan for the use and/or selling of some town buildings.

Item #2 – FY 2018 Operating Budget

I have sent out the forms for departments to prepare their FY 2018 budget. The Town Accountant, Treasurer, and Collector assisted me in preparing the revenue estimate.

Item #3 – Public Records Law

KP Law has scheduled a training session for their clients on the new Public Records Law. Information attached.

Item #4 - MTF's Analysis of FY 2016 State Budget Shortfall

Attached is a brief report prepared by the Mass Taxpayers Foundation about the state budget in FY 2016. This will have an impact on FY 2018.

Item #5 – Annex Playground Slide
