1. IRS increases in mileage rate

The IRS has increased the mileage rate for the remainder of 2022. Midyear increase in the mileage rates are rare, the last time the IRS made such an increase was in 2011. Overall fuel prices will have an impact on department budgets, FY23 budgets were prepared in September of 2021 and prices have risen 54% since that time. To offset some of this increase, the finance committee made some minor adjustments to the fuel accounts just prior to Town meeting but these accounts could still run short.

2. Chapter 90 Funding

Senator Michael J. Rodrigues, Chair of the Senate Committee on Ways and Means notified the Town, that the Senate Authorized \$200 million for Chapter 90 Funds, and will be authorizing an additional \$150 million in grant-based programs. The Town has applied for some of this additional funding through the small bridge repair program and the Complete Streets grant program. Letter in files

3. Pond Meadow Water Trust

The Pond Meadow Water Trust notified the office that they plan on repairing a leak in their water main on River Road after June 30, 2022. The revised work plan design appears to be a better and more achievable. They are proposing to go over the culvert with an insulated pipe to minimize the impact and will work with the conservation commission and highway department. Letter and sketch in the file.
