# Item #1 – FEMA Flood Insurance Map Modfications

FEMA has made some modest changes in the Flood Insurance Maps for Westport. Other Mass towns received notice of changes as well. FEMA is requiring that a town's legislative body (Town Meeting) vote to accept the changes. But FEMA has set a July 8, 2020 deadlline. The Zoning Amendments drafted for the Annual Town Meeting would accept the changes as FEMA requires. However with Town Meeting postponed we may not be able to have them approved by FEMA's July 8 deadline. There are numerous other Mass towns with the same problem. Some towns are seeking special legislation to authorize the BOS in the instance to serve as the legislative body. Stay tuned.

# Item # 2 – Motor Vehicle Fuel UST Environmental Testing Report

Campbell Environmental Inc. has completed the annual testing of the underground water in the vicinity of Town Hall and the Highway Garage. This stems from a UST leak many years ago. Numerous test wells were installed and maintained. Annual testing is required. The testing disclosed some decrease in VPH in a couple of the wells. That is good. The annual testing will continue. No further action is required. Report attached.

## Item #3 - FY 21 Municipal Budget - COVID-19 Impact

The economic impact of COVID-19 will have consequential affects on Westport's FY 21 Municipal Budget. Given the likely major decreases in State revenues I an becoming increasingly pessimistic about the amounts to be made available on the Cherry Sheet in Local Aid and Education Aid. I think we may be looking at a budget reduction of \$1.5M rather than the \$500,000 I estimated two weeks ago. The Town should wait until the State starts moving through their budget process before addressing any significant changes.

#### Item #4 - Energy Aggregation III

Constellation Energy was the successful bidder for the electricity aggregation program. The bid is for \$10.385 cents per kwh fixed for 35 month. This is less than the \$10.43 residents are paying now in the current aggregation program. The new rate will go into effect in January 2021.

## Item # 5 – Algoinguin Gas Transmission

Algonguin Gas has a transmission line that goes through Westport. They are notifying the town that they will be doing some repair work. Letter attached.
