Item #1 – Westport Elementary School – Roof Replacement

MSBA has invited the Town of Westport into the 2019 Accelerated Repair Program for the replacement of the WES roof. Funds for the Town's share of the feasibility study were included in the FY 2020 CIP.

Item #2 - Westport LED Streetlight Project

The contractor has installed 104 fixtures so far. The project should be completed in a week or so.

Item #3 - Green Communities

Eric Abreene from SRPEDD has been working with the Town on the Green Communities application. We expect to hear soon on the REPA grant application.

Item #4 – River Center at Head of Westport

Attached is the most recent construction update for WRWA's River Center at HOW.

Plans and Specs for the demolition of the old Police Station have been prepared and the project has been advertised. Bids are due July 31.
