Item #4 – Route 88 – Phase II

MassDOT is getting ready to start the construction on Phase II of the Route 88 Paving Project. This section is from Old County Road to Drift Road. J H Lynch is the prime contractor.

Item #5 – Eversource Solar Rate Proposal

Eversource is proposing a change in the rates for solar projects. This proposal would reduce the value of net metering credits by 40%.
