## MINUTES OF THE 10/24/22 MEETING OF THE WESTPORT COMMISSION ON DISABILITY

MEMBERS PARTICIPATING; BRIAN GALLAGHER, CHAIRMAN, ANDERS NEWCOMER, VICE CHAIRMAN, RAY PHOENIX, MARTIN COSTA, SUE SHERMAN, RICK GRUNDY.

THE MEETING OPENED AT 3:46 P.M.

REMOTE PARTICIPATION: RAY PHOENIX PARTICIPATED VIA TELEPHONE

THE MINUTES OF THE SEPTEMBER MEETING WERE APPROVED WITHOUT CHANGE

THERE WAS A DISCUSSION ABOUT THE ENTRANCE TO THE LOWER LEVEL OF THE TOWN HALL ANNEX. IMPROVEMENTS INCLUDE A CONCRETE WALKWAY TO THE DOOR. MARTIN WILL CHECK ON THE PLANNED IMPROVEMENT TO THE INSIDE RAILING ON THE RAMP

## WATER ACCESS.

HIXBRIDGE LANDING; JEFF BULL, OUR CONSULTANT ADVISED THE FIRST \$90,000.00 NEEDED FOR THE DESIGN AND ENGINEERING HAS BEEN SECURED BUT WE ARE STILL MONTHS AWAY FROM COMPLETION OF THE PROJECT. EVENTUALLY SEVERAL HUNDREDS OF THOUSANDS OF MORE DOLLARS WILL BE REQUIRED AND THE TOWN WILL BE RESPONSIBLE FOR A PERCENTAGE OF THAT AMOUNT. JEFF ALSO SPOKE ABOUT A SMALL AREA OF LAND ON HIXBRIDGE ROAD WHICH IS OWNED BY THE TOWN THAT COULD POTENTIALLY BECOME A PICNIC AREA WITH A VIEW OF THE RIVER. THERE IS NO WATER ACCESS AT THE SPOT. A HANDICAPPED PARKING SPOT WILL BE CREATED

WE ALSO HAD A PRESENTATION BY MICHAEL MOSHER WHO IS WORKING ON THE REQUIREMENTS NECESSARY TO BECOME AN EAGLE SCOUT. HE ORIGINALLY THOUGHT ABOUTCREATING A LIFT AT HIXBRIDGE LANDING TO BE USED BY DISABLED RESIDENTS TO TRANSFER INTO A WATERCRAFT LIKE A BOAT, CANOE, KAYAK ETC. WE APPLAUDED MICHAEL FOR HIS THOUGHTFULNESS AND HIS DESIRE TO HELP BUT THE PROPOSED PROJECT IS NOT FEASIBLE SINCE HE WILL NOT BE ABLE TO ACCOMPLISH IT BEFORE HE TURNS 18 AND BECAUSE OF ISSUES SUCH AS MAINTENANCE AND LIABILITY. JEFF BULL IS ON THE LANDING COMMISSION IN TOWN AND HE HAS OTHER POSSIBLE PROJECTS IN TOWN THAT MICHAEL MIGHT WORK ON FOR HIS EAGLE SCOUT BADGE. MICHAEL AND JEFF

WILL STAY IN TOUCH TO DISCUSS THOSE POSSIBLE PROJECTS, MICHAEL LEFT WITH US HIS CONTACT INFORMATION, PROJECT IDEAS AND REQUIREMENTS FOR AN EAGLE SCOUT SERVICE PROJECT

CHILDREN'S BEACH: THE MOBILITY MATS HAVE BEEN TAKEN UP BY THE HIGHWAY DEPARTMENT AND WILL BE STORED IN THE DEPARTMENT'S GARAGE BEACH AVENUE: WE RECEIVED AN ORDER OF CONDITIONS WHICH HAS TO BE RECORDED AT THE MASSACHUSETTS REGISTRY OF DEEDS. THE MOBILITY MATS ARE TAKEN UP BY THE LAND CONSERVATION TRUST. THE GEOGRIDS WILL BE INSTALLED IN THE SPRING. MARTIN WILL ASK CHRIS GONSALVES TO PUT IT AT THE TOP OF THE HIGHWAY DEPARTMENT'S LIST OF THINGS TO DO

SIDEWALKS IN TOWN; BRIAN AND MARTIN APPEARED AT THE PLANNING BOARD TO REQUEST A CHANGE TO THE CURRENT REQUIREMENT THAT A SIDEWALK BE INSTALLED IF A NEW DEVELOPMENT HAS 20 OR MORE HOUSES. THE WCOD WANTS THAT PARAGRAPH CHANGED TO REQUIRE SIDEWALKS IF 5 OR MORE NEW HOUSES ARE BUILT. THERE WILL BE A PUBLIC HEARING ON OUR REQUEST ON NOVEMBER 15, 2022. THERE WAS A DISCUSSION ABOUT HOW THE SIDEALKS AT WESTPORT POINT ARE FREQUENTLY IMPASSABLE DUE TO A NUMBER OF REASONS.

DISCRIMINATORY PRACTICES IN MEDICAL OFFICES; FREQUENTLY THE OFFICES ASK A DISABLED PERSON TO STEP UP ONTO A SCALE. THERE IS NO ALTERNATIVE WAY TO MEASURE THE WEIGHT. THERE WAS A RECENT ARTICLE IN THE BOSTON GLOBE WHICH ALSO STATED THAT SOME DOCTORS DO NOT LIKE TO TRWEAT OR REFUSE TO TREAT A DISABLED PERSON. THERE WAS A DISCUSSION ABOUT THE USE OF FORMS TO EDUCATE MEDICAL PROVIDERS ABOUT TREATING DISABLED PATIENTS. SUE SHERMAN SPOKE ABOUT THE HOW SOUTHCOAST REHABILITATION DEALS WITH DISABLED CLIENTS. THERE WAS A DISCUSSION ABOUT THE PRACTICE OF PLACING DISABLED AND DISADVANTAGED INDIVIDUALS IN NURSING HOMES RATHER THAN FINDING APPROPRIATE LIVING ARRANGEMENTS FOR THEM. MARTIN'S FRIEND, ED WALSHE IS WORKING TO BUILD DISABLED ACCESSIBLE HOUSING IN NEW EBGLAND. THE PROCESS OF EDUCATING THE PUBLIC ABOUT DISABILITIES AND CHANGING ATTITUDES AND PERCEPTIONS IS NOT EASY. ANDERS SPOKE ABOUT ENCOUNTERING PEOPLE WITH CLOSED MINDED ATTITUDES WHEN HE USES HIS SEGWAY.

WCOD DONATIONS; THE WCOD DONATION OF \$5,000.00 TO THE TOWN RECREATION DEPARTMENT HAS NOT YET BEEN FINALIZED. MARTIN WILL FOLLOW UP WITH THE TOWN ACCOUNTANT ABOUT THIS. THAT AMOUNT HAS BEEN DEDUCTED FROM OUR ACCOUNT BALANCE WHICH IS CURRENTLY \$17,549.36. THE WCOD HAS RECEIVED THE APPROVAL OF THE SELECT BOARD TO DONATE \$5,000.00 TO THE HIXBRIDGE LANDING PROJECT. IN LIGHT OF THE INCREASE IN THE OVERALL COST OF THE PROJECT WE MAY, AT SOME FUTURE POINT DECIDE TO INCREASE THE AMOUNT OF THIS CONTRIBUTION. WE CONTINUE TO LOOK FOR OTHER WAYS TO USE THIS MONEY TO IMPROVE ACCESSIBILITY AND TO IMPROVE THE LIVES OF DISABLED RESIDENTS OF WESTPORT
