## ATTENTION BOATERS RATES FOR 2024 SEASON

### Water Way User Permitting Steps for Docks and Moorings

**\*\*\*\*\*Mooring and dock slip registrations are due and payable by June 1, 2024**

**\*\*\*\*\* Please Register by mail in 2024.** Please mail all forms to Westport Harbormaster

**\*\*\*\*\*First, please attach a copy of your Boat Registration Card with your 2024 Water Way User Fee Form.** Your boat information must match your Boat Registration Card, full legal name (no nicknames), mailing address, telephone numbers, length, year, and MS or Document Numbers. Use cell phone number if possible. **Your permits will not be processed if form is not completely filled out.** All Boaters operating a boat in Westport waters must read the Town of Westport Waterways Rules and Regulations.

**\*\*\*\*\*You must check a box next to your signature affirming that you have read the Westport Waterways Rules and Regulations. The Town of Westport Waterways Rules and Regulations can be found at [www.westport-ma.com/harbormaster](http://www.westport-ma.com/harbormaster).**

**\*\*\*\*\*Fees for the 2024 season are \$6.00 per foot of registered boat length for all waterways user fees for all vessels over 10'.**

**\*\*\*\*\* Commercial Mooring Permits are \$60.00**

**\*\*\*\*\* Private mooring permits are \$25.00**

The Westport River is a "No Discharge Zone" and **Free** vessel pump-out service will be available from May through October 2024 and regular patrols and vessel assistance will be provided. For pump-outs call 508-636-1105 (Harbor Master Office) or channel 9 VHF. Please **Slow No Wake** from #10 Red Nun to the Fontaine 88 bridge with mooring fields on both sides of the channel. **Take Notice:** Tickets with **Fines** will be written for speed and wake violations through any mooring fields, or in the Federally Marked Channel within the Westport River.

**\*\*\*\*\* Note: Slow No Wake** entering and exiting underneath the 88 Fontaine Bridge.

**\*\*\*\*\* Note:** Mooring owners **must** have a white mooring ball with a horizontal blue stripe with their mooring permit # on it by **July 1<sup>st</sup>** or it will be considered abandoned and cause for fine or revocation of mooring permit and location.

**\*\*\*\*\*Note:** Winter Mooring Floatation (**polyfoam type or net float plastic**) with mooring permit number marked on it shall be removed by June 1<sup>st</sup> of each year and not set before October 1<sup>st</sup> of each year. **Winter logs are NOT ALLOWED.**
