Section 1. Purpose

In order to promote the health, safety, convenience and general welfare of its inhabitants, to lessen the danger from fire and congestion, and to improve the town under the provisions of General Law, Chapter 40A, the use, construction, repair, alteration and height of buildings and structures and the use of premises in the town are hereby regulated as hereinafter provided. Section 2. Definitions.

In this By-Law the following terms, unless a contrary meaning is required by the context or is specifically prescribed, shall have the following meanings: Words used in the present tense include the future, and the plural includes the singular; the word "lot" includes the word "plot"; the word "building" includes the word "structure"; the word "shall" is intended to be mandatory; "occupied" or "used" shall be considered as though followed by the words "or intended, arranged or designed to be used or occupied". The word "person" includes a corporation as well as an individual.

1. Accessory Use: A use or building customarily incidental and subordinate to the principal use or building and located on the same lot with such
principal use or building. In buildings restricted to residence use, the
office of a professional man, customary family occupations and workshops
not conducted for compensation, shall be deemed accessory uses.

- 2. Dwelling: A building designated or used as the living quarters for one or more families as the principal use.
- 3. Dwelling, One-Family: A detached building containing one dwelling unit only and having two side yards.
- 4. Family: One or more persons occupying a dwelling unit and living sleeping, cooking and eating on the same premises as a single housekeeping unit.
- 5. Frontage: That portion of a lot fronting upon a street or way, said frontage to be measured continuously along one street line between its side lot lines and their intersection with the street line.
- 6. Lot: A parcel of land having not less than the frontage, area, and width required under the provisions of this by-law and the Building Regulations and having its principal frontage on a street or other means of access as may be determined in accordance with the provisions of the law to be adequate as a condition of the issuance of a building permit.
- 7. Nonconforming Use: A building or land lawfully occupied by a use that does not conform to the regulations of the district in which it is situated.
- 8. Street Line: The dividing line between the street right of way and the lot.

Section III. Establishment of Districts

III-A. Types of district. For puposes of this By-Law, the Town of Westport is hereby divided into the following types of use district.

Residence

Business

Unrestricted

III-B. Location of Districts. Said districts are located and bounded as shown on a map entitled "Zoning Map of Westport, Massachusetts", dated June 6, 1957, and on file in the office of the Town Clerk. The Zoning Map, with all explanatory matter thereon, is hereby made a part of this By-Law. The map is described as follows:

Add 3. As Unrestricted: All remaining portions of the Town. Section IV. Use Regulations

Except as provided in Section VI-A-1 hereof, no building or structure shall be constructed, and no building, structure or land, or part thereof shall be used for any purpose or in any manner other than for one or more of the uses hereinafter set forth as permitted in the district in which such building, structure or land is located, or set forth as permissible by special permit in said district and so authorized.

IV-B. Business District

- 1. Permitted Uses
 - a. Any use permitted in a Residence District.
- b. Office, bank, newspaper, job printing establishments and standardized out-door advertising under permit.

- c. Hotel, motel or restaurant.
- d. Any wholesale or retail business, research laboratory, service, or public utility not involving manufacture on the premises except of products the major portion of which is sold on the premises by the producer to the consumer.
- e. Automobile service station, repair shop, storage garage, or salesroom (class 1 and 2 licenses only).
- 2. Uses which may be permitted by the Board of Appeals in accordance with the regulations appearing in Section VII-B-2 of this By-Law.
 - a. Place of amusement or assembly, club conducted for profit.

 IV-C Unrestricted District
- 1. Any lawful use shall be permitted, provided that it does not impair the use of adjacent properties by reason of dirt, odor, fumes, smoke, gas, sewage, refuse, noise, excessive vibration, or danger of explosion or fire. Section V. Intensity Regulations.
 - V-A Amend by changing the word "Industrial" to read "Unrestricted". Section VI. General Regulations

VI-A Non-conforming Uses.

- 1. The lawful use of any structure or land existing at the time of the enactment or subsequent amendment of this By-Law may be continued although such structure or use does not conform with provisions of the By-Law.
- 2. Abandonment. A non-conforming use which has been abandoned 2 years shall not be re-established and any future use shall conform with this By-Law.
- 3. Changes. Once changed to a conforming use, no structure or land shall be permitted to revert to a non-conforming use.

Section VII. Administration

VII-A. Enforcement.

This By-Law shall be enforced by the Selectmen through the Building Inspector appointed by them. No building shall be built or altered and no use of land or a building shall be begun or changed without a permit having been issued by the Building Inspector. No building shall be occupied until a certificate of occupancy has been issued by the Building Inspector. Any person violating any of the provisions of this By-Law may be fined not more than twenty dollars for each offense. Each day that such violation continues shall constitute a separate offense.

VII-B. Board of Appeals

There is hereby established a Board of Appeals of (3) members and (2) associate members to be appointed by the Selectmen, as provided in Chapter 40A of the General Laws, which shall act on all matters within its jurisdiction under this By-Law in the manner prescribed in Chapter 40A of the General Laws. The Board of Appeals shall have the following powers:

- 1. Appeals. To hear and decide an appeal taken by any persons aggrieved by reason of his inability to obtain a permit from any administrative official under the provisions of Chapter 40A of the General Laws or by any officer or board of the town, or by any person aggrieved by any order or decision of the inspector of buildings or other administrative official in violation of any provisions of Chapter 40A of the General Laws, or of this By-Law.
- 2. Special Permits. To grant a special permit for an exception as provided by sections of this By-Law when it shall have found that the use involved will not be detrimental to the established or future character of the neighborhood and town and subject to appropriate conditions or safeguards if deemed necessary.
- 3. Variances. To authorize upon appeal, or upon petition in cases where a particular use is sought for which no permit is required, with respect to a particular parcel of land or to an existing building thereon a variance from the terms of this By-Law where, owing to conditions especially affecting such parcel or such building but not affecting generally the zoning district in which it is located, a literal enforcement of the provisions of this By-Law would involve substantial hardship to the appellant, and where desirable relief may be granted without substantial detriment to the public good and without nullifying or substantially derogating from the intent or purpose of this By-Law, but not otherwise.

VII*C. Amendment. This By-Law may be amended from time to time at the annual or special town meeting in accord with the provisions of Section 6 of Chapter 40-A.

VII-D. Validity. The invalidity of any section or provision of this By-Law shall not invalidate any other section or provision thereof.

VII-E. Effective Date. These By-Laws and any amendments thereto shall become effective upon vote of the Town Meeting, subject to approval by the Attorney General of the Commonwealth of Massachusetts.

Article 39. A motion to adopt Trailer Regulation amendments as published in newspapers and posted on bulletin board of Town Hall was carried, 104 voting Yes and 8 voting No as follows:

To see if the town will vote to amend the by-laws regarding trailers by striking out the last sentence of paragraph 1 which says:

"No such permit shall be issued for a period of more than one year from the date of such hearing." and substitute the following:

"No such permit shall be issued for a period of more than two months in any single year."

Article 40. A motion to adopt Soil Conservation amendments as published in newspapers and posted on bulletin board of Town Hall was carried, 134 voting Yes and 16 voting No, as follows:

In Section 2 Change "at least 7 days" to "at least 4 days".

Soil Conservation

Section 1. A soil Conservation Board is hereby established in the Town of Westport for the purpose of regulating the removal of soil, loan, sand, gravel and granite from land within the Town and enforcing the provisions of this By-Law. The members of the Board shall consist of the Selectmen, two members of the Board of Health, one member of the Planning Board, the Building Inspector and the Chairman of the Finance Committee, who shall, from time to time hold office in said town. The Planning Board shall designate its member to serve on this Board. No person engaged in the business of removing soil, loam, sand, gravel or granite from land in said Town shall serve on such Board and in the event that a vacancy or vacancies shall occur for this reason, a substitute or substitutes shall be elected by a majority of the remaining members who shall hold office until such time as the disqualification of the person or persons in whose place they are appointed shall be removed, but in no event for more than two years. The Board shall elect a Chairman and Secretary. The Secretary need not be a member of the Board and shall keep a true record of the proceedings of the Board, which shall be public records.

Section 2. Except as hereinafter provided, no soil, loam, sand, gravel or granite shall be removed from any land within the Town without a written permit from the Board, stating the land to which it applies, and issued a public hearing, a notice of which, setting forth the time, place and purpose of said meeting and the land with reference to which application has been made, shall have been published in English-language newspapers published in Fall River and New Bedford at least asseed days prior to the day set for such hearing.

Section 2a. The applicant for the permit shall submit a plan to the Board showing the location and size as recorded in the Town Assessors' Office of the land from which the soil, loam, sand, gravel or granite is to be removed. This plan shall also indicate approximately the specific area on this land where the removal will take place and shall list the names of all abutters to the property.

Section 2b. The applicant for the permit shall notify the abutter or abutters of the property on which the permit is applied for by registered mail at least three days prior to the hearing on the permit.

Section 3. A permit shall not be required for the removal of soil, loam, sand, gravel or granite in the course of excavation incidental to the construction of a building. A permit shall also not be required for the removal of soil, loam, sand, gravel or granite for use upon the same premises or in the ordinary and customary use of land in Westport for a farm, garden, orchard or nursery and purposes incidental thereto except where this removal or transfer of soil, loam, sand, gravel or granite exceeds 100 cubic yards and then a permit will be required in accordance with Section 2. The Board may issue a permit without a hearing for such removal for use within the Town of not more than twenty yards of soil, loam, sand, gravel or granite for any other purpose which is not commercial.

Section 4. In issuing a permit the Board shall impose reasonable conditions, which shall be written upon and pose reasonable conditions, which shall be written upon and shall constitute part of the permit, requiring the restoration of the land within a designated period by grading, levelling or filling and by replacing sufficient top soil for planting cover, to the end that no substantial injury to the health, safety convenience, welfare, beautification, economic status of the district, Town and the inhabitants will be caused by the acts authorized by such permit. Conditions shall in like manner be imposed to provide adequate protection for the neighborhood and the Town from nuisances that may arise in the course of such removal. that may arise in the course of such removal and specifically that the finished grade and contour of the land after the material has been removed shall be such as not to direct the flow of drainage water onto an abutter's property or private or public way. Section 5. A permit shall not be issued for the removal of top soil except upon condition that a cover of top soil of not less than six inches in depth shall be allowed to remain or shall be replaced; provided, however, that a permit may be granted for the removal of all of the top soil or loam when necessary for or incidental to the construction of a road, or other permanent facility which changes the character or the use of the land; but in such case the Board shall require sworn evidence of good faith in the intent of the applicant to complete such road or other facility, and shall make such evidence part of its records. Section 6. A permit shall not be issued for the removal of soil, loam, sand, gravel or granite within 300 feet of a public way or within 250 feet of a private way or within 250 feet of an abutting owner unless the Board finds that such removal will not undermine the way or otherwise endanger the safety of public travel upon it, or impair the convenience and welfare of the public or the amenities of living in the houses upon such way, or injuriously affect the abutting owners. A permit shall not be issued for the removal of soil, loam, sand, gravel or granite in any location if such removal will endanger the public health or safety or constitute a nuisance. A permit shall not be issued for the removal of soil, loam, sand, gravel or granite below the grade of a Public or Private way or where the land to be excavated is more than 300 feet from a public or private way

Add Section 2.a. to read "The applicant for the permit shall submit a plan to the Board showing the location and size as recorded in the Town Assessor's Office of the land from which the soil, loam, sand, gravel or granite is to be removed. This plan shall also indicate approximately the specific area on this land where the removal will take place and shall list the names of all abutters to the property."

Add Section 2.b. to read "The applicant for the permit shall notify the abutter or abutters of the property on which the permit is applied for by registered mail at least 3 days prior to the hearing on the permit.

In Section 3 add at end of second sentence "except where this removal or transfer of soil, loam, sand, gravel or granite exceeds 100 cubic yards and then a permit will be required in accordance with Section 2".

In Section 4 At the end of the second sentence add "and specifically that the finished grade and contour of the land after the material has been removed shall be such as not to direct the flow of drainage water onto an abutter's property or private or public way."

In Section 6 add the following sentence: A permit shall not be issued for the removal of soil, loam, sand, gravel or granite below the grade of a Public or Private way or where the land to be excavated is more than 300 feet from a public or private way the permit shall not allow any excavation below the predominated lowest grade of the surrounding land.

In Section 7 add after "without a hearing" the following: "provided an application for renewal is made within 30 days of the expiration date of the permit".

Article 41.A motion to amend article VIII of the Town By-Laws was carried 142 voting Yes and 12 voting No, as follows: "Section 1A. Antique dealers are excluded from Section 1".

Article 42. - 4. After the Board of Selectmen hold a public hearing, they shall then act upon the application.

No permit for business or other purposes shall be issued for a period of more than one year from and after the date of such hearing.

No permit for living purposes shall be issued for a period of more than 6 months in any single year except:

- 1. A permit may be issued to an applicant for a period not to exceed 18 months (with no extensions or renewals) while the applicant is in the process of constructing a house.
- 2. A permit may be issued without a public hearing for any reason for a period not to exceed 30 days.

Each trailer shall be removed from the land after expiration of any permit issued under this By-Law.

Permits granted for the storage of trailers need not comply with Section 1B, 1C and 3 of Article 15.

Article 1. To determine the salary and compensation of all elected town officers.

Article 2. To determine to what department or departments the money last received from the County Treasurer for Dog Fund shall be appropriated.

Article 3. To see if the town will vote to raise and appropriate such sums of money as may be considered necessary to defray the Town's expenses for the year 1965 and appropriate the same to the several departments and take any other action relative thereto.

Article 4. Article 22. To see if the town will vote to acquire by donation, purchase or eminent domain land located on East Beach Road, to make the Town Beach contiguous and take any action relative thereto.

Article 23. To see if the town will vote to appropriate a sum of money to be used to construct Bathing Facilities on the Town Beach and to take any other action relative thereto.

Article 24. To see if the town will vote to amend Section 1, as amended, Article 15, of the By-Laws, regulating the installation, maintenance, and use of house trailers by the addition of the following:

Section 1E Notwithstanding the six month limitation in Section 1, a yearly permit may be issued for living purposes only, to those persons who have attained the age of sixty-five (65). No permit issued under this section shall be renewed or transferred unless the recipient has attained the age of sixty-five (65), except that a permit may be transferred to a surviving husband or wife of a permittee without regard to age.

Article 26. To see if the town will vote to add an additional paragraph Section 12; of the Soil Conservation By-Law to read as follows:

"The Soil Conservation Board and their officers or agents may, as far as they deem it necessary in carrying out the Soil Conservation By-Laws, enter upon any lands in the town of Westport to make examinations and surveys and to place and maintain markers." and take any other action relative thereto.

Article 27. To see if the town will vote to strike out the second sentence of Section 1, Article XI the Soil Conservation by-law which reads as follows: "The members of the board shall consist of the Selectmen, two members of the Board of Health, one member of the Planning Board, the Building Inspector and the chairman of the Finance Committee who shall from time to time hold office in said town," and to substitute therefor the following: "The members of the board shall consist of one member of the Board of Selectmen, the Planning Board, the Conservation Commission, the Board of Health and the Finance Committee. Each of the members shall be appointed by their respective organizations and an alternate shall be designated in the same manner to serve in the absence." and take any other action relative thereto.

Article 28. To see if the town will vote to appropriate the sum of \$1071.00 in accordance with the recommendations of the Department of Public Health of the Commonwealth of Massachusetts for the control of algae in the South Watuppa Pond, said funds to be used only in the event a like amount is appropriated and used for the same purpose by the City of Fall River and take any other action relative thereto.

Article 29. To see if the town will authorize Wilfred C. Driscoll, Representative of the 12th Bristol District to file legislation granting tenure of office to Public Health Nurses of the Westport Board of Health.

Tenure to be granted to all present permanent public Health Nurses and all future Public Health Nurses of the Westport Board of Health who will satisfactorily complete three (3) years of service.

It is recommended that the law shall so be worded that the Public Health Nurses on tenure can be discharged only in compliance with General Laws, Chapter 31, Section 43.

The law when enacted shall be placed on the ballot as a referendum for the consideration of the voters."

Article 30. To see if the town will adopt a resolution thanking Mr. and Mrs. Albert G. Pierce and Mr. Oliver M. Cherry, donors of the gift of land at Westport Point to the Town of Westport and take any other action relative thereto.

Article 31. To see if the town will vote to adopt the following resolution: Whereas—the general court sitting as a Constitutional Convention, did on July 16, 1963, give initial approval to a Home Rule amendment to the state Constitution, and—Whereas—this bill of rights for local governments requires a second approval by the members of the General Court during this legislative session, and—Whereas—we, as members of this Town Meeting, feel competent to handle the affairs of our town without strict supervision by the Common—wealth of our every act and deed. Now therefore be it resolved that this town meeting hereby instructs its representatives to the General Court to vote in favor of the Home Rule proposal (H 1384 of 1963 as revised) when it comes before them, or take any other action relative thereto.

Article 32. To see if the town will vote to appropriate a sum of money to purchase a truck for the Highway Department and take any other action relative thereto.

Article 33. To see if the town will vote to appropriate a sum of money to purchase a Snow Plow and attachments and to take any other action relative thereto.

Article 34. To see if the town will vote to appropriate a sum of money to purchase a combination shovel and back-hoe and take any other action relative thereto.

Article 35. To see if the town will/vote to appropriate a sum of money to purchase an ambulance for the town and take any other action relative thereto.

Article 36. To see if the town will vote to appropriate a sum of money for the purchase of cruiser car for the Police Department and take any other action relative thereto.

Article 37. To see if the town will vote to appropriate a sum of money for the purchase of a Police boat for the Police Department and take any other action relative thereto.

Voted: (Unanimously) "The Soil Conservation Board and their officers or agents may, as far as they deem it necessary in carrying out the Soil Conservation By-Laws, enter upon any land in the Town of Westport of anyone holding a soil removal permit, to make examinations and surveys and to place and maintain markers." to add an additional paragraph Section 12.

Article 27. Voted: (Unanimously) to strike out the second sentence of Section 1, Article XI the Soil Conservation by-law which reads as follows: "The members of the board shall consist of the Selectmen, two members of the Board of Health, one member of the Planning Board, the Building Inspector, and the chairman of the Finance Committee who shall from time to time, hold office in said town," and to substitute therefor the following: "The members of the Board shall consist of one member of the Board of Selectmen, the Planning Board, the Conservation Commission, the Board of Health and the Finance Committee. Each of the members shall be appointed by their respective organizations, and an alternate shall be designated in the same manner to serve in the absence."

Article 28. Voted: (unanimously) to raise and appropriate \$1,071.00 in accordance with the recommendations of the Department of Public Health of the Commonwealth of Massachusetts for the control of algae in the South Watuppa Pond, said funds to be used only in the event a like amount is appropriated and used for the same purpose by the City of Fall River.

Article 29. Voted: to authorize Wilfred C. Driscoll, Representative of the 12th Bristol District to file legislation granting tenure of office to Public Health Nurses of the Westport Board of Health.

Tenure to be granted to all present permanent Public Health Nurses and all future Public Health Nurses of the Westport Board of Health who will satisfactorily complete three (3) years of service.

It is recommended that the law shall so be worded that the Public Health Nurses on tenure can be discharged only in compliance with General Laws, Chapter 31, Section 43.

The law when enacted shall be placed on the ballot as a referendum for the consideration of the voters. This vote was not unanimous.

Article 30. Voted: (unanimously) to adopt a resolution thanking Mr. and Mrs. Albert G. Pierce and Mr. Oliver M. Cherry, donors of the gift of land at Westport Point to the Town of Westport and to raise and appropriate \$25.00

Approved Apr.8/65 by Attorne: General

Approved Apr.8/65 lay Attorney General to have scrolls made and presented to the aforementioned donors.

Article 31. Voted: (Unanimously) to adopt the following resolution: Whereas—the General Court sitting as a Constitutional Convention, did on July 16, 1963 give initial approval to a Home Rule amendment to the State Constitution, and—Whereas—this bill of rights for local governments requires a second approval by the members of the General Court during this legislative session, and—Whereas—we, as members of this Town Meeting feel competent to handle the affairs of our town without strict supervision by the Commonwealth of our every act and deed. Now therefore be it resolved that this town meeting hereby instructs its representatives to the General Court to vote in favor of the Home Rule proposal (H 1384 of 1963 as revised) when it comes before them.

Voted: (Unanimously)
Article 32. To raise and appropriate \$7,000.00 to purchase a truck for the Highway Department.

Article 33. Voted: (Unanimously) to raise and appropriate \$1,300.00 to purchase a Snow Plow and attachments.

Article 34. Voted: (Unanimously) to pass over article 34.

Article 35. Voted: To raise and appropriate \$9,000.00 to purchase an ambulance for the Town. The Selectmen as purchasing committee. Not unanimous.

Article 36. Voted: (Unanimously) to raise and appropriate \$3,041.00 for the purchase of a cruiser car for the Police Department, said cruiser car to be a 1965 full size station wagon with stretcher and resuscitator.

Article 37. Voted: to raise and appropriate \$1,500.00 for the purchase of a Police boat for the Police Department and that a purchasing committee be appointed by the Moderator. This vote was not unanimous.

Article 38. A motion to raise and appropriate \$200.00 to be used for the safety of the citizens of Westport to patrol the South Watuppa Pond, similar to what is presently being done on the Westport River provided the City of Fall River does the same, was passed.

Apticle 39. Voted: (Unanimously) to raise and appropriate \$2,800.00 to be used for the purchase of a Carry-All for the Fire Department.

Article 40. Voted: (Unanimously) to raise and appropriate \$750.00 to install a well at the Central Village Fire Station.

Article 41. A motion to raise and appropriate \$625.00 to be used for obtaining land for a fire station and/or other future town departments, to be located on the northwest corner of Briggs Road and Route 88, and to acquire same by donation, purchase, or eminent domain was carried.

Voted: (Unanimously) to accept the report of the Master Plan Committee and discharge the Committee.

Article 43. A motion to accept the provisions of Article 43 was lost. Yes 57 No 208.

Article 44. A motion to Pass over Article 44 was carried. Yes 109. No 51.

Article 45. Voted: (Unanimously) to raise and appropriate \$415.00 to install and maintain additional buoys in the West branch of the Westport River. Article 46. Voted: (Unanimously) to pass over article 46.

Article 47. A motion to convey to John Wolstenholme all right, title and interest it may have in the land under his restaurant on East Beach and extending a distance of two feet beyond his building on the southerly side, provided grantee pays all costs was carried.

Article 48. Voted: (Unanimously) to convey all right, title, and interest it may have in the portion of Fairway Drive, discontinued by vote of the town under Article 33 of the Annual Town Meeting, March 21, 1961, to Henry and Cora W. Truslow.

Article 49. Voted: (Unanimously) to raise and appropriate \$8,400.00 to resurface Cornell Road as presently existing from end of new surface westerly.

Article 50. Voted: (Unanimously) to accept the layout of Hillside Avenue as made by the Selectmen and on file in the office of Town Clerk and to acquire the same by donation, purchase or eminent domain and raise and appropriate \$1,000.00 therefor.

Article 51. Voted: (Unanimously) to accept the layout of High Street as made by the Selectmen and on file in the office of Town Clerk and to acquire the same by donation, purchase or eminent domain and raise and appropriate \$2,000.00 for construction of approximately 200 feet eastward from Railroad Park and approximately 300 feet westward from Pinewood Ave.

Article 52. A motion to accept the layout of "D" Drive as made by The Selectmen and on file in the office of Town Clerk and to acquire the same by donation, purchase or eminent domain and raise and appropriate \$2,080.00 therefor was carried.

Article 53. Voted: (Unanimously) to accept the layout of Briggs Road as made by the Selectmen and on file in the office of Town Clerk and to acquire the same by donation, purchase, or eminent domain.

Article 54. A motion to accept the layout of Cherry & Webb Lane as made by the Selectmen and on file in the office of Town Clerk and to acquire the same by donation, purchase or eminent domain and raise and appropriate \$750.00 therefor was carried.

Article 55. A motion to accept the layout of Barbara St. as made by the Selectmen and on file in the office of Town Clerk and to acquire the same by donation, purchase or eminent domain and raise and appropriate \$2,400.00 therefor was carried.

Article 66. A motion to raise and appropriate \$15,000.00 to resurface the Horseneck Road beginning at Macomber's Garage and working south was carried.

Article 67. Voted: (Unanimously) to raise and appropriate \$3,100.00 to resurface Gifford Road from Route 177 to Route 6.

Article 68. Voted: (Unanimously) to raise and appropriate \$6,000.00 to resurface Reed Road at the Head of Westport.

Article 69. Voted: (Unanimously) to raise and appropriate \$2,500.00 to \lor resurface and repair Conserve $^{\text{Ave}}$.

Article 70. Voted: (Unanimously) to abandon a portion of Mullen Hill Road also known as Nickerson's Corner Road running westerly from Old Acoaxet Road approximately 300 feet to a point where it joins the relocation of said road voted by Article 2 of the Westport Town Warrant of 1935.

Article 71. Voted: (Unanimously) to raise and appropriate \$72.00 to install four (4) street lights on Conserve Avenue on Poles 785, 788, 790 and 792.

Article 72. Voted: (Unanimously) to raise and appropriate \$18.00 to install one street light on pole No. 2343, Christopher Drive.

Article 73. Voted: (Unanimously) to raise and appropriate \$28.80 to install vone street light on Monroe St. pole No. 73531.

Article 74. Voted: (Unanimously) to raise and appropriate \$28.80 to install one street light on Briggs Road, pole No. 72728.

Article 75. Voted: (Unanimously) to raise and appropriate \$2,000.00 for drainage account to correct drainage as the occasion arises.

Article 76. Voted: (Unanimously) to confirm a sale to Henry Arruda referred to in Article 30 of the Town Meeting of March 1964 as "Listed in the Assessor's records as Lot #31 Plan 52" and now referred to as being the same premises described in a deed from Louis White to the Town of Westport and recorded in the Bristol County Southern District Registry of Deeds Book 1088, Page 194.

Article 77. Voted: (Unanimously) to have the Selectmen appoint a committee to revise the Building By-Laws.

Article 78. Voted: (Unanimously) to raise and appropriate the sum of \$3,000.00 for the purpose of maintaining during the ensuing year, the mosquito control works as estimated and certified to by the State Reclamation Board in accordance with the provisions of Chapter 112, Acts of 1931.

Article 79. Voted: (Unanimously) to raise and appropriate the sum of \$1,400.00 in accordance with Section 11 Chapter 660 Acts of 1948 for Gypsy Moth Work.

Article 80. (Voted) (Unanimously) to raise and appropriate \$1,000.00 in accordance with Section 13 Chapter 761 Acts of 1949 for Dutch Elm Work.

Article 81. Voted: (Unanimously) to raise and appropriate the sum of \$24,088.20 for Pension Fund.

Article 82. Voted: (Unanimously) to raise and appropriate the sum of \$16,000.00 for Insurance on Town Employees under Chapter 32B of the General Laws.

Article 83. Voted: (Unanimously) to raise and appropriate \$50,000.00 for the Stabilization Fund, the sum of \$25,000.00 to be earmarked for Harbor Improvement, and to meet said appropriation the sum of \$25,000.00 be taken from available funds in the treasury and \$25,000.00 be raised from Revenue of the current year.

Article 84. Voted: (Unanimously) to appropriate the sum of \$40,000.00 from free cash for the reduction of the Tax Rate.

Article 85. Voted: (Unanimously) to raise and appropriate the sum of \$10,000.00 for the Reserve Fund and to meet said appropriation the sum of \$3,623,28 be taken from Overlay Surplus and the balance of \$6,376.72 be taken from Revenue of the current year.

Article 86. Voted: (Unanimously) that all the town's charges for the ensuing year be raised from taxation and available funds.

Voted: (Unanimously) that we now adjourn.
