On Monday the thirteenth day of March next, it being the second Monday of said month, at ten o'clock in the forencon then and there to choose the following officers, viz: one Selectman, one Assessor, one member of the Board of Health, one member of the Board of Public Welfare, two members of the School Committee, one Fish Commissioner, two Trustees of the Free Public Library, each for three years; also the following officers for the year ensuing, viz: four Landing Commissioners, Tree Warden, also the following officer, one member of the Planning Board for five years; also the following vacancies, Town Clerk for two years, one member of the School Committee for one year, all to be voted for on the official ballot. And to assemble at the High School Auditorium on Tuesday the twenty-first day of March next, it being the second Tuesday after the second Monday of said month at 7:30 in the evening, then and there to act on the following articles, viz:

Article 1. To determine the salary and compensation of all elected town officers.

Article 2. To determine to what department or departments the money last received from the County Treasurer for Dog Fund shall be appropriated.
