

REGULATIONS PERTAINING TO FIREARMS LICENSES

When applying for a Class A License to Carry, as a NEW ISSUE, you will need the following:

- Completed application signed and dated
- Certificate of completion from approved safety course
- letter addressed to licensing official explaining reason for requesting issuance of letter (sole reason of "all lawful purposes" will no longer be accepted)
- three (3) letters of reference written and signed by person(s) of impeccable moral character
- check or money order payable to "Town of Westnort" in amount of \$100.00

Upon applying for a Class A License to Carry, as a RENEWAL, you will need the following:

- completed application signed and dated
- check or money order payable to "Town of Westport' in amount of \$100.00 IF YOU ARE OVER 70 YEARS OF AGE, LICENSE IS FREE.

If you are applying for a Class C Firearms Identification Card, as a **NEW ISSUE** or **RENEWAL**, you will need the following:

- completed application signed and dated
- certificate completion from approved safety course (for new issue only)
- check or money order payable to "Town of Westport" in amount of \$100.00 IF YOU ARE OVER 70 YEARS OF AGE, LICENSE IS FREE.

If you are applying for a Class D Firearms Identification Card, Restricted for Chemical Mace, you need the following:

- completed application signed and dated
- check or money order payable to "Town of Westport" in amount of \$100.00 IF YOU ARE OVER 70 YEARS OF AGE, LICENSE IS FREE.
