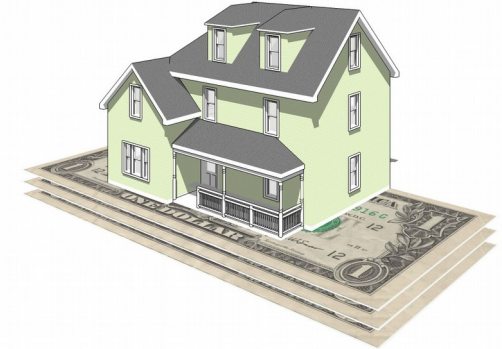

SOME FACTS ABOUT AFFORDABLE HOUSING

General Information

The definition of “Affordable” housing is housing that does not cost more than 30% of the gross household income.

The annual cost of mortgage (principal, interest, property taxes, insurance, and condo fees) should not exceed 30% of what a low to moderate income household earns annually. Households with housing costs above this amount may have difficulty affording other necessities. Household income includes the wages from all residents of the housing unit.

The mission of the Westport Affordable Housing Trust Fund is to provide for the creation and preservation of affordable housing in the Town of Westport for the benefit of low and moderate income households.

Households earning 80% or less of the Area Median Income (AMI) are qualified to buy or rent an affordable home. Certain programs may also benefit households earning up to 100 % of the AMI or more.

Who Qualifies For Westport Affordable Housing Trust Programs?

The Town of Westport has adopted these qualifications, followed by most municipalities, to determine eligibility for affordable housing programs. Details may vary, but generally these general rules apply:

- 1) Total household gross income cannot exceed 80% of the AMI, based on household size as follows:

Household Size Income Limits (2018)

- 1 person - \$45,000**
- 2 people - \$51,400**
- 3 people - \$57,850**
- 4 people - \$64,250**
- 5 people - \$69,400**

* There is also an asset limit of \$75,000 which cannot be exceeded.

- 2) For home ownership opportunities, the household shall not have owned a home within the three years preceding the application, with certain exceptions, including households where at least one person is 55 or over. The household shall have sufficient funds for a down payment and closing costs, as determined by the participating lender. The household must obtain a fixed rate mortgage.
- 3) Household size shall be appropriate for the number of bedrooms.

Affordable Housing Trust Primary Programs

HOPP

The Housing Opportunity Purchase Program offers grants to income and asset qualified first-time homebuyers to finance the gap between the affordable price and the selling price of an existing market rate house in Westport. Grants up to \$175,000 are available for two or three bedroom homes. The program will reimburse each buyer up to \$1,000 toward initial home inspections and any additional required inspections. Applicants must secure approval for a mortgage loan, submit evidence of such approval and availability of funds for a down payment with the application.

CRE-HAB

Housing rehabilitation grants up to \$40,000 are offered to income and asset qualified individuals or households to make substantial improvements to existing homes in Westport.

SEED

The SEED Program offers grants to qualified project proponents to create multiple new affordable housing units in Westport. The grants come in the form of forgivable loans.
